- 20 husband before Mr. Lopez's passing in 2011; in addition to her son
- 21 Carlos, she took great pride in their 11 other children, Mario
- 22 Humberto, Luis Homero, Larry, Manuel, Humberto, Ernest, Mena Lamar,
- 23 Melinda, Ray, Lisa, and Mary Helen, and over the years, her
- 24 treasured family grew to include 39 grandchildren and 31
