1 WHEREAS, Family and friends will long cherish their memories
2 of Felix Landin Jr. of Corpus Christi, who passed away on
3 December 15, 2021, at the age of 80; and

4 WHEREAS, The son of Mary S. Landin and Felix Landin Sr., Felix
5 Landin was born on October 8, 1941, and he grew up with the
6 companionship of four siblings, Mary Alice, Lena, Amando, and
7 Armando; after graduating from Tuloso-Midway High School in 1962,
8 he joined the Texas Army National Guard and completed assignments
9 at Missouri and California; he later served in the reserve for six
10 years; and

11 WHEREAS, Mr. Landin began his career in retail with the Gulf
12 Merchandising Company, and he went on to take a position with the
13 Woolco Department Store in Corpus Christi before working as a
14 division manager in Laredo and as an assistant store manager in
15 Brownsville; he was subsequently employed with Gibson Discount
16 Stores in Brownsville and Corpus Christi; he joined the Gibraltar
17 Mausoleum Corporation, and he became a manager at cemeteries in
18 Robstown and Corpus Christi; after a brief retirement, he returned
19 to work at Memory Gardens Cemetery for five years; and

20 WHEREAS, Highly engaged in his community, Mr. Landin served
21 as vice president of the Tuloso-Midway Independent School District
22 Board of Trustees, and he was a former member and grant chair of the
23 Tuloso-Midway ISD Education Foundation; he was also involved in
24 numerous other civic organizations, including Boy Scouts of

1 America, Corpus Christi Bay Kiwanis, the American G.I. Forum of
2 Texas, and American Legion Post 364; and

3 WHEREAS, In all his endeavors, Mr. Landin enjoyed the love
4 and support of his wife, Yolanda, with whom he shared 58 years, and
5 he took great pride in his four children, Felix IV, Aldo Allen,
6 Erika Lanette, and Alex, who preceded his father in death; with the
7 passage of time, his treasured family grew to include six
8 grandchildren and five great-grandchildren; and

9 WHEREAS, Felix Landin lived a life that was rich in personal
10 and professional achievements, and he will forever be a source of
11 inspiration to those he leaves behind; now, therefore, be it

12 RESOLVED, That the House of Representatives of the 88th Texas
13 Legislature hereby pay tribute to the memory of Felix Landin Jr.
14 and extend sincere condolences to his loved ones; and, be it further

15 RESOLVED, That an official copy of this resolution be
16 prepared for his family and that when the Texas House of
17 Representatives adjourns this day, it do so in memory of Felix
18 Landin.
