- 10 WHEREAS, Margaret and Jim Perkins have long been champions
- 11 for education, and their efforts over the past several decades have
- 12 touched the lives of thousands of students and families across the
- 13 state; Mr. Perkins' affiliation with Stephen F. Austin State
- 14 University has included two terms on the SFA Board of Regents from
- 15 1969 to 1981, during which time he served as chair of the board and
- 16 led the establishment of the SFA Foundation; and
- 17 WHEREAS, In 2007, the College of Education was renamed the
- 18 James I. Perkins College of Education, and it has continued to
- 19 thrive with the support of the couple; for 13 years, the Perkins
- 20 Professional Development Travel Fund has enabled faculty to make
- 21 more than 850 national and international trips to present their
- 22 research, and Mr. and Mrs. Perkins have also helped promote
- 23 excellence at the college through the establishment of the
- 24 Hoover-Perkins Professorship and through their funding of seven

- 1 awards within the Department of Education Studies; every year, the
- 2 couple hosts a reception for College of Education faculty to
- 3 acknowledge their dedicated service to their students, their
- 4 profession, and the university; and
- 5 WHEREAS, Beyond their extensive support for the College of
- 6 Education, Mr. and Mrs. Perkins provided a grant for the JacksTeach
- 7 program within the College of Sciences and Mathematics to help
- 8 students attain STEM teaching certifications; for two decades, they
- 9 have also served as lead partners in the Nacogdoches County Chamber
- 10 of Commerce's Nacogdoches Opportunity for Better Learning
- 11 Experience program, which awards scholarships to attend SFA to 20
- 12 area students each year; and
- WHEREAS, Few can claim such an admirable record of leadership
- 14 and service to a university as Margaret and Jim Perkins, and they
- 15 may indeed reflect with pride on their many contributions to SFA;
