1 WHEREAS, A life made rich through meaningful service drew to
2 a close with the passing of retired Texas Department of Public
3 Safety trooper Brian Clint Worley on December 26, 2022, at the age
4 of 54; and

5 WHEREAS, Brian Worley was born in Denton on March 11, 1968, to
6 Fred and Sue Worley, and he grew up with four siblings, Hapi, Shane,
7 Tyson, and Misty; he graduated in 1987 from Rains High School, where
8 he was a star basketball, baseball, track, and football athlete and
9 the recipient of All-District honors; and

10 WHEREAS, Following his completion of the Kilgore College
11 Police Academy in 1991, Mr. Worley began his law enforcement career
12 with the Mount Pleasant Police Department; he was honored with
13 multiple commendations during his tenure, and he received a Life
14 Saving Award, as well as the District Commander's Award; he also
15 initiated the Selective Traffic Enforcement Program, and he was
16 involved with the Juvenile Gang Intervention Task Unit; and

17 WHEREAS, Mr. Worley subsequently graduated from the Texas
18 Department of Public Safety trooper training academy, and he was
19 first stationed in Cooper in 1996 and then in Sulphur Springs;
20 highly respected, he was named Trooper of the Year in 1998, and he
21 garnered the DPS Chief's Award for his actions that resulted in
22 criminal arrests and drug seizures; additionally, he was commended
23 by the FBI for his assistance in the apprehension of counterfeit
24 currency; he retired from DPS in 2009; and

1 WHEREAS, Above all else, Mr. Worley was a loving and devoted
2 father to his two treasured children, Emily and Caden; he also
3 adored his dogs, Buster, Buddy, and Puppy, as well as his horses,
4 Legacy and Jasper; he was a man of great faith, and he endeared
5 himself to others with his warm and caring nature; and

6 WHEREAS, Although Brian Worley is deeply missed, memories of
7 his kindness, his strength, and his dedication to his family and his
8 fellow citizens remain to comfort and inspire those he leaves
9 behind; now, therefore, be it

10 RESOLVED, That the House of Representatives of the 88th Texas
11 Legislature hereby pay tribute to the memory of Brian Clint Worley
12 and extend heartfelt condolences to the members of his family: to
13 his daughter, Emily Diane Worley; to his son, Caden Matthew Worley;
14 to the mother of his children, Kelly Worley; to his brothers, Shane
15 Worley and Tyson Worley and his wife, Jennifer; to his sister, Misty
16 Mattson, and her husband, Jay; to his parents, Fred and Sue Worley;
17 to his nieces and nephews, Jacob, Trenton, Ty, Kennedy, Brooks, and
18 Cannon; to his special friend, Keith Kenemore; and to all others who
19 mourn his passing; and, be it further
