WHEREAS, The new owners of the XFL, actor Dwayne Johnson,

Dany Garcia, and RedBird Capital Partners, purchased the league

6 after the COVID-19 pandemic forced the cancellation of the 2020

7 season; on July 25, 2022, they selected Arlington to serve as the

8 location of the XFL headquarters; moreover, the Dallas-Fort Worth

9 area was chosen as a center of operations for all of the league's

10 franchises; and

11 WHEREAS, Since the opening of the 2023 season, the eight XFL

teams practice at local venues in North Texas during the week before

flying to games in the league's host cities; as a result of this

innovative "hub" arrangement, more than 400 players train and

15 receive medical care in the area, and the Metroplex also serves as a

16 content creation center, giving teams and players an opportunity to

17 build personal brands and engage with fans through social media and
