

R E S O L U T I O N

1 WHEREAS, The mock trial team from Covenant Classical School
2 in Fort Worth won first place at the 2023 Texas High School Mock
3 Trial Competition; and

4 WHEREAS, Administered by the Dallas Bar Association Mock
5 Trial Committee, the competition was established in 1979 to deepen
6 knowledge of the courtroom environment among students interested in
7 careers as lawyers, public speakers, and politicians; the exercise
8 shows how the legal system works in everyday life while encouraging
9 critical thinking and quick analysis; and

10 WHEREAS, More than 20 high school teams from across the state
11 participated in this year's competition, arguing a hypothetical
12 criminal case; judges and attorneys performed the role of jurors,
13 and students portrayed a variety of trial participants, from
14 defense or prosecution attorneys to witnesses; and

15 WHEREAS, Competitors were evaluated on the basis of
16 preparation and presentation; in addition to the first-place
17 trophy, the Covenant Classical team received the Team
18 Professionalism Award, conferred by their peers; individual honors
19 were garnered by senior Sophia Foster, named Outstanding Advocate,
20 and senior Jonathan Fredricks, who received honorable mention in
21 the Best Advocate and Best Witness categories; the team further
22 included Emerson Espanet, Elizabeth Farah, Nancy Jageman, Bridgett
23 Kennedy, Daniel Keyes, Ellie Monwai, Sachi Monwai, Gracie Patel,
24 Emma Pharris, Nate Smith, and Claire Tollefson; they benefited from

1 able guidance of coordinators Scott Fredricks, an attorney, and
2 Judge Josh Burgess; and

3 WHEREAS, Before advancing to the state competition, the team
4 took home top honors at the regional level for the sixth consecutive
5 year; the members are now set to represent Texas at the 2023
6 National High School Mock Trial Competition in Little Rock,
7 Arkansas, in May; and

8 WHEREAS, The members of the Covenant Classical School mock
9 trial team have demonstrated exceptional dedication and a true
10 commitment to excellence, and their accomplishments are a source of
11 great pride to their families, their school, and their community;
12 now, therefore, be it

13 RESOLVED, That the House of Representatives of the 88th Texas
14 Legislature hereby congratulate the Covenant Classical School mock
15 trial team on winning first place at the 2023 Texas High School Mock
16 Trial Competition and extend to the members sincere best wishes for
17 continued success; and, be it further
