3 24, 2022, at the age of 44; and

4           WHEREAS, Born in Dallas on March 17, 1978, Eva Mireles was the  
5 daughter of Paula Mireles and the stepdaughter of Santiago Moreno,  
6 and she grew up with two sisters, Maggie and Sandra; she graduated  
7 from Eagle Pass High School in 1996, before enrolling at Sul Ross  
8 State University and obtaining her bachelor's degree in  
9 interdisciplinary studies in 2003; and

10           WHEREAS, Ms. Mireles held a special education certification,  
11 and throughout her nearly 17-year career, she was passionate about  
12 providing a quality education to students of all abilities; as a  
13 fourth grade teacher, she went above and beyond to ensure the  
14 happiness and well-being of her students, and along the way, she  
15 earned the heartfelt gratitude of many families in her community;  
16 she found immense fulfillment in helping her students succeed and  
17 was always proud to see them graduate; and

18           WHEREAS, Blessed with a loving family, Ms. Mireles was the  
19 beloved wife of Ruben Ruiz Jr., and they were blessed with a  
20 daughter, Adalynn; her favorite hobbies included CrossFit, hiking,  
21 and karaoke, as well as spending time with her dog, Kane; with her  
22 contagious smile and lively personality, she made every gathering  
23 all the more fun for everyone; and

24           WHEREAS, Eva Mireles is profoundly missed by the many people

1 she left behind, and they will forever treasure their memories of  
2 her kindness, her exuberance, and her devotion to her family and to  
3 her students; now, therefore, be it
