- 1 WHEREAS, Memories of a life well lived may help to comfort
- 2 those saddened by the passing of Glen Dale Hunt on April 20, 2023,
- 3 at the age of 75; and
- WHEREAS, A native of Lubbock, Glen Hunt was born on July 12,
- 5 1947, to George Wilbur and Dorothy Nixon Hunt; as a youth, he
- 6 participated in activities at Asbury United Methodist Church
- 7 Lubbock, and he earned the rank of Eagle Scout and the God and
- 8 Country Award during his years in the Boy Scouts; following his
- 9 graduation from Monterey High School in 1965, he obtained a degree
- 10 in government and completed further graduate work at Texas Tech
- 11 University; and
- WHEREAS, After being hired by the Idalou Independent School
- 13 District, Mr. Hunt worked for 13 years as a teacher, K-12
- 14 counselor, and curriculum director; his desire to play an active
- 15 role in the community led him to successfully run for a seat on the
- 16 Idalou City Council and then to serve two terms as the city's mayor;
- 17 from 1979 to 1985, he worked as an administrative assistant to
- 18 Congressman Kent Hance, and then became executive assistant to
- 19 Mr. Hance at the Railroad Commission of Texas; he went on to join
- 20 the office of state comptroller John Sharp, to serve as the first
- 21 director of operations for the Texas Lottery, and to work as a clerk
- 22 with the Redistricting Committee of the Texas House of
- 23 Representatives; and
- 24 WHEREAS, Mr. Hunt continued his career in education as an

- 1 adjunct government professor at Austin Community College, where his
- 2 nearly three decades of service also included a tenure as chair of
- 3 the Government Department; teaching the subject was his greatest
- 4 joy in life, and he relished having the opportunity to impart to his
- 5 students the importance of being an informed participant in the
- 6 democratic process; and
- 7 WHEREAS, Outside of his professional life, Mr. Hunt took
- 8 pleasure in taking trips to locations around the globe; since 2002,
- 9 he had been an active member of the upRising congregation in Austin,
- 10 and he was involved in neighborhood activities in the Ashton Woods
- 11 subdivision; and
- WHEREAS, Although Glen Hunt is deeply missed, he will forever
- 13 be remembered with admiration and affection by his loved ones and by
- 14 the countless other individuals whose lives he touched; now,
- 15 therefore, be it
- RESOLVED, That the House of Representatives of the 88th Texas
- 17 Legislature hereby pay tribute to the life of Glen Dale Hunt and
- 18 extend deepest sympathy to the members of his family: to his
- 19 sisters, Sue Hunt and Ann McAdams and her husband, Kenneth; to his
