R E S O L U T I O N

1 WHEREAS, The life of a highly respected oil and gas industry
2 leader drew to a close with the passing of Robert Leroy Looney of
3 Evant on December 1, 2022, at the age of 79; and

4 WHEREAS, Rob Looney was born in Hutchinson, Kansas, on
5 June 2, 1943, to Walter and Helen Looney, and he grew up with five
6 brothers, Charles, Walter, Larry, Donald, and Harold, and a sister,
7 Janice; a graduate of Iola High School, he earned an education
8 degree from the University of Kansas and a juris doctor degree from
9 its school of law; and

10 WHEREAS, Embarking on a career with the Phillips Petroleum
11 Company, Mr. Looney served in its legal departments in Colorado,
12 Alaska, Texas, and Oklahoma before settling in Austin in 1976 to
13 become senior vice president of the Texas Association of Business;
14 in 1982, he established his own legal practice; and

15 WHEREAS, Mr. Looney joined the Texas Oil and Gas Association
16 in 1988, and during his 26 years as president, he oversaw a number
17 of changes that led to the establishment of new industry safety
18 guidelines and the responsible production of natural resources;
19 moreover, he created the TXOGA Insurance Agency and the TXOGA
20 Workers' Compensation Safety Group; additionally, he served on the
21 Interstate Oil and Gas Compact Commission and with the U.S. Oil &
22 Gas Association; upon his retirement in 2014, he was honored with
23 the prestigious TXOGA Distinguished Service Award; and

24 WHEREAS, In retirement, Mr. Looney served the Evant Chamber

1 of Commerce as president, and he helped put into place the Evant
2 Independent School District Heritage Foundation; in all his
3 endeavors, he enjoyed the love and support of his wife, Charlotte,
4 and his daughters, Stacy and Krissy; and

5 WHEREAS, Admired for his kind and generous nature, Rob Looney
6 lived a life that was rich in personal and professional
7 achievements, and he will forever be a source of inspiration to
8 those he leaves behind; now, therefore, be it

9 RESOLVED, That the House of Representatives of the 88th Texas
10 Legislature hereby pay tribute to the memory of Robert Leroy Looney
11 and extend sincere condolences to the members of his family: to his
12 wife, Charlotte Bennight Looney; to his daughters, Stacy Looney and
13 Krissy Lilljedahl, and their mother, Linda Strang Looney; to his
14 son-in-law, Bobby Lilljedahl; to his grandchildren, Lila Grace,
15 Jace, and Elli Lilljedahl; to his wife's children, Sheldon Bennight
