

R E S O L U T I O N

1           WHEREAS, The life of an esteemed civic leader and legendary  
2 football player drew to a close with the passing of Richard Preston  
3 Ritchie on May 11, 2023, at the age of 68; and

4           WHEREAS, Born on May 2, 1955, in Mineral Wells, Richard  
5 Ritchie was the son of John and Ann Ritchie; he gained national  
6 acclaim on the gridiron during his years at Texas A&I University,  
7 compiling a remarkable 39-0 record as the starting quarterback and  
8 leading the Javelinas to undefeated seasons in 1974, 1975, and 1976  
9 that yielded three Lone Star Conference crowns and three NAIA  
10 Division I championships; named Most Valuable Player of the 1974  
11 NAIA title game, he also garnered the 1975-1976 NAIA and LSC Player  
12 of the Year honors; he graduated with a degree in education and  
13 kinesiology in 1977, and he later created the Richard Ritchie  
14 Endowment in support of the school's athletic programs; he was  
15 inducted into the Javelina Hall of Fame, the LSC Hall of Honor, and  
16 the College Football Hall of Fame, and he earned the Distinguished  
17 Alumni Award for his continuing involvement with the university;

19           WHEREAS, Mr. Ritchie went on to serve as an assistant  
20 football coach at The University of Texas at Austin, the University  
21 of North Texas, and Texas Tech University; after receiving his  
22 juris doctor degree from St. Mary's University in 1991, he embarked  
23 on his career as an attorney, following the tradition set by four  
24 previous generations in his family; he joined his father's

1 practice, the Richard P. Ritchie Law firm in Mineral Wells, and he  
2 was a prominent member of the community, serving as an attorney for  
3 the Palo Pinto Water District and as a director of the First State  
4 Bank of Mineral Wells and the Brazos Foundation; moreover, he was  
5 president of the Noon Lions Club and captain of the Palo Pinto  
6 County Sheriff's Posse, and he also distinguished himself as a  
7 rancher, another occupation long pursued by the members of his  
8 family; and

9 WHEREAS, In all his endeavors, Mr. Ritchie enjoyed the love  
10 and support of his wife, Penny, his daughters, Leslie Kay and Lacie,  
11 and his five grandchildren; and

12 WHEREAS, While the death of Richard Ritchie brings great  
13 sadness to his loved ones, he leaves behind a legacy that will long  
14 be treasured by all who held him dear; now, therefore, be it

15 RESOLVED, That the House of Representatives of the 88th Texas  
16 Legislature hereby pay tribute to the memory of Richard Preston  
17 Ritchie and extend deepest condolences to the members of his  
18 family: to his wife, Penny Ritchie; to his daughters, Leslie Kay  
19 Ritchie Robnett and her husband, Kevin, and Lacie Ritchie Austin  
20 and her husband, Matthew; to his grandchildren, Elisha, Cyrus,  
21 Arleigh, Sky, and Sydney; and to his other relatives and friends;
