WHEREAS, Mr. Jensen began his career with the Texas College 10 11 of Osteopathic Medicine at the University of North Texas Health 12 Science Center at Fort Worth in 1984, and he initially served as director of development and executive director of the foundation; 13 in 1990, he became the vice president for governmental affairs for 14 HSC, and he was later appointed the associate vice chancellor for 15 16 governmental relations; over the course of his nearly four decades of service, he spearheaded legislative strategy that was central to 17 the growth of a significantly larger and more diverse HSC; he played 18 an instrumental role in gaining support for a number of new 19 20 facilities on campus and for the establishment of the Graduate 21 School of Biomedical Sciences, the School of Public Health, the School of Health Professions, and the UNT System College of 22 23 Pharmacy; he collaborated with local, state, and federal officials as well as with other community leaders to advance HSC, the City of
