- the organization, which facilitated mask distribution, vaccine 1 delivery, and financial assistance, and his example drew other 2 3 benefactors; the group was also charged with making the city more resilient, which led him to conclude that it needed a Tier 1 4 5 research university; working with city and business officials, as well as Texas A&M University Law School dean Bobby Ahdieh and 6 A&M System chancellor John Sharp, Mr. Goff was instrumental in the 7 8 university's commitment to build the \$350 million Texas A&M-Fort Worth campus; appointed chair of the successor to Fort Worth Now, 9 the Fort Worth-Tarrant County Innovation Partnership, he continues 10 to share his time and expertise to promote the city's vibrancy and 11 12 prosperity; and
