1 WHEREAS, Lancaster Independent School District chief of 2 athletics and head girls' track coach Beverly Day Humphrey has enjoyed remarkable success over the course of an exemplary coaching 3 and teaching career that has spanned more than three decades; and 4 5 WHEREAS, After starring in track at Lincoln High School in Dallas, Beverly Humphrey received a full scholarship to Prairie 6 View A&M University; there, she was a four-time All-American and a 7 national champion in the 200 meters, earning Most Valuable and Most 8 Outstanding Runner accolades on the women's track team; and 9 WHEREAS, Coach Humphrey began her career as the volleyball 10 and girls' track coach for the Greenville Independent School 11 12 District, becoming the district's first African American head coach; she subsequently became the first Black head coach at 13 14 Lancaster ISD, where she currently holds the titles of chief of athletics and public relations and head coach of the Lancaster High 15 School girls' track team; credited with establishing the district's 16 winning culture, she has led her track teams to a UIL-record 13 17 state championships as well as a total of more than 60 area, 18 regional, and district crowns through the years; and 19 WHEREAS, In 2007, the Lancaster ISD stadium was renamed 20 21 Beverly D. Humphrey Tiger Stadium; moreover, she was honored with 22 induction into the Prairie View A&M University Sports Hall of Fame with the Class of 2020-2021, and she also belongs to the Texas Black 23
