A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the administration and investment of, and distribution
- 3 and use of money from, certain constitutional and statutory funds
- 4 to support general academic teaching institutions in achieving
- 5 national prominence as major research universities and driving the
- 6 state economy; redesignating the national research university fund
- 7 as the Texas University Fund.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 9 SECTION 1. Section 51.406(c), Education Code, is amended to
- 10 read as follows:
- 11 (c) A rule or policy of a state agency, including the Texas
- 12 Higher Education Coordinating Board, in effect on June 1, 2011,
- 13 that requires reporting by a university system or an institution of
- 14 higher education has no effect on or after September 1, 2013, unless
- 15 the rule or policy is affirmatively and formally readopted before
- 16 that date by formal administrative rule published in the Texas
- 17 Register and adopted in compliance with Chapter 2001, Government
- 18 Code. This subsection does not apply to:
- 19 (1) a rule or policy for which the authorizing statute
- 20 is listed in Subsection (b);
- 21 (2) a rule or policy for which the authorizing statute
- 22 is repealed on or before September 1, 2013, by legislation enacted
- 23 by the legislature that becomes law; or
- 24 (3) a report required under any of the following
