6	SECTION 1. Subchapter C, Chapter 61, Education Code, is

9	AUTISM SPECTRUM DISORDER. (a) The board, with the assistance of
10	the advisory council on postsecondary education for persons with
11	intellectual and developmental disabilities established under
12	Section 61.06641, shall conduct a study to determine best practices
13	for assisting students with autism spectrum disorder who are
14	enrolled at institutions of higher education.
15	(b) The study must:
16	(1) identify and track:
17	(A) the number of students with autism spectrum
18	disorder who graduate from secondary schools in this state;
19	(B) the number of students with autism spectrum
20	disorder who are enrolled at institutions of higher education;
21	(C) the student financial assistance available
22	to students with autism spectrum disorder who enroll at
23	institutions of higher education; and
24	(D) the graduation rates of students with autism

1	spectrum disorder who enroll at institutions of higher education;
2	and
3	(2) identify and examine best practices and program
4	modules from public and private institutions of higher education
5	outside this state that have achieved successful results in working
6	with students with autism spectrum disorder.
7	(c) In conducting the study, the board:
8	(1) shall collaborate with the Texas Education Agency
9	regarding specialized programs offered by elementary or secondary
10	schools for students with autism spectrum disorder to determine how
11	those programs could be replicated at or extended to postsecondary
12	institutions; and
13	(2) may not request, require, or use personally
14	identifiable student information.
15	(d) Not later than December 1, 2025, the board shall submit
16	to the governor, the lieutenant governor, the speaker of the house
17	of representatives, and the commissioner of education a written
18	report that includes the study's findings and any recommendations
19	for legislative or other action.
20	(e) This section expires January 1, 2026.
21	SECTION 2. This Act takes effect immediately if it receives
22	a vote of two-thirds of all the members elected to each house, as
23	provided by Section 39, Article III, Texas Constitution. If this
24	Act does not receive the vote necessary for immediate effect, this
