S.B. No. 263

A BILL TO BE ENTITLED

AN ACT

relating to the use of average enrollment for purposes of the public school finance system.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 48.005, Education Code, is amended to read as follows:

Sec. 48.005. AVERAGE ENROLLMENT [~~DAILY ATTENDANCE~~]. (a) In this chapter, average enrollment [~~daily attendance~~] is:

(1) the average number of students enrolled in the school district during a school year [~~quotient of the sum of attendance for each day of the minimum number of days of instruction as described under Section 25.081(a) divided by the minimum number of days of instruction,~~

~~[(2) for a district that operates under a flexible year program under Section 29.0821, the quotient of the sum of attendance for each actual day of instruction as permitted by Section 29.0821(b)(1) divided by the number of actual days of instruction as permitted by Section 29.0821(b)(1),~~

~~[(3) for a district that operates under a flexible school day program under Section 29.0822, the average daily attendance as calculated by the commissioner in accordance with Sections 29.0822(d) and (d-1)]; or~~

(2) [~~(4)~~] for a district that operates a half-day program or a full-day program under Section 29.153(c), one-half of

1 the average enrollment [~~daily attendance~~] calculated under
2 Subdivision (1).

3 (b) A school district that experiences a decline of two
4 percent or more in average enrollment [~~daily attendance~~] shall be
5 funded on the basis of:

6 (1) the actual average enrollment [~~daily attendance~~]
7 of the preceding school year, if the decline is the result of the
8 closing or reduction in personnel of a military base; or

9 (2) subject to Subsection (e), an average enrollment
10 [~~daily attendance~~] not to exceed 98 percent of the actual average
11 enrollment [~~daily attendance~~] of the preceding school year, if the
12 decline is not the result of the closing or reduction in personnel
13 of a military base.

14 (c) The commissioner shall adjust the average enrollment
15 [~~daily attendance~~] of a school district that has a significant
16 percentage of students who are migratory children as defined by 20
17 U.S.C. Section 6399.

18 (d) The commissioner may adjust the average enrollment
19 [~~daily attendance~~] of a school district in which a disaster, flood,
20 extreme weather condition, fuel curtailment, or other calamity has
21 a significant effect on the district's enrollment [~~attendance~~]. In
22 addition to providing the adjustment for the amount of
23 instructional days during the semester in which the calamity first
24 occurred, an adjustment under this section may only be provided
25 based on a particular calamity for an additional amount of
26 instructional days equivalent to one school year. The commissioner
27 may divide the adjustment between two consecutive school years.

1 (e) For each school year, the commissioner shall adjust the
2 average enrollment [~~daily attendance~~] of school districts that are
3 entitled to funding on the basis of an adjusted average enrollment
4 [~~daily attendance~~] under Subsection (b)(2) so that:

5 (1) all districts are funded on the basis of the same
6 percentage of the preceding year's actual average enrollment [~~daily~~
7 ~~attendance~~]; and

8 (2) the total cost to the state does not exceed the
9 amount specifically appropriated for that year for purposes of
10 Subsection (b)(2).

11 (f) An open-enrollment charter school is not entitled to
12 funding based on an adjustment under Subsection (b)(2).

13 (g) If a student may receive course credit toward the
14 student's high school academic requirements and toward the
15 student's higher education academic requirements for a single
16 course, including a course provided under Section 28.009 by a
17 public institution of higher education, the time during which the
18 student attends the course shall be counted as part of the minimum
19 number of instructional hours required for a student to be
20 considered a full-time student in average enrollment [~~daily~~
21 ~~attendance~~] for purposes of this section.

22 [~~(g-1) The commissioner shall adopt rules to calculate~~
23 ~~average daily attendance for students participating in a blended~~
24 ~~learning program in which classroom instruction is supplemented~~
25 ~~with applied workforce learning opportunities, including~~
26 ~~participation of students in internships, externships, and~~
27 ~~apprenticeships.~~]

1 (h) Time [~~Subject to rules adopted by the commissioner under~~
2 ~~Section 48.007(b), time~~] that a student participates in an
3 off-campus instructional program provided by an entity other than a
4 school district or open-enrollment charter school and approved by
5 the commissioner in accordance with commissioner rule [~~under~~
6 ~~Section 48.007(a)~~] shall be counted as part of the minimum number of
7 instructional hours required for a student to be considered a
8 full-time student in average enrollment [~~daily attendance~~] for
9 purposes of this section.

10 (h-1) Subject to rules adopted by the commissioner under
11 Section 48.007(b), time that a student participates in a course or
12 program provided under Section 48.0071(b) shall be counted as part
13 of the minimum number of instructional hours required for a student
14 to be considered a full-time student in average daily attendance
15 for purposes of this section. This subsection expires September 1,
16 2023.

17 (i) A district or a charter school operating under Chapter
18 12 that operates a prekindergarten program is eligible to receive
19 one-half of average enrollment [~~daily attendance~~] under Subsection
20 (a) if the district's or charter school's prekindergarten program
21 provides at least 32,400 minutes of instructional time to students.

22 (j) A district or charter school is eligible to earn full
23 average enrollment [~~daily attendance~~] under Subsection (a) if the
24 district or school provides at least 43,200 minutes of
25 instructional time to students enrolled in:

26 (1) a dropout recovery school or program operating
27 under Section 12.1141(c) or Section 39.0548;

1 (2) an alternative education program operating under
2 Section 37.008;

3 (3) a school program located at a day treatment
4 facility, residential treatment facility, psychiatric hospital, or
5 medical hospital;

6 (4) a school program offered at a correctional
7 facility; or

8 (5) a school operating under Subchapter G, Chapter 12.

9 (k) A charter school operating under a charter granted under
10 Chapter 12 before January 1, 2015, is eligible to earn full average
11 enrollment [~~daily attendance~~] under Subsection (a), as that
12 subsection existed immediately before January 1, 2015, for:

13 (1) all campuses of the charter school operating
14 before January 1, 2015; and

15 (2) any campus or site expansion approved on or after
16 January 1, 2015, provided that the charter school received an
17 academic accountability performance rating of C or higher, and the
18 campus or site expansion is approved by the commissioner.

19 (l) A school district campus or charter school described by
20 Subsection (j) may operate more than one program and be eligible for
21 full average enrollment [~~daily attendance~~] for each program if the
22 programs operated by the district campus or charter school satisfy
23 all applicable state and federal requirements.

24 (m) The commissioner shall adopt rules necessary to
25 implement this section, including rules that:

26 (1) determine the method to calculate the average
27 number of students enrolled in a school district during a school

1 year;

2 (2) establish the minimum amount of instructional time
3 per day that allows a school district or charter school to be
4 eligible for full average enrollment [~~daily attendance~~], which may
5 differ based on the instructional program offered by the district
6 or charter school;

7 (3) [~~(2)~~] establish the requirements necessary for a
8 school district or charter school to be eligible for one-half of
9 average enrollment [~~daily attendance~~], which may differ based on
10 the instructional program offered by the district or charter
11 school;

12 (4) [~~(3)~~] proportionally reduce the average
13 enrollment [~~daily attendance~~] for a school district if any campus
14 or instructional program in the district provides fewer than the
15 required minimum minutes of instruction to students; and

16 (5) [~~(4)~~] allow a grade or course repeated under
17 Section [28.02124](#) to qualify for average enrollment [~~daily~~
18 ~~attendance~~] even if the student previously passed or earned credit
19 for the grade or course, if the grade or course would otherwise be
20 eligible.

21 (m-1) Except for students enrolled in programs or courses
22 offered under Chapter [30A](#) or Section [48.053](#), a school district or
23 open-enrollment charter school may not count for purposes of
24 calculating the district's or school's average daily attendance a
25 student who received virtual or remote instruction for a majority
26 of the instructional days during the preceding school year if the
27 student:

1 (1) did not achieve satisfactory performance or higher
2 or the equivalent in the preceding school year on:

3 (A) each assessment instrument administered to
4 the student under Section 39.023 or 39.025; or

5 (B) if the student was not administered an
6 assessment instrument that was required to be administered to the
7 student under Section 39.023 or 39.025 during the preceding school
8 year, an assessment instrument designed to show grade-level
9 proficiency in the essential knowledge and skills identified under
10 Section 28.002 by the State Board of Education for the student's
11 grade level;

12 (2) had a number of unexcused absences that exceeds 10
13 percent of the number of instructional days in the preceding school
14 year; or

15 (3) did not earn a grade of C or higher or the
16 equivalent in each of the foundation curriculum courses taken
17 virtually or remotely in the preceding school year.

18 (m-2) Subsection (m-1) and this subsection expire September
19 1, 2023.

20 (n) To assist school districts in implementing this section
21 as amended by H.B. 2442, Acts of the 85th Legislature, Regular
22 Session, 2017, the commissioner may waive a requirement of this
23 section or adopt rules to implement this section.

24 SECTION 2. Section 7.062(a), Education Code, is amended to
25 read as follows:

26 (a) In this section, "wealth per student" means a school
27 district's taxable value of property as determined under Subchapter

1 M, Chapter 403, Government Code, or, if applicable, Section 48.258,
2 divided by the district's average enrollment [~~daily attendance~~] as
3 determined under Section 48.005.

4 SECTION 3. Section 11.052(f), Education Code, is amended to
5 read as follows:

6 (f) If single-member trustee districts are adopted or
7 approved as provided by this section, the board shall divide the
8 school district into the appropriate number of trustee districts,
9 based on the number of members of the board that are to be elected
10 from single-member trustee districts, and shall number each trustee
11 district. The trustee districts must be compact and contiguous and
12 must be as nearly as practicable of equal population. In a district
13 with 150,000 or more students in average enrollment [~~daily
14 attendance~~], the boundary of a trustee district may not cross a
15 county election precinct boundary except at a point at which the
16 boundary of the school district crosses the county election
17 precinct boundary. Trustee districts must be drawn not later than
18 the 90th day before the date of the first election of trustees from
19 those districts.

20 SECTION 4. Sections 12.106(a), (a-2), and (d), Education
21 Code, are amended to read as follows:

22 (a) A charter holder is entitled to receive for the
23 open-enrollment charter school funding under Chapter 48 equal to
24 the amount of funding per student in weighted average enrollment
25 [~~daily attendance~~], excluding the adjustment under Section 48.052,
26 the funding under Sections 48.101, 48.110, 48.111, and 48.112, and
27 enrichment funding under Section 48.202(a), to which the charter

1 holder would be entitled for the school under Chapter 48 if the
2 school were a school district without a tier one local share for
3 purposes of Section 48.266.

4 (a-2) In addition to the funding provided by Subsection (a),
5 a charter holder is entitled to receive for the open-enrollment
6 charter school an allotment per student in average enrollment
7 [~~daily attendance~~] in an amount equal to the difference between:

8 (1) the product of:

9 (A) the quotient of:

10 (i) the total amount of funding provided to
11 eligible school districts under Section 48.101(b) or (c); and

12 (ii) the total number of students in
13 average enrollment [~~daily attendance~~] in school districts that
14 receive an allotment under Section 48.101(b) or (c); and

15 (B) the sum of one and the quotient of:

16 (i) the total number of students in average
17 enrollment [~~daily attendance~~] in school districts that receive an
18 allotment under Section 48.101(b) or (c); and

19 (ii) the total number of students in
20 average enrollment [~~daily attendance~~] in school districts
21 statewide; and

22 (2) \$125.

23 (d) Subject to Subsection (e), in addition to other amounts
24 provided by this section, a charter holder is entitled to receive,
25 for the open-enrollment charter school, funding per student in
26 average enrollment [~~daily attendance~~] in an amount equal to the
27 guaranteed level of state and local funds per student per cent of

1 tax effort under Section 46.032(a) multiplied by the lesser of:

2 (1) the state average interest and sinking fund tax
3 rate imposed by school districts for the current year; or

4 (2) a rate that would result in a total amount to which
5 charter schools are entitled under this subsection for the current
6 year equal to \$60 million.

7 SECTION 5. Sections 12.263(a), (b), and (c), Education
8 Code, as effective September 1, 2023, are amended to read as
9 follows:

10 (a) Except as otherwise provided by this section, funding
11 for an adult education program operated under a charter granted
12 under this subchapter is an amount per participant through the
13 Foundation School Program equal to the amount of state funding per
14 student in weighted average enrollment [~~daily attendance~~] that
15 would be allocated under the Foundation School Program for the
16 student's attendance at an open-enrollment charter school in
17 accordance with Section 12.106.

18 (b) For purposes of determining the average enrollment
19 [~~daily attendance~~] of an adult education program operated under a
20 charter granted under this subchapter, a student is considered to
21 be in average enrollment [~~daily attendance, with a 100 percent~~
22 ~~attendance rate,~~] for:

23 (1) all of the instructional days of the school year,
24 if the student is enrolled for at least 75 percent of the school
25 year;

26 (2) half of the instructional days of the school year,
27 if the student is enrolled for at least 50 percent but less than 75

1 percent of the school year;

2 (3) a quarter of the instructional days of the school
3 year, if the student is enrolled for at least 25 percent but less
4 than 50 percent of the school year; or

5 (4) one-tenth of the instructional days of the school
6 year, if the student is enrolled for at least 10 percent but less
7 than 25 percent of the school year.

8 (c) A student enrolled in an adult education program
9 operated under a charter granted under this subchapter for less
10 than 10 percent of a school year may not be counted toward the adult
11 education program's average enrollment [~~daily attendance~~] for that
12 school year.

13 SECTION 6. Section 13.051(c), Education Code, is amended to
14 read as follows:

15 (c) Territory that does not have residents may be detached
16 from a school district and annexed to another school district if:

17 (1) the total taxable value of the property in the
18 territory according to the most recent certified appraisal roll for
19 each school district is not greater than:

20 (A) five percent of the district's taxable value
21 of all property in that district as determined under Subchapter M,
22 Chapter 403, Government Code; and

23 (B) \$5,000 property value per student in average
24 enrollment [~~daily attendance~~] as determined under Section 48.005;
25 and

26 (2) the school district from which the property will
27 be detached does not own any real property located in the territory.

1 SECTION 7. Section 13.102, Education Code, is amended to
2 read as follows:

3 Sec. 13.102. MINIMUM AREA AND ENROLLMENT [~~ATTENDANCE~~]
4 REQUIREMENTS. A new district may not be created with an area of
5 less than nine square miles or fewer than 8,000 students in average
6 enrollment [~~daily attendance~~], and a district may not be reduced to
7 an area of less than nine square miles or fewer than 8,000 students
8 in average enrollment [~~daily attendance~~].

9 SECTION 8. Section 13.283, Education Code, is amended to
10 read as follows:

11 Sec. 13.283. PAYMENTS REDUCED. The incentive aid payments
12 shall be reduced in direct proportion to any reduction in the
13 average enrollment [~~daily attendance~~] as determined under Section
14 48.005 of the reorganized school district for the preceding year.

15 SECTION 9. Section 19.009(d-2), Education Code, is amended
16 to read as follows:

17 (d-2) Beginning with the 2009-2010 school year, the
18 district shall increase the monthly salary of each classroom
19 teacher, full-time speech pathologist, full-time librarian,
20 full-time school counselor certified under Subchapter B, Chapter
21 21, and full-time school nurse employed by the district by the
22 greater of:

- 23 (1) \$80; or
24 (2) the maximum uniform amount that, when combined
25 with any resulting increases in the amount of contributions made by
26 the district for social security coverage for the specified
27 employees or by the district on behalf of the specified employees

1 under Section 825.405, Government Code, may be provided using an
2 amount equal to the product of \$60 multiplied by the number of
3 students in weighted average enrollment [~~daily attendance~~] in the
4 district during the 2009-2010 school year.

5 SECTION 10. Section 25.038, Education Code, is amended to
6 read as follows:

7 Sec. 25.038. TUITION FEE FOR TRANSFER STUDENTS. The
8 receiving school district may charge a tuition fee to the extent
9 that the district's actual expenditure per student in average
10 enrollment [~~daily attendance~~], as determined by its board of
11 trustees, exceeds the sum the district benefits from state aid
12 sources as provided by Section 25.037. However, unless a tuition
13 fee is prescribed and set out in a transfer agreement before its
14 execution by the parties, an increase in tuition charge may not be
15 made for the year of that transfer that exceeds the tuition charge,
16 if any, of the preceding school year.

17 SECTION 11. Section 25.045(c), Education Code, is amended
18 to read as follows:

19 (c) A student who transfers to another school district under
20 this section may not be charged tuition. The student is included in
21 the average enrollment [~~daily attendance~~] of the district in which
22 the student attends school.

23 SECTION 12. Sections 25.081(e) and (f), Education Code, are
24 amended to read as follows:

25 (e) A school district or education program is exempt from
26 the minimum minutes of operation requirement if the district's or
27 program's average enrollment [~~daily attendance~~] is calculated

1 under Section 48.005(j).

2 (f) The commissioner may proportionally reduce the amount
3 of funding a district receives under Chapter 46, 48, or 49 and the
4 average enrollment [~~daily attendance~~] calculation for the district
5 if the district operates on a calendar that provides fewer minutes
6 of operation than required under Subsection (a).

7 SECTION 13. Section 25.087(d), Education Code, is amended
8 to read as follows:

9 (d) A student whose absence is excused under Subsection (b),
10 (b-1), (b-2), (b-4), (b-5), (b-7), or (c) may not be penalized for
11 that absence and shall be counted as if the student attended school
12 for purposes of funding under Chapter 48 [~~calculating the average~~
13 ~~daily attendance of students in the school district~~]. A student
14 whose absence is excused under Subsection (b), (b-1), (b-2), (b-4),
15 (b-5), (b-7), or (c) shall be allowed a reasonable time to make up
16 school work missed on those days. If the student satisfactorily
17 completes the school work, the day of absence shall be counted as a
18 day of compulsory attendance.

19 SECTION 14. Section 25.111, Education Code, is amended to
20 read as follows:

21 Sec. 25.111. STUDENT/TEACHER RATIOS. Except as provided by
22 Section 25.112, each school district must employ a sufficient
23 number of teachers certified under Subchapter B, Chapter 21, to
24 maintain an average ratio of not less than one teacher for each 20
25 students in average enrollment [~~daily attendance~~].

26 SECTION 15. Sections 25.112(a) and (b), Education Code, are
27 amended to read as follows:

1 (a) Except as otherwise authorized by this section, a school
2 district may not enroll more than 22 students in a prekindergarten,
3 kindergarten, first, second, third, or fourth grade class. That
4 limitation does not apply during:

5 (1) any 12-week period of the school year selected by
6 the district, in the case of a district whose average enrollment
7 [~~daily attendance~~] is adjusted under Section 48.005(c); or

8 (2) the last 12 weeks of any school year in the case of
9 any other district.

10 (b) Not later than the 30th day after the first day of the
11 12-week period for which a district whose average enrollment [~~daily~~
12 ~~attendance~~] is adjusted under Section 48.005(c) is claiming an
13 exemption under Subsection (a), the district shall notify the
14 commissioner in writing that the district is claiming an exemption
15 for the period stated in the notice.

16 SECTION 16. Section 29.008(b), Education Code, is amended
17 to read as follows:

18 (b) Except as provided by Subsection (c), costs of an
19 approved contract for residential placement may be paid from a
20 combination of federal, state, and local funds. The local share of
21 the total contract cost for each student is that portion of the
22 local tax effort that exceeds the district's local fund assignment
23 under Section 48.256, divided by the average enrollment [~~daily~~
24 ~~attendance~~] in the district. If the contract involves a private
25 facility, the state share of the total contract cost is that amount
26 remaining after subtracting the local share. If the contract
27 involves a public facility, the state share is that amount

1 remaining after subtracting the local share from the portion of the
2 contract that involves the costs of instructional and related
3 services. For purposes of this subsection, "local tax effort"
4 means the total amount of money generated by taxes imposed for debt
5 service and maintenance and operation less any amounts paid into a
6 tax increment fund under Chapter 311, Tax Code.

7 SECTION 17. Section 29.014(b), Education Code, is amended
8 to read as follows:

9 (b) A school district to which this section applies may
10 operate an extended year program for a period not to exceed 45 days.
11 ~~[The district's average daily attendance shall be computed for the~~
12 ~~regular school year plus the extended year.]~~

13 SECTION 18. Section 29.081(f), Education Code, is amended
14 to read as follows:

15 (f) The commissioner shall include students enrolled in
16 ~~[attendance in]~~ a program under Subsection (e) in the computation
17 of the district's average enrollment ~~[daily attendance]~~ for funding
18 purposes.

19 SECTION 19. Section 29.0822(d), Education Code, is amended
20 to read as follows:

21 (d) The commissioner may adopt rules for the administration
22 of this section, including rules establishing application
23 requirements. ~~[Subject to Subsection (d-1), the commissioner shall~~
24 ~~calculate average daily attendance for students served under this~~
25 ~~section. The commissioner shall allow accumulations of hours of~~
26 ~~instruction for students whose schedule would not otherwise allow~~
27 ~~full state funding. Funding under this subsection shall be~~

1 ~~determined based on the number of instructional days in the school~~
2 ~~district calendar and a seven-hour school day, but attendance may~~
3 ~~be cumulated over a school year, including any summer or vacation~~
4 ~~session. The attendance of students who accumulate less than the~~
5 ~~number of attendance hours required under this subsection shall be~~
6 ~~proportionately reduced for funding purposes. The commissioner~~
7 ~~may:~~

8 ~~[(1) set maximum funding amounts for an individual~~
9 ~~course under this section; and~~

10 ~~[(2) limit funding for the attendance of a student~~
11 ~~described by Subsection (a)(3) in a course under this section to~~
12 ~~funding only for the attendance necessary for the student to earn~~
13 ~~class credit that, as a result of attendance requirements under~~
14 ~~Section 25.092, the student would not otherwise be able to receive~~
15 ~~without retaking the class.]~~

16 SECTION 20. Section 29.184(b), Education Code, is amended
17 to read as follows:

18 (b) A student who attends career and technology classes at
19 another school under a contract authorized by Subsection (a) is
20 included in the average enrollment [~~daily attendance~~] of the
21 district in which the student is regularly enrolled.

22 SECTION 21. Sections 29.203(a) and (c), Education Code, are
23 amended to read as follows:

24 (a) A student who under this subchapter uses a public
25 education grant to attend a public school in a school district other
26 than the district in which the student resides is included in the
27 average enrollment [~~daily attendance~~] of the district in which the

1 student attends school.

2 (c) A school district is entitled to additional facilities
3 assistance under Section 48.301 if the district agrees to:

4 (1) accept a number of students using public education
5 grants that is at least one percent of the district's average
6 enrollment [~~daily attendance~~] for the preceding school year; and

7 (2) provide services to each student until the student
8 either voluntarily decides to attend a school in a different
9 district or graduates from high school.

10 SECTION 22. Section 29.403(b), Education Code, is amended
11 to read as follows:

12 (b) A student who is enrolled in a program under this
13 subchapter is included in determining the average enrollment [~~daily
14 attendance~~] under Section 48.005 of the partnering school district.

15 SECTION 23. Section 29.457(a), Education Code, is amended
16 to read as follows:

17 (a) In addition to other funding to which a school district
18 is entitled under this code, each district in which alleged
19 offender residents attend school is entitled to an annual allotment
20 of \$5,100 for each resident in average enrollment [~~daily
21 attendance~~] or a different amount for any year provided by
22 appropriation.

23 SECTION 24. Section 30.003(b), Education Code, is amended
24 to read as follows:

25 (b) If the student is admitted to the school for a full-time
26 program for the equivalent of two long semesters, the district's
27 share of the cost is an amount equal to the dollar amount of

1 maintenance and debt service taxes imposed by the district for that
2 year divided by the district's average enrollment [~~daily~~
3 ~~attendance~~] for the preceding year.

4 SECTION 25. Section 30.102(a), Education Code, is amended
5 to read as follows:

6 (a) The Texas Juvenile Justice Department is entitled to
7 receive the state available school fund apportionment based on the
8 average enrollment [~~daily attendance~~] in the department's
9 educational programs of students who are at least three years of age
10 and not older than 21 years of age.

11 SECTION 26. Section 30A.151(f), Education Code, is amended
12 to read as follows:

13 (f) For a full-time electronic course program offered
14 through the state virtual school network for a grade level at or
15 above grade level three but not above grade level eight, a school
16 district or open-enrollment charter school is entitled to receive
17 federal, state, and local funding for a student enrolled in the
18 program in an amount equal to the funding the district or school
19 would otherwise receive for a student enrolled in the district or
20 school. [~~The district or school may calculate the average daily~~
21 ~~attendance of a student enrolled in the program based on:~~

- 22 [~~(1) hours of contact with the student,~~
23 [~~(2) the student's successful completion of a course,~~
24 ~~or~~
25 [~~(3) a method approved by the commissioner.~~]

16 your local property tax database on which you can easily access
17 information regarding your property taxes, including information
18 about proposed tax rates and scheduled public hearings of each
19 entity that taxes your property.";

20 (2) contain a section entitled "Comparison of Proposed
21 Budget with Last Year's Budget," which must show the difference,
22 expressed as a percent increase or decrease, as applicable, in the
23 amounts budgeted for the preceding fiscal year and the amount
24 budgeted for the fiscal year that begins in the current tax year for
25 each of the following:

26 (A) maintenance and operations;

27 (B) debt service; and

1 (C) total expenditures;

2 (3) contain a section entitled "Total Appraised Value
3 and Total Taxable Value," which must show the total appraised value
4 and the total taxable value of all property and the total appraised
5 value and the total taxable value of new property taxable by the
6 district in the preceding tax year and the current tax year as
7 calculated under Section 26.04, Tax Code;

8 (4) contain a statement of the total amount of the
9 outstanding and unpaid bonded indebtedness of the school district;

10 (5) contain a section entitled "Comparison of Proposed
11 Rates with Last Year's Rates," which must:

12 (A) show in rows the tax rates described by
13 Subparagraphs (i)-(iii), expressed as amounts per \$100 valuation of
14 property, for columns entitled "Maintenance & Operations,"
15 "Interest & Sinking Fund," and "Total," which is the sum of
16 "Maintenance & Operations" and "Interest & Sinking Fund":

17 (i) the school district's "Last Year's
18 Rate";

19 (ii) the "Rate to Maintain Same Level of
20 Maintenance & Operations Revenue & Pay Debt Service," which:

21 (a) in the case of "Maintenance &
22 Operations," is the tax rate that, when applied to the current
23 taxable value for the district, as certified by the chief appraiser
24 under Section 26.01, Tax Code, and as adjusted to reflect changes
25 made by the chief appraiser as of the time the notice is prepared,
26 would impose taxes in an amount that, when added to state funds to
27 be distributed to the district under Chapter 48, would provide the

1 same amount of maintenance and operations taxes and state funds
2 distributed under Chapter 48 per student in average enrollment
3 [~~daily attendance~~] for the applicable school year that was
4 available to the district in the preceding school year; and

5 (b) in the case of "Interest & Sinking
6 Fund," is the tax rate that, when applied to the current taxable
7 value for the district, as certified by the chief appraiser under

23 school year under Section 26.01, Tax Code, and as adjusted to
24 reflect changes made by the chief appraiser as of the time the
25 notice is prepared, by the total tax rate, and dividing the product
26 by the number of students in average enrollment [~~daily attendance~~]
27 in the district for the applicable school year; and

1 (ii) the "State Revenue per Student," which
2 is computed by determining the amount of state aid received or to be
3 received by the district under Chapters 43, 46, and 48 and dividing
4 that amount by the number of students in average enrollment [~~daily~~
5 ~~attendance~~] in the district for the applicable school year; and

6 (C) contain an asterisk after each calculation
7 for "Interest & Sinking Fund" and a footnote to the section that, in
8 reduced type, states "The Interest & Sinking Fund tax revenue is
9 used to pay for bonded indebtedness on construction, equipment, or
10 both. The bonds, and the tax rate necessary to pay those bonds, were
11 approved by the voters of this district.";

12 (6) contain a section entitled "Comparison of Proposed
13 Levy with Last Year's Levy on Average Residence," which must:

14 (A) show in rows the information described by
15 Subparagraphs (i)-(iv), rounded to the nearest dollar, for columns
16 entitled "Last Year" and "This Year":

17 (i) "Average Market Value of Residences,"
18 determined using the same group of residences for each year;

19 (ii) "Average Taxable Value of Residences,"
20 determined after taking into account the limitation on the
21 appraised value of residences under Section 23.23, Tax Code, and
22 after subtracting all homestead exemptions applicable in each year,
23 other than exemptions available only to disabled persons or persons
24 65 years of age or older or their surviving spouses, and using the
25 same group of residences for each year;

26 (iii) "Last Year's Rate Versus Proposed
27 Rate per \$100 Value"; and

1 (iv) "Taxes Due on Average Residence,"
2 determined using the same group of residences for each year; and

3 (B) contain the following information: "Increase
4 (Decrease) in Taxes" expressed in dollars and cents, which is
5 computed by subtracting the "Taxes Due on Average Residence" for
6 the preceding tax year from the "Taxes Due on Average Residence" for
7 the current tax year;

8 (7) contain the following statement in bold print:
9 "Under state law, the dollar amount of school taxes imposed on the
10 residence of a person 65 years of age or older or of the surviving
11 spouse of such a person, if the surviving spouse was 55 years of age
12 or older when the person died, may not be increased above the amount
13 paid in the first year after the person turned 65, regardless of
14 changes in tax rate or property value.";

15 (8) contain the following statement in bold print:
16 "Notice of Voter-Approval Rate: The highest tax rate the district
17 can adopt before requiring voter approval at an election is (the
18 school district voter-approval rate determined under Section
19 [26.08](#), Tax Code). This election will be automatically held if the
20 district adopts a rate in excess of the voter-approval rate of (the
21 school district voter-approval rate)."; and

22 (9) contain a section entitled "Fund Balances," which
23 must include the estimated amount of interest and sinking fund

1 "BTR" is the district's bond tax rate for the current year,
2 which is determined by dividing the amount budgeted by the district
3 for payment of eligible bonds by the quotient of the district's
4 taxable value of property as determined under Subchapter M, Chapter
5 403, Government Code, or, if applicable, Section 48.258, divided by
6 100; and

7 "DPV" is the district's taxable value of property as
8 determined under Subchapter M, Chapter 403, Government Code, or, if
9 applicable, Section 48.258.

10 SECTION 40. Section 46.005, Education Code, is amended to
11 read as follows:

12 Sec. 46.005. LIMITATION ON GUARANTEED AMOUNT. The
13 guaranteed amount of state and local funds for a new project that a
14 district may be awarded in any state fiscal biennium under Section
15 46.003 for a school district may not exceed the lesser of:

9 SECTION 43. Sections 48.0051(a) and (b), Education Code,

7 average enrollment [~~daily attendance~~] of a school district all or

4 indebtedness that is rated by a nationally recognized rating agency
5 for municipal securities in one of the four highest rating
6 categories for a long-term obligation;

7 (B) a conservation and reclamation district
8 created and organized as a river authority under Section 52,
9 Article III, or Section 59, Article XVI, Texas Constitution;

10 (C) a joint powers agency organized and operating
11 under Chapter 163, Utilities Code;

12 (D) a metropolitan rapid transit authority,
13 regional transportation authority, or coordinated county
14 transportation authority created, organized, or operating under
15 Chapter 451, 452, or 460, Transportation Code;

16 (E) a conservation and reclamation district
17 organized or operating as a navigation district under Section 52,
18 Article III, or Section 59, Article XVI, Texas Constitution;

19 (F) a district organized or operating under
20 Section 59, Article XVI, Texas Constitution, that has all or part of
21 two or more municipalities within its boundaries;

22 (G) a state agency, including a state institution
23 of higher education;

24 (H) a hospital authority created or operating
25 under Chapter 262 or 264, Health and Safety Code, in a county that:

26 (i) has a population of more than 3.3
27 million; or

1 (ii) is included, in whole or in part, in a
2 standard metropolitan statistical area of this state that includes
3 a county with a population of more than 2.2 million;

4 (I) a hospital district in a county that has a
5 population of more than two million;

6 (J) a nonprofit corporation organized to
7 exercise the powers of a higher education loan authority under
8 Section 53B.47(e), Education Code;

9 (K) a county:

10 (i) that has a population of 3.3 million or
11 more; or

12 (ii) that, on the date of issuance of
13 obligations under this chapter, has authorized, outstanding, or any
14 combination of authorized and outstanding, indebtedness of at least
15 \$100 million secured by and payable from the county's ad valorem
16 taxes and the authorized long-term indebtedness of which is rated
17 by a nationally recognized rating agency of securities issued by
18 local governments in one of the four highest rating categories for a
19 long-term obligation;

20 (L) an independent school district that has an
21 average enrollment [~~daily attendance~~] of 50,000 or more as
22 determined under Section 48.005, Education Code;

23 (M) a municipality or county operating under
24 Chapter 334, Local Government Code;

25 (N) a district created under Chapter 335, Local
26 Government Code;

27 (O) a junior college district that has a total

1 headcount enrollment of 40,000 or more based on enrollment in the
2 most recent regular semester; or

3 (P) an issuer, as defined by Section 1201.002,
4 that has:

5 (i) a principal amount of at least \$100
6 million in outstanding long-term indebtedness, in long-term
7 indebtedness proposed to be issued, or in a combination of
8 outstanding or proposed long-term indebtedness; and

9 (ii) some amount of long-term indebtedness
10 outstanding or proposed to be issued that is rated in one of the
11 four highest rating categories for long-term debt instruments by a
12 nationally recognized rating agency for municipal securities,
13 without regard to the effect of any credit agreement or other form
14 of credit enhancement entered into in connection with the
15 obligation.

16 SECTION 77. Section 1431.001(3), Government Code, is
17 amended to read as follows:

18 (3) "Eligible school district" means an independent
19 school district that has an average enrollment [~~daily attendance~~]
20 of 190,000 or more as determined under Section 48.005, Education
21 Code.

22 SECTION 78. Section 325.011(a), Local Government Code, is
23 amended to read as follows:

24 (a) The district is governed by a board of directors
25 composed of five members, with two directors appointed by the
26 commissioners court of the county, two directors appointed by the
27 governing body of the municipality having the largest population in

1 the county, and one director appointed by the governing body of the
2 school district with the largest number of students in average
3 enrollment [~~daily attendance~~] in the county. The board shall
4 manage the district and administer this chapter.

5 SECTION 79. Section 313.027(i), Tax Code, is amended to
6 read as follows:

7 (i) A person and the school district may not enter into an
8 agreement under which the person agrees to provide supplemental
9 payments to a school district or any other entity on behalf of a
10 school district in an amount that exceeds an amount equal to the
11 greater of \$100 per student per year in average enrollment [~~daily
12 attendance~~], as defined by Section 48.005, Education Code, or
13 \$50,000 per year, or for a period that exceeds the period beginning
14 with the period described by Section 313.021(4) and ending December
15 31 of the third tax year after the date the person's eligibility for
16 a limitation under this chapter expires. This limit does not apply
17 to amounts described by Subsection (f)(1) or (2).

18 SECTION 80. Section 1, Article 2688d, Vernon's Texas Civil
19 Statutes, is amended to read as follows:

20 Section 1. In all counties of the State where, according to
21 the preceding annual statistical report of the schools said county
22 has not more than four (4) school districts, with one (1) of such
23 districts comprising more than half of the county and having more
24 than two thousand (2,000) pupils in average enrollment [~~daily
25 attendance~~] in the one (1) district alone, and such district having
26 an assessed valuation of more than Twenty Million Dollars
27 (\$20,000,000) and where there is only one (1) common school

1 district in such county with an average enrollment [~~daily~~
2 ~~attendance~~] of less than sixteen (16), the office of county
3 superintendent is hereby abolished, to be effective at the end of
4 the term of the incumbent county superintendent, as is now provided
5 by law.

6 SECTION 81. The following provisions of the Education Code
7 are repealed:

8 (1) Section 29.0822(d-1); and

9 (2) Section 48.007.

10 SECTION 82. This Act takes effect September 1, 2023.
