- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 2054.1125, Government Code, is
- 6 transferred to Subchapter R, Chapter 2054, Government Code,
- 7 redesignated as Section 2054.603, Government Code, and amended to
- 8 read as follows:
- 9 Sec. 2054.603 [2054.1125]. SECURITY INCIDENT [BREACH]
- 10 NOTIFICATION BY STATE AGENCY OR LOCAL GOVERNMENT. (a) In this
- 11 section:
- 12 (1) "Security incident" means the actual or suspected
- 13 unauthorized access, disclosure, exposure, modification, or
- 14 destruction of sensitive personal information, confidential
- 15 information, or other information the disclosure of which is
- 16 regulated by law, including:
- 17 <u>(A) a breach or suspected breach ["Breach</u>] of
- 18 system security as defined [security" has the meaning assigned] by
- 19 Section 521.053, Business & Commerce Code; and
- 20 (B) the introduction of ransomware, as defined by
- 21 Section 33.023, Penal Code, into a computer, computer network, or
- 22 computer system.
- 23 (2) "Sensitive personal information" has the meaning
- 24 assigned by Section 521.002, Business & Commerce Code.

- 1 (b) A state agency or local government that owns, licenses,
- 2 or maintains computerized data that includes sensitive personal
- 3 information, confidential information, or information the
- 4 disclosure of which is regulated by law shall, in the event of a
- 5 security incident [breach or suspected breach of system security or
- 6 an unauthorized exposure of that information]:
- 7 (1) comply with the notification requirements of
- 8 Section 521.053, Business & Commerce Code, to the same extent as a
- 9 person who conducts business in this state; [and]
- 10 (2) not later than 48 hours after the discovery of the
- 11 security incident [breach, suspected breach, or unauthorized
- 12 exposure], notify:
- 13 (A) the department, including the chief
- 14 information security officer; or
- 15 (B) if the <u>security incident</u> [breach, suspected
- 16 breach, or unauthorized exposure] involves election data, the
- 17 secretary of state; and
- 18 (3) comply with all department rules relating to
- 19 security incidents.
- 20 (c) Not later than the 10th business day after the date of
- 21 the eradication, closure, and recovery from a security incident
- 22 [breach, suspected breach, or unauthorized exposure], a state
- 23 agency or local government shall notify the department, including
- 24 the chief information security officer, of the details of the
- 25 security incident [event] and include in the notification an
- 26 analysis of the cause of the security incident [event].
- 27 SECTION 2. This Act takes effect September 1, 2023.
