(3) "Gender identity or expression" means having or 18 being perceived as having a gender-related identity, appearance, 19 expression, or behavior, regardless of whether that identity, 20 appearance, expression, or behavior is different from that commonly 21 associated with the individual's actual or perceived sex assigned 22 23 or designated at birth. 24 (4) "Public accommodation" means a business or other

24	SUBCHAPTER B. DISCRIMINATION IN PUBLIC ACCOMMODATIONS PROHIBITED
25	Sec. 100B.051. PUBLIC ACCOMMODATIONS. (a) Except as
26	provided by Subsection (b), a person engages in a discriminatory
27	practice and violates this chapter if the person, because of the

1 sexual orientation or gender identity or expression of an 2 individual: 3 (1) denies that individual full and equal accommodation in any place of public accommodation in this state, 4 5 subject only to the conditions and limitations established by law and applicable to all persons; or 6 7 (2) otherwise discriminates against or segregates or 8 separates the individual based on sexual orientation or gender identity or expression. 9 10 (b) A person does not engage in a discriminatory practice or violate this chapter under Subsection (a) if segregation or 11 12 separation of an individual is necessary to provide a service that: (1) provides acceptance, support, and understanding 13 14 to the individual; 15 (2) assists the individual with coping with the individual's sexual orientation or gender identity or expression, 16 17 maintaining social support, and exploring and identifying the individual's identity; or 18 19 (3) provides support to an individual undergoing a gender transition. 20 21 (c) The services described by Subsection (b)(2) include a sexual orientation-neutral intervention for preventing or 22 addressing unlawful conduct or unsafe sexual practices if the 23 24 intervention does not seek to change the individual's sexual orientation or gender identity or expression. 25 26 SUBCHAPTER C. CAUSE OF ACTION Sec. 100B.101. CIVIL ACTION. An aggrieved person may file a 27

1 civil action in district court not later than the second 2 anniversary of the occurrence of the termination of an alleged discriminatory practice under this chapter to obtain appropriate 3 relief with respect to the discriminatory practice. 4 5 Sec. 100B.102. RELIEF GRANTED. In an action under this subchapter, if the court finds that a discriminatory practice has 6 7 occurred or is about to occur, the court may award to the plaintiff: 8 actual and punitive damages; 9 (2) reasonable attorney's fees; 10 (3) court costs; and 11 (4) any permanent or temporary injunction, temporary 12 restraining order, or other order, including an order enjoining the defendant from engaging in the practice or ordering other 13 appropriate action. 14 15 SECTION 2. Subchapter A, Chapter 2155, Government Code, is 16 amended by adding Section 2155.0065 to read as follows: 17 Sec. 2155.0065. PROHIBITION AGAINST DISCRIMINATION ΒY STATE CONTRACTOR BASED ON SEXUAL ORIENTATION OR GENDER IDENTITY OR 18 EXPRESSION. (a) In this section: 19 "Employee" means an individual who is employed by 20 (1) a contractor or subcontractor for compensation. 21 (2) "Gender identity or expression" means having or 22 being perceived as having a gender-related identity, appearance, 23 24 expression, or behavior, regardless of whether that identity, appearance, expression, or behavior is different from that commonly 25 26 associated with the individual's actual or perceived sex assigned 27 or designated at birth.

No. 274 (3) "Sexual orientation" means the actual or perceived 1 status of an individual with respect to the individual's sexuality. 2 3 (b) A state agency contracting with a contractor under this subtitle shall require the contractor to adopt and apply an 4 5 employment policy under which the contractor and any subcontractor may not, because of sexual orientation or gender identity or 6 7 expression: 8 (1) fail or refuse to hire an individual, discharge an individual, or discriminate in any other manner against an 9 10 individual in connection with compensation or the terms, conditions, or privileges of employment; or 11 12 (2) limit, segregate, or classify an employee or applicant for employment in a manner that would deprive or tend to 13 deprive an individual of any employment opportunity or adversely 14 15 affect in any other manner the status of an employee. (c) Each contract entered into between a state agency and a 16 17 contractor under this subtitle must include terms that: (1) authorize an employee of a contractor or 18 19 subcontractor, or an applicant for employment with the contractor or subcontractor, to make a verbal or written complaint to the state 20 agency regarding the contractor's or subcontractor's noncompliance 21 with an employment policy required by Subsection (b); 22 (2) explain that, on confirmation of a contractor's or 23 24 subcontractor's noncompliance with an employment policy required by Subsection (b) that is the subject of a complaint, the state 25 26 agency shall provide to the contractor written notice of the noncompliance by hand delivery or certified mail; 27

(3) inform a contractor that the state agency may 1 impose an administrative penalty if the contractor fails to comply 2 with an employment policy required by Subsection (b) after the date 3 on which the contractor receives notice under Subdivision (2); and 4 5 (4) explain that an amount equal to the amount of the 6 administrative penalty may be withheld from a payment otherwise 7 owed to a contractor under a contract. 8 (d) The amount of an administrative penalty imposed under Subsection (c)(3) is \$100 per day for each employee or applicant for 9 employment who is discriminated against in violation of an 10

11 <u>employment policy required by Subsection (b).</u>

12 (e) Each state agency shall develop procedures for the 13 administration of this section.

 an individual, or discriminates in any other manner against an
 individual in connection with compensation or the terms,
 conditions, or privileges of employment; or

27 SECTION 9. Section 21.059(a), Labor Code, is amended to

1 read as follows:

2 (a) An employer, labor organization, employment agency, or 3 joint labor-management committee controlling an apprenticeship, 4 on-the-job training, or other training or retraining program 5 commits an unlawful employment practice if the employer, labor 6 organization, employment agency, or committee prints or publishes 7 or causes to be printed or published a notice or advertisement 8 relating to employment that:

9 (1) indicates a preference, limitation, 10 specification, or discrimination based on race, color, disability, 11 religion, sex, national origin, [or] age<u>, sexual orientation, or</u> 12 <u>gender identity or expression</u>; and

13 (2) concerns an employee's status, employment, or 14 admission to or membership or participation in a labor union or 15 training or retraining program.

16 SECTION 10. Section 21.102(c), Labor Code, is amended to 17 read as follows:

(c) This section does not apply to standards of compensation or terms, conditions, or privileges of employment that are discriminatory on the basis of race, color, disability, religion, sex, national origin, [or] age<u>, sexual orientation, or gender</u> identity or expression.

25 Sec. 21.112. EMPLOYEES AT DIFFERENT LOCATIONS. An employer 26 does not commit an unlawful employment practice by applying to 27 employees who work in different locations different standards of

compensation or different terms, conditions, or privileges of
 employment that are not discriminatory on the basis of race, color,
 disability, religion, sex, national origin, [or] age, sexual
 orientation, or gender identity or expression.

5 SECTION 12. Section 21.113, Labor Code, is amended to read 6 as follows:

7 Sec. 21.113. IMBALANCE PLAN NOT REQUIRED. 10 SECTION 14. Section 21.122(a), Labor Code, is amended to 11 read as follows:

12 (a) An unlawful employment practice based on disparate13 impact is established under this chapter only if:

(1) a complainant demonstrates that a respondent uses a particular employment practice that causes a disparate impact on the basis of race, color, sex, national origin, religion, [or] disability, sexual orientation, or gender identity or expression and the respondent fails to demonstrate that the challenged practice is job-related for the position in question and consistent with business necessity; or

(2) the complainant makes the demonstration in accordance with federal law as that law existed June 4, 1989, with respect to the concept of alternative employment practices, and the respondent refuses to adopt such an alternative employment practice.

26 SECTION 15. Section 21.124, Labor Code, is amended to read 27 as follows:

Sec. 21.124. PROHIBITION AGAINST DISCRIMINATORY USE OF TEST 1 SCORES. It is an unlawful employment practice for a respondent, in 2 3 connection with the selection or referral of applicants for employment or promotion, to adjust the scores of, use different 4 5 cutoff scores for, or otherwise alter the results of employment-related tests on the basis of race, color, sex, national 6 origin, religion, age, [or] disability, sexual orientation, or 7 8 gender identity or expression.

10 (1) serve on the elected official's personal staff; 11 (2) serve the elected official on a policy-making 12 level; or

13 (3) serve the elected official as an immediate advisor 14 with respect to the exercise of the constitutional or legal powers 15 of the office.

SECTION 19. Section 21.152(a), Labor Code, is amended to read as follows:

(a) A political subdivision or two or more politicalsubdivisions acting jointly may create a local commission to:

(b) A person may not discriminate against another in the terms, conditions, or privileges of sale or rental of a dwelling or in providing services or facilities in connection with a sale or rental of a dwelling because of race, color, religion, sex, familial status, [or] national origin<u>, sexual orientation, or</u> <u>gender identity or expression</u>.

SECTION 23. Section 301.022, Property Code, is amended to read as follows:

Sec. 301.022. PUBLICATION. A person may not make, print, or 19 publish or effect the making, printing, or publishing of a notice, 20 statement, or advertisement that is about the sale or rental of a 21 dwelling and that indicates any preference, limitation, or 22 discrimination or the intention to make a preference, limitation, 23 24 discrimination because of race, color, religion, sex, or disability, familial status, [or] national origin, sexual 25 26 orientation, or gender identity or expression.

SECTION 24. Section 301.023, Property Code, is amended to

2 Sec. 301.023. INSPECTION. A person may not represent to 3 another because of race, color, religion, sex, disability, familial 4 status, [or] national origin<u>, sexual orientation, or gender</u> 5 <u>identity or expression</u> that a dwelling is not available for 6 inspection for sale or rental when the dwelling is available for 7 inspection.

8 SECTION 25. Section 301.024, Property Code, is amended to 9 read as follows:

10 Sec. 301.024. ENTRY INTO NEIGHBORHOOD. A person may not, 11 for profit, induce or attempt to induce another to sell or rent a 12 dwelling by representations regarding the entry or prospective 13 entry into a neighborhood of a person of a particular race, color, 14 religion, sex, disability, familial status, [or] national origin<u>,</u> 15 sexual orientation, or gender identity or expression.

SECTION 26. Section 301.026(a), Property Code, is amended to read as follows:

(a) A whose business includes 18 person engaging in 19 residential real estate related transactions may not discriminate against another in making a real estate related transaction 20 21 available or in the terms or conditions of a real estate related transaction because of race, color, religion, sex, disability, 22 familial status, [or] national origin, sexual orientation, or 23 24 gender identity or expression.

25 SECTION 27. Section 301.027, Property Code, is amended to 26 read as follows:

27 Sec. 301.027. BROKERAGE SERVICES. A person may not deny

1 another access to, or membership or participation in, a multiple-listing service, real estate brokers' organization, or 2 3 other service, organization, or facility relating to the business of selling or renting dwellings, or discriminate against a person 4 in the terms or conditions of access, membership, or participation 5 in such an organization, service, or facility because of race, 6 color, religion, sex, disability, familial status, [or] national 7 8 origin, sexual orientation, or gender identity or expression.

9 SECTION 28. Sections 301.042(a) and (c), Property Code, are 10 amended to read as follows:

11 (a) This chapter does not prohibit а religious 12 organization, association, or society or a nonprofit institution or organization operated, supervised, or controlled by or 13 in 14 conjunction with a religious organization, association, or society 15 from:

16 (1) limiting the sale, rental, or occupancy of 17 dwellings that it owns or operates for other than a commercial 18 purpose to persons of the same religion; or

19 (2) giving preference to persons of the same religion,
20 unless membership in the religion is restricted because of race,
21 color, [or] national origin, sexual orientation, or gender identity
22 or expression.

(c) This chapter does not prohibit a person engaged in the
business of furnishing appraisals of real property from considering
in those appraisals factors other than race, color, religion, sex,

1 SECTION 29. Section 301.068, Property Code, is amended to 2 read as follows:

3 Sec. 301.068. REFERRAL TO MUNICIPALITY. (a) Subject to 4 <u>Subsection (b), the</u> [The] commission may defer proceedings under 5 this chapter and refer a complaint to a municipality that has been 6 certified by the federal Department of Housing and Urban 7 Development as a substantially equivalent fair housing agency.

8 (b) The commission may not defer proceedings and refer a 9 complaint under Subsection (a) to a municipality in which the 10 alleged discrimination occurred if:

11 (1) the complaint alleges discrimination based on 12 sexual orientation or gender identity or expression; and

13 (2) the municipality does not have laws prohibiting 14 <u>the alleged discrimination.</u>

1 the business of selling or renting dwellings; or

2 (2) because the person is or has been or to intimidate3 the person from:

(A) participating, without discrimination
because of race, color, religion, sex, disability, familial status,
[or] national origin, <u>sexual orientation, or gender identity or</u>
<u>expression,</u> in an activity, service, organization, or facility
described by Subdivision (1); [or]

9 (B) affording another person opportunity or 10 protection to so participate; or

(C) lawfully aiding or encouraging other persons to participate, without discrimination because of race, color, religion, sex, disability, familial status, [or] national origin, <u>sexual orientation, or gender identity or expression,</u> in an activity, service, organization, or facility described by Subdivision (1).

17 SECTION 31. (a) Section 2155.0065, Government Code, as 18 added by this Act, applies only to a contract for which a state 19 agency first advertises or otherwise solicits bids, proposals, 20 offers, qualifications, or other similar expressions of interest on 21 or after the effective date of this Act.

(b) The changes in law made by this Act to the Labor Code apply to conduct occurring on or after the effective date of this Act. Conduct occurring before that date is governed by the law in effect on the date the conduct occurred, and the former law is continued in effect for that purpose.

(c) The changes in law made by this Act to the Property Code

apply only to a complaint filed with the Texas Workforce Commission on or after the effective date of this Act. A complaint filed before that date is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose.
