## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the extension of the period of community supervision
- 3 for certain defendants who fail to pay a previously assessed fine or
- 4 cost.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Article 42A.753, Code of Criminal Procedure, is
- 7 amended by amending Subsections (a) and (b) and adding Subsections
- 8 (b-1) and (b-2) to read as follows:
- 9 (a) On a showing of good cause, the judge may extend a period
- 10 of community supervision under Article 42A.752(a)(2) as frequently
- 11 as the judge determines is necessary, but, except as otherwise
- 12 provided by this article, the period of community supervision in a
- 13 first, second, or third degree felony case may not exceed 10 years
- 14 and [, except as otherwise provided by Subsection (b), ] the period
- 15 of community supervision in a misdemeanor case may not exceed three
- 16 years.
- 17 (b) <u>Subject to Subsection (b-2), the [The]</u> judge may extend
- 18 the period of community supervision in a misdemeanor case for any
- 19 period the judge determines is necessary [, not to exceed an
- 20 additional two years beyond the three-year limit provided by
- 21 Subsection (a), if:
- 22 (1) the defendant fails to pay a previously assessed
- 23 [fine, cost, or] restitution amount; and
- 24 (2) the judge determines that extending the

- 1 supervision period will increase [increases] the likelihood that
- 2 the defendant will fully pay the [fine, cost, or] restitution
- 3 amount.
- 4 (b-1) For any period the judge determines is necessary but
- 5 subject to Subsection (b-2), in a felony or misdemeanor case the
- 6 judge may extend the period of community supervision based on the
- 7 defendant's failure to pay a previously assessed fine or cost only
- 8 if the judge, after a hearing, determines that:
- 9 <u>(1) the defendant has the financial resources to pay</u>
- 10 the fine or cost; and
- 11 (2) extending the supervision period will increase the
- 12 likelihood that the defendant will fully pay the fine or cost.
- 13 (b-2) The total length of an extension of the period of
- 14 community supervision under Subsection (b) or (b-1), as applicable,
- 15 <u>in a felony or misdemeanor case may not exceed an additional two</u>
- 16 years beyond the applicable limit provided by Subsection (a).
- 17 SECTION 2. The change in law made by this Act applies to a
- 18 person on community supervision, including deferred adjudication
- 19 community supervision, on or after the effective date of this Act,
- 20 regardless of whether the person was placed on community
- 21 supervision before, on, or after the effective date of this Act.
- 22 SECTION 3. This Act takes effect September 1, 2023.
