A BILL TO BE ENTITLED 1 AN ACT 2 relating to the inclusion of a school safety domain for evaluating 3 districts and campuses under the public school accountability 4 system. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Sections 39.053(a-1) and (c), Education Code, are amended to read as follows: 7 (a-1) The indicators adopted by the commissioner under 8 Subsection (a) must measure and evaluate school districts and 9 campuses with respect to: 10 11 (1)improving student preparedness for success in: subsequent grade levels; and 12 (A) 13 (B) entering the workforce, the military, or 14 postsecondary education; reducing, with the goal of eliminating, student 15 (2) academic achievement differentials among students from different 16 racial and ethnic groups and socioeconomic backgrounds; [and] 17 18 providing a safe learning environment; and (3) (4) informing parents and the community regarding 19 20 campus and district performance. 21 (c) School districts and campuses must be evaluated based on four [three] domains of indicators of achievement adopted under 22 this section that include: 23 (1) in the student achievement domain, indicators of 24

1 student achievement that must include:

2 (A) for evaluating the performance of districts3 and campuses generally:

4 (i) an indicator that accounts for the 5 of assessment instruments required under results Sections 39.023(a), (c), and (l), as applicable for the district and campus, 6 including the results of assessment instruments required for 7 8 graduation retaken by a student, aggregated across grade levels by subject area, including: 9

10 (a) for the performance standard 11 determined by the commissioner under Section 39.0241(a), the 12 percentage of students who performed satisfactorily on the 13 assessment instruments, aggregated across grade levels by subject 14 area; and

(b) for the college readiness performance standard as determined under Section 39.0241, the percentage of students who performed satisfactorily on the assessment instruments, aggregated across grade levels by subject area; and

an indicator that accounts for the 20 (ii) 21 results of assessment instruments required under Section 39.023(b), as applicable for the district and campus, including the 22 23 percentage of students who performed satisfactorily on the 24 assessment instruments, as determined by the performance standard adopted by the agency, aggregated across grade levels by subject 25 26 area; and

(B) for evaluating the performance of high school

No. 475 1 campuses and districts that include high school campuses, indicators that account for: 2 3 (i) students who satisfy the Texas Success Initiative (TSI) college readiness benchmarks prescribed by the 4 5 Texas Higher Education Coordinating Board under Section 51.334 on an assessment instrument in reading or mathematics designated by 6 the coordinating board under that section; 7 8 (ii) students who satisfy relevant performance standards on advanced placement tests or similar 9 10 assessments; (iii) students who earn dual course credits 11 12 in the dual credit courses; students who enlist in the 13 (iv) armed 14 forces of the United States or the Texas National Guard; 15 (v) students who industry earn 16 certifications; 17 (vi) students admitted into postsecondary industry certification programs that require as a prerequisite for 18 19 entrance successful performance at the secondary level; (vii) students whose successful completion 20 21 of a course or courses under Section 28.014 indicates the student's preparation to enroll and succeed, without remediation, in an 22 23 entry-level general education course for a baccalaureate degree or 24 associate degree; 25 (viii) students who successfully met 26 standards on a composite of indicators that through research indicates the student's preparation to enroll and succeed, without 27

No. 475 remediation, in an entry-level general education course for a 1 baccalaureate degree or associate degree; 2 3 (ix) high school graduation rates, computed in accordance with standards and definitions adopted in compliance 4 5 with the Every Student Succeeds Act (20 U.S.C. Section 6301 et seq.) subject to the exclusions provided by Subsections (g), (g-1), 6 (q-2), (q-3), and (q-4); 7 students who successfully completed an 8 (X) OnRamps dual enrollment course; 9 10 (xi) students who successfully completed a practicum or internship approved by the State Board of Education; 11 (xii) students who are awarded an associate 12 degree; and 13 14 (xiii) students who successfully completed 15 a program of study in career and technical education; 16 in the school progress domain, indicators for (2) 17 effectiveness in promoting student learning, which must include: (A) for assessment 18 instruments, including assessment instruments under Subdivisions (1)(A)(i) and (ii), the 19 percentage of students who met the standard for improvement, as 20 determined by the commissioner; and 21 for evaluating relative performance, the 22 (B) 23 performance of districts and campuses compared to similar districts 24 or campuses; [and] (3) in the closing the gaps domain, the use of 25 26 disaggregated data to demonstrate the differentials among students 27 from different racial and ethnic groups, socioeconomic

No. 475 1 backgrounds, and other factors, including: 2 (A) students formerly receiving special 3 education services; 4 students continuously enrolled; and (B) 5 students who are mobile; and (C) 6 (4) in the school safety domain, indicators for effectiveness in promoting a safe learning environment, including: 7 (A) the security of school facilities; 8 9 (B) training of faculty and staff to improve 10 school safety; (C) instruction to students to improve school 11 12 safety; and (D) the integration of local, state, and federal 13 14 resources into school safety programs. 15 SECTION 2. Section 39.301(d), Education Code, is amended to read as follows: 16 Performance on the indicators described by Sections 17 (d) <u>39.053(c)(1), (2), and (3)</u> [Section <u>39.053(c)</u>] and Subsections 18 (c)(3), (4), and (9) must be based on longitudinal student data that 19 is disaggregated by the bilingual education or special language 20 program, if any, in which emergent bilingual students, as defined 21 by Section 29.052, are or former emergent bilingual students were 22 enrolled. If a student described by this subsection is not or was 23 24 not enrolled in specialized language instruction, the number and percentage of those students shall be provided. 25 SECTION 3. This Act applies beginning with the 2023-2024 26

school year.

1 SECTION 4. This Act takes effect immediately if it receives 2 a vote of two-thirds of all the members elected to each house, as 3 provided by Section 39, Article III, Texas Constitution. If this 4 Act does not receive the vote necessary for immediate effect, this 5 Act takes effect September 1, 2023.
