- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 61.603, Education Code, is amended to 6 read as follows:
- 7 Sec. 61.603. ELIGIBILITY. (a) Except as provided by
- 8 Subsection (b), to [To] be eligible to receive repayment assistance
- 9 under this subchapter, a mental health professional must:
- 10 (1) apply to the board;
- 11 (2) have completed one, two, or three[, four, or five]
- 12 consecutive years of practice in a mental health professional
- 13 shortage area designated by the Department of State Health
- 14 Services; and

- 15 (3) provide mental health services in this state to:
- 16 (A) recipients under the medical assistance
- 17 program authorized by Chapter 32, Human Resources Code;
- 18 (B) enrollees under the child health plan program
- 19 authorized by Chapter 62, Health and Safety Code; or
- 20 (C) persons committed to a secure correctional
- 21 facility operated by or under contract with the Texas Juvenile
- 22 Justice Department or persons confined in a secure correctional
- 23 facility operated by or under contract with any division of the
- 24 Texas Department of Criminal Justice.

A mental health professional may also establish 1 (b) 2 eligibility for the repayment assistance under this subchapter by satisfying the requirements of this subsection. To establish 3 eligibility under this subsection, the mental health professional 4 5 must: (1) apply to the board; 6 7 (2) provide mental health services to: (A) patients in a state hospital, as defined by 8 9 Section 552.0011, Health and Safety Code; or 10 (B) individuals receiving community-based mental health services from a local mental health authority that provides 11 the services in accordance with Subchapter B, Chapter 534, Health 12 13 and Safety Code; and (3) have completed one, two, or three consecutive 14 years of practice in this state as described by Subdivision (2). 15 16 [In addition to satisfying the requirements under Subsection (a), for a licensed physician to be eligible to receive repayment 17 assistance under this subchapter after the physician's third 18 consecutive year of practice described under Subsection (a)(2), the 19 20 physician must be certified in psychiatry by: 21 [(1) the American Board of Psychiatry and Neurology; 22 [(2) the American Osteopathic Board of Neurology 23 24 Psychiatry. 25 SECTION 2. - 1 assistance under Subchapter K, Chapter 61, Education Code, as
- 2 amended by this Act, on the basis of an application submitted on or
- 3 after September 1, 2023. A person who first establishes
- 4 eligibility on the basis of an application submitted before
- 5 September 1, 2023, is governed by the law in effect at the time the
- 6 application was submitted, and the former law is continued in
- 7 effect for that purpose.
- 8 SECTION 6. This Act takes effect September 1, 2023.
