- 1 SECTION 4. Section 250.0035, Health and Safety Code, is
- 2 amended by adding Subsection (c-1) to read as follows:
- 3 (c-1) Chapter 53, Occupations Code, does not apply to the
- 4 <u>issuance or renewal of a nurse aide's certificate of registration</u>
- 5 or an applicant's inclusion in the nurse aide registry under this
- 6 <u>section</u>.
- 7 SECTION 5. The changes in law made by this Act to Chapters
- 8 242 and 250, Health and Safety Code, apply only to a license,
- 9 permit, or certificate of registration issued or renewed on or
- 10 after the effective date of this Act. A license, permit, or
- 11 certificate of registration issued or renewed before the effective
- 12 date of this Act is governed by the law in effect when the license,
- 13 permit, or certificate was issued or renewed, and the former law is
- 14 continued in effect for that purpose.
- 15 SECTION 6. This Act takes effect September 1, 2023.
