3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Title 2, Agriculture Code, is amended by adding
5	Chapter 23 to read as follows:
6	CHAPTER 23. FOOD SYSTEM SECURITY
7	Sec. 23.001. DEFINITIONS. In this chapter:
8	(1) "Council" means the Texas food system security and
9	resiliency planning council.
10	(2) "Office" means:
11	(A) the office of food system security and
12	resiliency if that office is established as a division within the
13	department by an Act of the 88th Legislature, Regular Session,
14	<u>2023; or</u>
15	(B) the food and nutrition division of the
16	department if the office of food system security and resiliency is
17	not established as a division within the department by an Act of the
18	88th Legislature, Regular Session, 2023.
19	Sec. 23.002. TEXAS FOOD SYSTEM SECURITY AND RESILIENCY
20	PLANNING COUNCIL. (a) The office shall establish the Texas food
21	system security and resiliency planning council. The council is
22	<pre>composed of the following members:</pre>
23	(1) seven members appointed by the governor;
24	(2) seven members appointed by the lieutenant

- 1 governor;
- 2 (3) six members appointed by the speaker of the house
- 3 of representatives;
- 4 (4) one member appointed by the commissioner to
- 5 represent food banks;
- 6 (5) the assistant commissioner of agriculture for the
- 7 <u>food and nutrition division as a nonvoting member;</u>
- 8 (6) the director of the Texas A&M AgriLife Extension
- 9 Service as a nonvoting member; and
- 10 (7) one nonvoting member appointed by the executive
- 11 commissioner of the Health and Human Services Commission to
- 12 represent the supplemental nutrition assistance program, the
- 13 federal special supplemental nutrition program for women, infants,
- 14 and children, and the supplemental nutrition assistance
- 15 program-education.
- 16 (b) A council member serves at the pleasure of the
- 17 appointing authority.
- 18 (c) The governor shall designate a chair of the council from
- 19 the members that the governor appoints. The lieutenant governor
- 20 shall designate a vice chair of the council from the members that
- 21 the lieutenant governor appoints.
- 22 <u>(d) The council shall meet at least once quarterly or more</u>
- 23 frequently at the call of the chair.
- (e) A member of the council is not entitled to compensation
- 25 or reimbursement for expenses incurred in performing council
- 26 duties.
- 27 <u>(f) The council shall:</u>

1	(1) give guidance to the office; and
2	(2) review the state food system security plan
3	developed under Section 23.003.
4	Sec. 23.003. STATE FOOD SYSTEM SECURITY PLAN. (a) The
5	office shall develop a state food system security plan. The plan
6	must:
7	(1) provide for the orderly development and management
8	of food system security throughout this state, including ensuring
9	sufficient food is available at a reasonable cost to:
10	(A) ensure public health, safety, and welfare;
11	(B) further economic development; and
12	(C) protect the agricultural and natural
13	resources of this state;
14	(2) account for times of severe drought conditions,
15	natural disaster, man-made disaster, or other calamities; and
16	(3) include legislative recommendations that are
17	needed or desirable to facilitate the resilience and availability
18	of food in this state.
19	(b) In developing the plan, the office shall seek the advice
20	of:
21	(1) the Department of State Health Services; and
22	(2) the Parks and Wildlife Department.
23	(c) The office shall:
24	(1) review and revise as necessary the plan developed
25	under Subsection (a) at least once every five years; and
26	(2) deliver the plan to the governor, the lieutenant
27	governor the speaker of the house of representatives and the

- 1 chair of the appropriate committees in each house of the
- 2 legislature.
- 3 Sec. 23.004. FOOD SYSTEM SECURITY PLANNING FUND. (a) In
- 4 this section, "planning fund" means the food system security
- 5 planning fund.
- 6 (b) The planning fund is a dedicated account in the general
- 7 revenue fund and consists of:
- 8 (1) appropriations of money to the planning fund by
- 9 the legislature;
- 10 (2) gifts, grants, including federal grants, and other
- 11 donations received for the planning fund; and
- 12 (3) interest earned on the investment of money in the
- 13 planning fund.
- 14 (c) The planning fund may be used only to administer the
- 15 council under Section 23.002.
- 16 <u>(d) The office may accept grants, gifts, or donations from</u>
- 17 any source that are made for the purposes of this section. Money
- 18 received under this subsection shall be deposited in the planning
- 19 fund.
- Sec. 23.005. TEXAS FOOD SYSTEM SECURITY AND RESILIENCY
- 21 GRANT PROGRAM. (a) In this section:
- 22 (1) "Eligible recipient" means:
- 23 (A) a municipality;
- 24 <u>(B) a county;</u>
- 25 (C) a council of government;
- 26 (D) a regional planning council;
- 27 (E) an economic development corporation;

1	(F) a transit authority;
2	(G) a nonprofit or similar organization;
3	(H) a farm or agricultural product or service
4	cooperative;
5	(I) a nonprofit farmers' market or grocery store;
6	<u>or</u>
7	(J) a micro-business as defined by Section
8	2006.001, Government Code.
9	(2) "Grant fund" means the Texas food system security
10	and resiliency projects fund.
11	(b) The grant fund is a dedicated account in the general
12	revenue fund and consists of:
13	(1) appropriations of money to the grant fund by the
14	<u>legislature;</u>
15	(2) gifts, grants, including federal grants, and other
16	donations received for the grant fund; and
17	(3) interest earned on the investment of money in the
18	grant fund.
19	(c) The office shall award grants to eligible recipients to
20	increase food system security or resiliency in this state. To be
21	eligible for a grant, a project must be related to food production,
22	food system security, or food supply resiliency and have the
23	ability to impact either an individual community or the production
24	of a specific agricultural commodity.
25	(d) The grant fund may be used by the office only to:
26	(1) award grants under this section; and
27	(2) administer the grant program under this section.

- 1 Sec. 23.006. RULES. The department shall adopt rules
- 2 necessary to administer this chapter.
- 3 SECTION 2. (a) As soon as practicable after the effective
- 4 date of this Act, the Department of Agriculture shall adopt rules
- 5 and procedures as required to implement Chapter 23, Agriculture
- 6 Code, as added by this Act.
- 7 (b) As soon as practicable after the adoption of rules and
- 8 procedures under Subsection (a) of this section, the governor,
- 9 lieutenant governor, speaker of the house of representatives,
- 10 executive commissioner of the Health and Human Services Commission,
- 11 and commissioner of agriculture shall appoint the initial members
- 12 of the Texas food system security and resiliency planning council
- 13 under Section 23.002, Agriculture Code, as added by this Act.
- 14 SECTION 3. Not later than September 1, 2025, the office, as
- 15 that term is defined by Section 23.001, Agriculture Code, as added
- 16 by this Act, shall deliver the initial state food system security
- 17 plan as required by Section 23.003(c), Agriculture Code, as added
- 18 by this Act.
- 19 SECTION 4. This Act takes effect immediately if it receives
- 20 a vote of two-thirds of all the members elected to each house, as
- 21 provided by Section 39, Article III, Texas Constitution. If this
- 22 Act does not receive the vote necessary for immediate effect, this
- 23 Act takes effect September 1, 2023.
