SECTION 2. The change in law made by this Act to Section 26 27 61.603, Education Code, applies only to a person who first

1 establishes eligibility for loan repayment assistance under 2 Subchapter K, Chapter 61, Education Code, as amended by this Act, on 3 the basis of an application submitted on or after September 1, 2023. 4 A person who first establishes eligibility on the basis of an 5 application submitted before September 1, 2023, is governed by the 6 law in effect on the date the application was submitted, and the 7 former law is continued in effect for that purpose.
