5	SECTION 1. The heading to Subchapter I, Chapter 56A, Code of
6	Criminal Procedure, is amended to read as follows:
7	SUBCHAPTER I. PEACE OFFICER AND [REQUIRED NOTIFICATIONS BY] LAW
8	ENFORCEMENT AGENCY DUTIES; VICTIM NOTIFICATIONS
9	SECTION 2. Subchapter I, Chapter 56A, Code of Criminal
10	Procedure, is amended by adding Article 56A.403 to read as follows:
11	Art. 56A.403. DUTIES OF PEACE OFFICERS REGARDING VICTIMS OF
12	SEXUAL ASSAULT. (a) A peace officer who investigates an incident
13	involving sexual assault or who responds to a disturbance call that
14	may involve sexual assault shall provide to the victim a writter
15	notice containing information about the rights of crime victims
16	under Article 56A.052.
17	(b) At the initial contact or at the earliest possible time
18	after the initial contact between a sexual assault victim and the

- 12 <u>(c) Each law enforcement agency shall consult with a local</u>

- 7 preventative medications, even if you decide not to make a report to
- 8 <u>a law enforcement agency;</u>
- 9 <u>"(2) anonymously track or receive updates regarding the</u>
- 10 status and location of each item of evidence collected in your case;
- 11 <u>"(3) have a sexual assault program advocate present during a</u>
- 12 <u>forensic medical examination;</u>
- "(4) have a sexual assault program advocate or other victim's
- 14 representative present during an investigative interview with law
- 15 enforcement;
- 16 <u>"(5) ask the local prosecutor to file a criminal complaint</u>
- 17 against the person who assaulted you; and
- 18 <u>"(6) if a defendant is arrested for a crime against you</u>

1 "(2) threatening, harassing, or contacting you or a member of 2 your family or household; and 3 "(3) going near your place of employment or near a child care facility or school attended by you or a member of your family or 4 household." 5 6 "You cannot be charged a fee by a court in connection with 7 filing, serving, or entering a protective order." "If you have questions about the status of your case or need 8 9 assistance, you may contact the crime victim liaison (insert name) at our agency (law enforcement agency address and victim liaison 10 11 phone number)." "If you would like to speak with someone in the prosecuting 12 attorney's office, you may reach their victim assistance 13 coordinator at (address and phone number)." 14 15 "Call the following sexual assault program or social service 16 organization if you need assistance or wish to speak with an 17 advocate: 18 19 "You may receive a sexual assault forensic medical 20 examination at the following location(s): 21 22 23 "To get help from the National Human Trafficking Hotline: 24 25 1-888-373-7888 or text HELP or INFO to BeFree (233733)." (e) A sexual assault program may provide a written 26 27 description of the program's services to a law enforcement agency,

- 3 SECTION 3. Article 56A.402, Code of Criminal Procedure, is
- 4 repealed.
- 5 SECTION 4. The changes in law made by this Act apply only to
- 6 a sexual assault reported on or after the effective date of this
- 7 Act. A sexual assault reported before the effective date of this
- 8 Act is governed by the law in effect on the date the sexual assault
- 9 was reported, and the former law is continued in effect for that
- 10 purpose.
- 11 SECTION 5. This Act takes effect September 1, 2023.
