| 6 | BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: |
| 7 | SECTION 1. Subtitle Z, Title 10, Government Code, is |
| 8 | amended by adding Chapter 3001 to read as follows: |
| 9 | CHAPTER 3001. GOVERNMENTAL ACTION RELATED TO PERSONAL AFFILIATION |
| 10 | INFORMATION |
| 11 | Sec. 3001.001. DEFINITIONS. In this chapter: |
| 12 | (1) "Nonprofit organization" means an entity that is |
| 13 | exempt from federal income tax under Section 501(a), Internal |
| 14 | Revenue Code of 1986, by being listed as an exempt entity under |
| 15 | Section 501(c) of that code, has submitted an application with the |
| 16 | Internal Revenue Service for recognition of an exemption under |
| 17 | Section 501(c) of that code, or is a nonprofit corporation or |
| 18 | association organized or formed under the laws of this state or |
| 19 | another state. |

(2) "Personal affiliation information" means a list, 20 record, registry, roster, or other compilation of any data that 21 directly or indirectly identifies a person as a member, supporter, 22 or volunteer of, or a donor of financial or nonfinancial support to, 23 24 a nonprofit organization.

1 (3) "Public agency" means a state or local 2 governmental unit, including: (A) this state or a department, agency, office, 3 commission, board, division, or other entity of this state in the 4 executive branch of state government; 5 6 (B) any state or local court or other judicial or 7 quasi-judicial body in the judicial branch of state government; 8 (C) a university system or an institution of 9 higher education, as defined by Section 61.003, Education Code; or (D) a political subdivision of this state, 10 including a county, municipality, school district, community 11 college district, or any other local governmental unit, agency, 12 13 authority, council, board, or commission. Sec. 3001.002. PROTECTED PERSONAL AFFILIATION INFORMATION. 14 (a) Notwithstanding any other law except Section 3001.003, a 15 public agency or an officer or employee of a public agency may not: 16 17 (1) require an individual to provide personal 18 affiliation information to the agency or otherwise compel the release of personal affiliation information; 19 20 (2) require a nonprofit organization to provide personal affiliation information to the agency or otherwise compel 21 the release of personal affiliation information; 22 (3) release, publicize, or otherwise publicly 23 disclose personal affiliation information in the 24 agency's 25 possession; or (4) request or require a current or prospective 26

contractor with or grantee of the agency to provide to the agency a

- 2 has provided financial or nonfinancial support.
- 3 (b) Personal affiliation information is excepted from
- 4 release under Chapter 552.
- 5 Sec. 3001.003. EXCEPTIONS. Section 3001.002 does not apply
- 6 to:
- 7 (1) personal affiliation information included in a
- 8 report required to be filed under state law by a candidate for
- 9 public office, a public official, or a person required to register
- 10 as a lobbyist under Chapter 305;
- 11 (2) a warrant for personal affiliation information
- 12 issued by a court in this state;
- 13 (3) a request for discovery of personal affiliation
- 14 <u>information in an action brought in a court in this state if the</u>
- 15 requestor:
- 16 (A) demonstrates by clear and convincing
- 17 <u>evidence a compelling need for the information; and</u>
- 18 (B) obtains a protective order barring release of
- 19 the information to any person not directly involved in the action;
- 20 (4) personal affiliation information admitted as
- 21 relevant evidence in an action before a court provided the court
- 22 does not publicly release the information unless the court
- 23 <u>specifically finds good cause for the release;</u>
- 24 (5) personal affiliation information voluntarily
- 25 released to the public by a person or nonprofit organization;
- 26 (6) personal affiliation information disclosing the
- 27 identity of a director, officer, resident agent, or incorporator of

- 1 a nonprofit organization in any report, including a report required
- 2 under state law to be filed with the secretary of state, provided
- 3 that information directly identifying an individual as a donor of
- 4 financial support to a nonprofit organization is not collected or
- 5 disclosed;
- 6 (7) personal affiliation information that is derived
- 7 from an individual's donation to a nonprofit organization
- 8 <u>affiliated with a public agency and is required by state law, unless</u>
- 9 the individual submitted a request for the nonprofit organization
- 10 to maintain the individual's anonymity; and
- 11 (8) personal affiliation information obtained by a
- 12 national securities association registered under Section 15A of the
- 13 Securities Exchange Act of 1934 (15 U.S.C. Section 780-3), obtained
- 14 under regulations adopted under that Act, or provided by a national
- 15 securities association to a state agency in accordance with that
- 16 Act and state law.
- Sec. 3001.004. CIVIL ACTION. A person who alleges a
- 18 violation of Section 3001.002 may bring a civil action to obtain
- 19 appropriate:
- 20 (1) injunctive relief;
- 21 (2) damages incurred by the person in an amount equal
- 22 <u>to:</u>
- (A) not less than \$2,500 as compensatory damages
- 24 for injury or loss caused by each violation; or
- 25 (B) a sum not to exceed three times the amount
- 26 described in Paragraph (A) for each intentional violation; and
- 27 (3) court costs, including reasonable attorney's and

- 1 witness fees.
- 2 Sec. 3001.005. IMMUNITY WAIVED. A person who alleges a
- 3 violation of Section 3001.002 may sue the public agency for the
- 4 relief provided under Section 3001.004. Sovereign or governmental
- 5 immunity, as applicable, is waived and abolished to the extent of
- 6 liability for that relief.
- 7 Sec. 3001.006. CRIMINAL PENALTY. A person commits an
- 8 offense if the person violates Section 3001.002. An offense under
- 9 this section is a Class B misdemeanor.
- 10 SECTION 2. Chapter 3001, Government Code, as added by this
- 11 Act, applies only to personal affiliation information released or
- 12 disclosed on or after the effective date of this Act.
- SECTION 3. This Act takes effect September 1, 2023.
