- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. DEFINITIONS. In this Act:
- 7 (1) "Authority" means the Angelina and Neches River
- 8 Authority.
- 9 (2) "City" means the City of Nacogdoches.
- 10 SECTION 2. TRANSFER OF WATER SYSTEM. (a) Notwithstanding
- 11 Section 1502.055, Government Code, not later than 180 days from the
- 12 effective date of this Act, the city shall enter into a contract
- 13 with the authority to transfer the city's ownership interests in
- 14 the Central Heights Water System that is north of the intersection
- of U.S. Highway 59 and U.S. Highway 259 to the authority, including
- 16 the assets and service area portion of the city's water system.
- 17 (b) On the date of execution of the contract under
- 18 Subsection (a):
- 19 (1) the geographic territory of the Central Heights
- 20 Water System shall be incorporated into the authority's certificate
- 21 of convenience and necessity; and
- 22 (2) all real property, easements, appurtenances,
- 23 conveyance systems, transmission and treatment systems, designated
- 24 rights-of-way, and other property interests of the city related to

- 1 the Central Heights Water System are transferred to the authority
- 2 unless specifically reserved to the city in the contract agreed to
- 3 under Subsection (a).
- 4 (c) Following the transfer under Subsection (b), the
- 5 governing body of the city shall notify the Texas Commission on
- 6 Environmental Quality of the transfer of the Central Heights Water
- 7 System to the authority.
- 8 (d) On receipt of notice under Subsection (c), the Texas
- 9 Commission on Environmental Quality shall note the transfer of the
- 10 Central Heights Water System to the authority in its records. A
- 11 person, party, or entity does not have any right of protest,
- 12 objection, or administrative review of the transfer described by
- 13 this Act.
- 14 SECTION 3. EFFECTIVE DATE. This Act takes effect
- 15 immediately if it receives a vote of two-thirds of all the members
- 16 elected to each house, as provided by Section 39, Article III, Texas
- 17 Constitution. If this Act does not receive the vote necessary for
- 18 immediate effect, this Act takes effect September 1, 2023.
