## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to motor vehicle registration and license plates.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. The heading to Section 502.094, Transportation
- 5 Code, is amended to read as follows:
- 6 Sec. 502.094. 72- OR 144-HOUR <u>TEMPORARY REGISTRATION</u>
- 7 PERMITS.
- 8 SECTION 2. Section 502.094, Transportation Code, is amended
- 9 by amending Subsections (a), (b), (c), (e), (f), (g), and (h) and
- 10 adding Subsection (i) to read as follows:
- 11 (a) The department may issue a temporary registration
- 12 permit [in lieu of registration] for a commercial motor vehicle,
- 13 trailer, semitrailer, or motor bus that:
- 14 (1) is owned by a resident of the United States,
- 15 Canada, or the United Mexican States;
- 16 (2) is subject to registration in this state; and
- 17 (3) is not authorized to travel on a public highway
- 18 because of the lack of registration in this state or the lack of
- 19 reciprocity with the state or province in which the vehicle is
- 20 registered.
- 21 (b) A <u>temporary registration</u> permit issued under this
- 22 section is valid for the period stated on the permit, effective from
- 23 the date and time shown on the receipt issued as evidence of
- 24 registration under this section.

- 1 (c) A person may obtain a <u>temporary registration</u> permit
- 2 under this section by:
- 3 (1) applying to the county assessor-collector or the
- 4 department;
- 5 (2) paying a fee of \$25 for a 72-hour <u>temporary</u>
- 6 registration permit or \$50 for a 144-hour temporary registration
- 7 permit in the manner prescribed by the department that may include a
- 8 service charge for a credit card payment or escrow account;
- 9 (3) furnishing to the county assessor-collector or the
- 10 department evidence of financial responsibility for the vehicle
- 11 that complies with Sections 502.046(c) and 601.168(a); and
- 12 (4) submitting a copy of the applicable federal
- 13 declaration form required by the Federal Motor Carrier Safety
- 14 Administration or its successor in connection with the importation
- 15 of a motor vehicle or motor vehicle equipment subject to the federal
- 16 motor vehicle safety, bumper, and theft prevention standards.
- 17 (e) A vehicle issued a <u>temporary registration</u> permit under
- 18 this section is subject to Subchapters B and F, Chapter 548, unless
- 19 the vehicle:
- 20 (1) is registered in another state of the United
- 21 States, in a province of Canada, or in a state of the United Mexican
- 22 States; or
- 23 (2) is mobile drilling or servicing equipment used in
- 24 the production of gas, crude petroleum, or oil, including a mobile
- 25 crane or hoisting equipment, mobile lift equipment, forklift, or
- 26 tug.
- 27 (f) A commercial motor vehicle, trailer, semitrailer, or

- 1 motor bus apprehended for violating a registration law of this
- 2 state:
- 3 (1) may not be issued a temporary registration permit
- 4 under this section; and
- 5 (2) is immediately subject to registration in this
- 6 state.
- 7 (g) A person who operates a commercial motor vehicle,
- 8 trailer, or semitrailer with an expired temporary registration
- 9 permit issued under this section is considered to be operating an
- 10 unregistered vehicle subject to each penalty prescribed by law.
- 11 (h) The department may establish one or more escrow accounts
- 12 in the Texas Department of Motor Vehicles fund for the prepayment of
- 13 a 72-hour [ $\frac{permit}{permit}$ ] or [ $\frac{a}{a}$ ] 144-hour temporary registration permit.
- 14 Any fee established by the department for the administration of
- 15 this subsection shall be administered as required by an agreement
- 16 entered into by the department.
- 17 (i) A temporary registration permit issued under this
- 18 section must be carried in the vehicle, or, if the vehicle is a
- 19 trailer or semitrailer, in the motor vehicle pulling the trailer or
- 20 semitrailer, at all times during the period in which the permit is
- 21 valid, including when the vehicle is being operated.
- SECTION 3. The heading to Section 502.095, Transportation
- 23 Code, is amended to read as follows:
- Sec. 502.095. ONE-TRIP OR 30-DAY <u>TEMPORARY REGISTRATION</u>
- 25 [TRIP] PERMITS.
- SECTION 4. Section 502.095, Transportation Code, is amended
- 27 by amending Subsections (a), (b), (d), (e), (f), and (g) and adding

- 1 Subsection (h) to read as follows:
- 2 (a) The department may issue a temporary <u>registration</u>
- 3 permit [in lieu of registration] for a vehicle subject to
- 4 registration in this state that is not authorized to travel on a
- 5 public highway because of the lack of registration in this state or
- 6 the lack of reciprocity with the state or country in which the
- 7 vehicle is registered.
- 8 (b) A <u>temporary registration</u> permit issued under this
- 9 section is valid for:
- 10 (1) one trip, as provided by Subsection (c); or
- 11 (2) 30 days, as provided by Subsection (d).
- 12 (d) A 30-day temporary registration permit may be issued
- 13 only to a passenger vehicle, a private bus, a trailer or semitrailer
- 14 with a gross weight of not more than 10,000 pounds, a light truck,
- 15 or a light commercial vehicle with a gross vehicle weight of more
- 16 than 10,000 pounds that will operate unladen. A person may obtain
- 17 multiple 30-day temporary registration permits. The department may
- 18 issue a single registration receipt to apply to all of the periods
- 19 for which the vehicle is registered.
- 20 (e) A vehicle issued a 30-day temporary registration permit
- 21 under this section is subject to Subchapters B and F, Chapter 548.
- 22 <u>(f)</u> A person may obtain a <u>temporary registration</u> permit
- 23 under this section by:
- 24 (1) applying as provided by the department to:
- 25 (A) the county assessor-collector of the county
- 26 in which the vehicle will first be operated on a public highway; or
- 27 (B) the department in Austin or at one of the

- 1 department's vehicle title and registration regional offices;
- 2 (2) paying a fee, in the manner prescribed by the
- 3 department including a registration service charge for a credit
- 4 card payment or escrow account of:
- 5 (A) \$5 for a one-trip permit; or
- 6 (B) \$25 for each 30-day period; and
- 7 (3) furnishing evidence of financial responsibility
- 8 for the vehicle in a form listed under Section 502.046(c).
- 9  $\underline{\text{(g)}}$  [ $\frac{\text{(f)}}{\text{)}}$ ] A registration receipt shall be carried in the
- 10 vehicle at all times during the period in which it is valid. The
- 11 temporary registration permit [temporary tag] must contain all
- 12 pertinent information required by this section and must be <u>attached</u>
- 13 to the vehicle in the license plate display area located at the rear
- 14 of the vehicle, so that the entire permit is visible and legible at
- 15 all times, including when the vehicle is being operated. If the
- 16 vehicle does not have a license plate display area at the rear of
- 17 the vehicle, the temporary registration permit [displayed in the
- 18 rear window of the vehicle so that the tag is clearly visible and
- 19 legible when viewed from the rear of the vehicle. If the vehicle
- 20 does not have a rear window, the temporary tag] must be attached to
- 21 [on or carried in] the vehicle to allow ready inspection. The
- 22 registration receipt must be carried, in a manner prescribed by the
- 23 <u>department</u>, in the vehicle at all times during the period in which
- 24 it is valid.
- (h)  $\left[\frac{g}{g}\right]$  The department may refuse and may instruct a
- 26 county assessor-collector to refuse to issue a temporary
- 27 registration permit for any vehicle if, in the department's

- 1 opinion, the vehicle or the owner of the vehicle has been involved
- 2 in operations that constitute an abuse of the privilege granted by
- 3 this section. A registration issued after notice to a county
- 4 assessor-collector under this subsection is void.
- 5 SECTION 5. Section 502.146(a), Transportation Code, is
- 6 amended to read as follows:
- 7 (a) The department shall issue distinguishing license
- 8 plates to a vehicle described by Subsection (b) or (c). The
- 9 department may issue distinguishing license plates to a vehicle
- 10 with a gross weight of 4,000 pounds or less if the vehicle otherwise
- 11 meets the requirements of Subsection (b)(1). The fee for the
- 12 license plates is \$5 and shall be deposited to the credit of the
- 13 Texas Department of Motor Vehicles fund.
- SECTION 6. Subchapter D, Chapter 502, Transportation Code,
- is amended by adding Section 502.147 to read as follows:
- 16 Sec. 502.147. CERTAIN FARM TRAILERS, FARM SEMITRAILERS,
- 17 FARM TRACTORS, AND IMPLEMENTS OF HUSBANDRY. An owner is not
- 18 required to register a farm trailer or farm semitrailer with a gross
- 19 weight of 4,000 pounds or less or a farm tractor or an implement of
- 20 husbandry if the trailer, semitrailer, tractor, or implement is
- 21 operated only temporarily on the highways.
- SECTION 7. Section 502.410(b), Transportation Code, is
- 23 amended to read as follows:
- (b) Subsection (a) does not apply to a statement or
- 25 application filed or given under Section 502.060, 502.092, 502.093,
- 26 502.094, 502.095, 504.201, 504.202(b-1), or 504.508[<del>, or 504.515</del>].
- 27 SECTION 8. Sections 502.413(e) and (f), Transportation

- 1 Code, are amended to read as follows:
- 2 (e) The department shall consult with the <u>Health and Human</u>
- 3 [Department of Aging and Disability] Services Commission is
- 4 performing the department's duties under this section.
- 5 (f) The Special Olympics Texas fund is created as a trust
- 6 fund outside the state treasury to be held by the comptroller and
- 7 administered by the <u>Health and Human</u> [Department of Aging and
- 8 Disability | Services Commission as trustee on behalf of Special
- 9 Olympics Texas. The fund is composed of money deposited to the
- 10 credit of the fund under this section. Money in the fund shall be
- 11 disbursed at least monthly, without appropriation, to Special
- 12 Olympics Texas to provide training and athletic competitions for
- 13 persons with mental illness and intellectual disabilities.
- SECTION 9. Section 502.474, Transportation Code, is amended
- 15 to read as follows:
- 16 Sec. 502.474. OPERATION OF ONE-TRIP PERMIT VEHICLE. A
- 17 person commits an offense if the person operates a vehicle for which
- 18 a one-trip permit is required without the registration receipt and
- 19 properly displayed permit [temporary tag].
- SECTION 10. Section 504.202(e-1), Transportation Code, is
- 21 amended to read as follows:
- 22 (e-1) Other than license plates issued under Subsection
- 23 (h), license plates issued under this section may include, on
- 24 request<u>,</u>[+
- 25 [(1) the emblem of the veteran's branch of service; or
- 26  $\left[\frac{(2)}{2}\right]$  one emblem or design from another license plate
- 27 to which the person is entitled under Subchapter D [Section

- 26 souvenir license plates, specialty license plates, or souvenir or
- 27 specialty license plates that are personalized that are marketed

- 1 and sold by the private vendor or hosted on the private vendor's
- 2 website. The state's portion of the personalization fee may not be
- 3 less than \$40 for each year issued. Other fees must be reasonable
- 4 and not less than the amounts necessary to allow the department to
- 5 recover all reasonable costs to the department associated with the
- 6 evaluation of the competitive sealed proposals received by the
- 7 department and with the implementation and enforcement of the
- 8 contract, including direct, indirect, and administrative costs. A

- 16 for the issuance of personalized license plates for that vehicle.
- 17 SECTION 23. Section 504.943(b), Transportation Code, is
- 18 amended to read as follows:
- 19 (b) A person commits an offense if the person operates on a
- 20 public highway during a registration period a road tractor, truck
- 21 tractor, motorcycle, trailer, or semitrailer that does not display
- 22 a license plate that:
- 23 (1) has been assigned by the department for the
- 24 period; and
- (2) complies with department rules regarding the
- 26 placement of license plates.
- 27 SECTION 24. Section 504.515, Transportation Code, is

- 1 repealed.
- 2 SECTION 25. Section 504.943, Transportation Code, as
- 3 amended by this Act, applies only to an offense committed on or
- 4 after the effective date of this Act. An offense committed before
- 5 the effective date of this Act is governed by the law in effect on
- 6 the date the offense was committed, and the former law is continued
- 7 in effect for that purpose. For purposes of this section, an
- 8 offense was committed before the effective date of this Act if any
- 9 element of the offense occurred before that date.
- 10 SECTION 26. To the extent of any conflict, this Act prevails
- 11 over another Act of the 88th Legislature, Regular Session, 2023,
- 12 relating to nonsubstantive additions to and corrections in enacted
- 13 codes.
- 14 SECTION 27. This Act takes effect September 1, 2023.
