A BILL TO BE ENTITLED

1	AN ACT
2	relating to establishing the Mold Assessment and Remediation
3	Advisory Board at the Texas Department of Licensing and Regulation.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 1958, Occupations Code, is amended by
6	adding Subchapter A-1 to read as follows:
7	SUBCHAPTER A-1. ADVISORY BOARD
8	Sec. 1958.031. (a) The Mold Assessment and Remediation
9	Advisory Board consists of nine members appointed by the presiding
10	officer of the commission, with the approval of the commission, as
11	follows:
12	(1) three members who are licensed mold assessment
13	consultants;
14	(2) three members who are licensed mold remediation
15	contractors;
16	(3) one member who is a building contractor
17	principally engaged in home construction and is a member of a
18	statewide building trade association;
19	(4) one member who is a representative of an
20	accredited mold training provider; and
21	(5) one member who represents the public.
22	(b) Appointments to the advisory board shall be made without
23	regard to the race, color, disability, sex, religion, age, or
24	national origin of the appointees.

- 2 <u>duration of the advisory committee.</u>
- 3 Sec. 1958.032. TERMS; VACANCY. (a) Members of the
- 4 advisory board serve staggered six-year terms, with the terms of
- 5 three members expiring on February 1 of each odd-numbered year.
- 6 (b) If a vacancy occurs during a member's term, the
- 7 presiding officer of the commission, with the commission's
- 8 approval, shall appoint a replacement to fill the unexpired term.
- 9 Sec. 1958.033. PRESIDING OFFICER. The presiding officer of
- 10 the commission, with the approval of the commission, shall appoint
- 11 one of the advisory board members to serve as presiding officer of
- 12 the advisory board for a term of one year.
- 13 Sec. 1958.034. DUTIES. The advisory board may advise the
- 14 commission and department on:
- 15 (1) technical matters relevant to the administration
- 16 of this chapter;
- 17 (2) standards or performance and work practices for
- 18 mold assessment or remediation;
- 19 (3) qualifications for an initial license and the
- 20 renewal of a license issued under this chapter, including any
- 21 training or continuing education; and
- 22 (4) other issues affecting mold assessment and
- 23 <u>remediation.</u>
- SECTION 2. (a) Not later than December 1, 2023, the
- 25 presiding officer of the Texas Commission of Licensing and
- 26 Regulation shall appoint members to the Mold Assessment and
- 27 Remediation Advisory Board in accordance with Section 1958.031,

- 1 Occupations Code, as added by this Act.
- 2 (b) Notwithstanding Section 1958.032, Occupations Code, as
- 3 added by this Act, in making the initial appointments to the Mold
- 4 Assessment and Remediation Advisory Board, the presiding officer of
- 5 the Texas Commission of Licensing and Regulation shall designate
- 6 three members of the advisory board to serve terms expiring
- 7 February 1, 2025, three members to serve terms expiring February 1,
- 8 2027, and three members to serve terms expiring February 1, 2029.
- 9 SECTION 3. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2023.
