A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the continuation and duties of the Sexual Assault
- 3 Survivors' Task Force and establishment of a mandatory training
- 4 program for peace officers on responding to reports of child sexual
- 5 abuse and adult sexual assault.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. Section 772.0064(m), Government Code, is amended
- 8 to read as follows:
- 9 (m) Chapter 2110 does not apply to the composition or
- 10 duration of the task force or to the designation of the task force's
- 11 presiding officer [This section expires September 1, 2023].
- 12 SECTION 2. Section 1701.253, Occupations Code, is amended
- 13 by adding Subsection (q) to read as follows:
- 14 (q) As part of the minimum curriculum requirements, the
- 15 commission shall require an officer to complete the basic education
- 16 and training program developed under Section 1701.272. An officer
- 17 shall complete the program not later than the second anniversary of
- 18 the date the officer is licensed under this chapter unless the
- 19 officer completes the program as part of the officer's basic
- 20 <u>training course</u>.
- 21 SECTION 3. Subchapter F, Chapter 1701, Occupations Code, is
- 22 amended by adding Section 1701.272 to read as follows:
- 23 <u>Sec. 1701.272. TRAINING PROGRAM ON RESPONDING TO SEXUAL</u>
- 24 ABUSE OR ASSAULT. (a) The commission shall, in consultation with

- 1 the Sexual Assault Survivors' Task Force established under Section
- 2 772.0064, Government Code, establish a basic education and training
- 3 program on child sexual abuse and adult sexual assault, including
- 4 the use of best practices and trauma-informed response techniques
- 5 to effectively recognize, investigate, and document those cases.
- 6 The training program must consist of at least eight hours of
- 7 <u>instruction</u>.
- 8 (b) The commission by rule shall require an officer to
- 9 complete the training program unless the officer has completed the
- 10 training under Section 1701.253(q) or other training equivalent to
- 11 the training program as determined by the commission.
- 12 SECTION 4. Section 1701.253(b-2), Occupations Code, is
- 13 repealed.
- 14 SECTION 5. Not later than January 1, 2024, the Texas
- 15 Commission on Law Enforcement shall establish the training program
- 16 required by Section 1701.272, Occupations Code, as added by this
- 17 Act.
- SECTION 6. Section 1701.253(q), Occupations Code, as added
- 19 by this Act, applies only to a person who submits an application for
- 20 a peace officer license under Chapter 1701, Occupations Code, on or
- 21 after January 1, 2024. A person who submits an application for a
- 22 peace officer license under Chapter 1701, Occupations Code, before
- 23 January 1, 2024, is governed by the law in effect immediately before
- 24 the effective date of this Act, and the former law is continued in
- 25 effect for that purpose.
- SECTION 7. This Act takes effect September 1, 2023.
