16	other court subject to this chapter.
17	(4) "Diversion" means an intervention strategy that
18	redirects a child from formal criminal prosecution and holds the
19	child accountable for the child's actions. The term includes

- 16 (2) a waiver of criminal jurisdiction and transfer of

- 18 Art. 45.304. DIVERSION ELIGIBILITY. (a) Except as
- 19 otherwise provided by this subchapter, a child shall be diverted
- 20 from formal criminal prosecution as provided by this subchapter.
- 21 (b) A child is not eligible for diversion if the child has
- 22 previously had two unsuccessful diversions under this subchapter
- 23 for offenses that were not part of a single criminal episode, as
- 24 defined by Section 3.01, Penal Code.
- (c) Notwithstanding Subsection (b), a court may find a child
- 26 eligible for diversion if they have two or more prior unsuccessful
- 27 diversions.

- 9 (2) use an educational curriculum other than the
- 10 curriculum selected by the parent.
- Art. 45.306. YOUTH DIVERSION PLAN. (a) A youth diversion
- 12 plan is a written plan that describes the types of strategies that
- 13 will be used to implement youth diversion. A youth diversion plan
- 14 does not limit the types of diversion strategies that may be imposed
- 15 under a diversion agreement under Article 45.308.
- 16 (b) Each justice and municipal court shall adopt a youth
- 17 diversion plan.
- 18 (c) A youth diversion plan may be devised for a county or
- 19 municipality or an individual court within a county or
- 20 municipality.
- 21 (d) In accordance with Chapter 791, Government Code, a local
- 22 government may enter into an agreement with one or more local
- 23 governments to create a regional youth diversion plan and
- 24 collaborate in the implementation of this subchapter.
- 25 (e) A youth diversion plan may include an agreement with a
- 26 service provider to provide services for a diversion strategy.
- 27 (f) A youth diversion plan may contain guidelines for

- 1 disposition or diversion of a child's case by law enforcement. The
- 2 guidelines are not mandatory.
- 3 (g) A current youth diversion plan must be maintained on
- 4 file for public inspection in each justice and municipal court,
- 5 including courts that collaborate with one or more counties or
- 6 municipalities.
- 7 (h) A court or local government may adopt rules necessary to
- 8 coordinate services under a youth diversion plan or to implement
- 9 this subchapter.
- 10 Art. 45.307. YOUTH DIVERSION COORDINATOR. (a) A court may
- 11 designate a youth diversion coordinator to assist the court in:
- 12 (1) determining whether a child is eligible for
- 13 diversion;
- 14 (2) employing a diversion strategy authorized by this
- 15 subchapter;
- 16 (3) presenting and maintaining diversion agreements;
- 17 (4) monitoring diversions;
- 18 (5) maintaining records regarding whether one or more
- 19 diversions were successful or unsuccessful; and
- 20 (6) coordinating referrals to court.
- 21 (b) The responsibilities of the youth diversion coordinator
- 22 may be performed by:
- (1) a court administrator or court clerk, or a person
- 24 who regularly performs the duties of court administrator or court
- 25 clerk;
- 26 (2) an individual or entity that provides juvenile
- 27 case manager services under Article 45.056;

11	Art. 45.308. DIVERSION AGREEMENT. (a) A diversion
12	agreement must identify the parties to the agreement and the
13	responsibilities of the child and the child's parent to ensure
14	their meaningful participation in a diversion under Article 45.309
15	<u>or 45.310.</u>
16	(b) Stated objectives in a diversion agreement must be
17	measurable, realistic, and reasonable and consider the
18	circumstances of the child, the best interests of the child, and the
19	<pre>long-term safety of the community.</pre>
20	(c) A diversion agreement must include:
21	(1) the terms of the agreement, including one or more
22	diversions required to be completed by the child, written in a clear
23	and concise manner and identifying any offense or charge being
24	<pre>diverted;</pre>
25	(2) possible outcomes or consequences of a successful
26	diversion and an unsuccessful diversion;
27	(3) an explanation that participation in a diversion

- 1 is not an admission of guilt and a guilty plea is not required to
- 2 participate in a diversion;
- 3 (4) an explanation of the process that will be used for
- 4 reviewing and monitoring compliance with the terms of the
- 5 agreement;
- 6 (5) the period of the diversion;
- 7 <u>(6) a verification that:</u>
- 8 (A) the child and the child's parent were
- 9 notified of the child's rights, including the right to refuse
- 10 diversion; and
- 11 (B) the child knowingly and voluntarily consents
- 12 to participate in the diversion; and
- 13 (7) written acknowledgment and acceptance of the
- 14 agreement by the child and the child's parent.
- 15 (d) The terms of an agreement may vary depending on the
- 16 circumstances of the child, including the child's age and ability,
- 17 the charge being diverted, or the diversion strategy utilized.
- 18 (e) A charge may not be filed against a child or, if filed,
- 19 shall be dismissed if the child:
- 20 (1) does not contest the charge;
- 21 (2) is eligible for diversion under Article 45.304;
- 22 <u>and</u>
- 23 (3) accepts the terms of the agreement.
- 24 (f) Entering into a diversion agreement under this article
- 25 extends the court's jurisdiction for the term of the agreement.
- 26 (g) On entering into a diversion agreement, a copy of the
- 27 agreement shall be provided to the child and the child's parent, the

- 1 clerk of the court, a youth diversion coordinator, and any person
- 2 specified by the youth diversion plan.
- 3 Art. 45.309. INTERMEDIATE DIVERSION. (a) If provided by a
- 4 youth diversion plan, a youth diversion coordinator or juvenile
- 5 case manager shall advise the child and the child's parent before a
- 6 case is filed that the case may be diverted under this article for a
- 7 reasonable period not to exceed 180 days if:
- 8 (1) the child is eligible for diversion under Article
- 9 45.304;
- 10 (2) diversion is in the best interests of the child and
- 11 promotes the long-term safety of the community;
- 12 (3) the child and the child's parent consent to
- 13 diversion with the knowledge that diversion is optional; and
- 14 (4) the child and the child's parent are informed that
- 15 they may terminate the diversion at any time and, if terminated, the
- 16 <u>case will be referred to court.</u>
- 17 (b) The terms of a diversion agreement under this article
- 18 must be in writing and may include any of the diversion strategies
- 19 under Article 45.305.
- 20 (c) The case of a child who successfully complies with the
- 21 terms of a diversion agreement under this article shall be closed
- 22 and reported as successful to the court.
- 23 (d) A child who does not comply with the terms of a diversion
- 24 agreement under this article shall be referred to court under
- 25 <u>Article 45.311.</u>
- 26 Art. 45.310. DIVERSION BY JUSTICE OR JUDGE. (a) If a
- 27 charge involving a child who is eligible for diversion is filed with

- 1 a court, a justice or judge shall divert the case under this article
- 2 as follows:
- 3 (1) if the child does not contest the charge, a justice
- 4 or judge shall divert the case under this article without the child
- 5 having to enter a plea; or
- 6 (2) if the child contests the charge, a justice or
- 7 judge shall divert the case under this article at the conclusion of
- 8 trial on a finding of guilt without entering a judgment of
- 9 conviction as provided by Article 45.041.
- 10 (b) A diversion under this article may not exceed 180 days.
- 11 (c) The terms of a diversion agreement under this article
- 12 must be in writing and may include any of the diversion strategies
- 13 described by Article 45.305.
- 14 (d) The case of a child who successfully complies with the
- 15 terms of a diversion agreement under this article shall be closed
- 16 <u>and reported as successful to the court.</u>
- 17 (e) A child who does not comply with the terms of a diversion
- 18 agreement under this article shall be referred to court for a
- 19 hearing under Article 45.311.
- 20 Art. 45.311. REFERRAL TO COURT. (a) A court shall conduct
- 21 a non-adversarial hearing for a child who does not successfully
- 22 <u>complete the terms of a diversion under Article 45.309 or 45.310 and</u>
- 23 <u>is referred to the court.</u>
- 24 (b) The hearing is an opportunity for a justice or judge to
- 25 confer with the child and the child's parent to determine whether a
- 26 diversion should be declared unsuccessful by the court. The court
- 27 may also hear from any person who may be of assistance to the child

- 1 or the court in determining what is in the best interests of the
- 2 child and the long-term safety of the community.
- 3 (c) After the hearing, a court may enter an order:
- 4 (1) amending or setting aside terms in the diversion
- 5 agreement;
- 6 (2) extending the diversion for a period not to exceed
- 7 one year from the initial start date of the diversion;
- 8 (3) issuing a continuance for the hearing for a period
- 9 not to exceed 60 days to allow an opportunity for compliance with
- 10 the terms of the diversion;
- 11 (4) subject to Subsection (d), requiring the child's
- 12 parent to perform any act or refrain from performing any act as the
- 13 court determines will increase the likelihood the child will
- 14 successfully complete the diversion and comply with any other order
- of the court that is reasonable and necessary for the welfare of the
- 16 child;
- 17 (5) finding the diversion successful on the basis of
- 18 substantial compliance; or
- 19 (6) finding the diversion unsuccessful and:
- 20 (A) transferring the child to juvenile court for
- 21 alleged conduct indicating a need for supervision under Section
- 22 <u>51.08</u>, Family Code; or
- (B) referring the charge to the prosecutor for
- 24 consideration of re-filing.
- 25 (d) An order under Subsection (c)(4) may not have the
- 26 substantive effect of interfering with a parent's fundamental right
- 27 to determine how to raise the parent's child, unless the court finds

- 1 that the interference is necessary to prevent significant
- 2 impairment of the child's physical, mental, or emotional health.
- 3 (e) An order under Subsection (c)(4) is enforceable against
- 4 the parent by contempt.
- 5 (f) The statute of limitations in Article 12.02(b) is tolled
- 6 during the diversion period for purposes of Subsection (c)(6)(B).
- 7 Art. 45.312. LOCAL YOUTH DIVERSION ADMINISTRATIVE FEE.
- 8 (a) The clerk of a justice or municipal court may collect from a
- 9 child's parent a \$50 administrative fee to defray the costs of the
- 10 diversion of the child's case under this subchapter.
- 11 (b) The fee under this article may not be collected unless
- 12 specified as a term of the diversion agreement accepted by the
- 13 child's parent. If the fee is not paid after giving the child's
- 14 parent an opportunity to be heard, the court shall order the parent,
- 15 <u>if financially able, to pay the fee to the clerk of the court.</u>
- 16 <u>(c) A court shall waive the fee if the child's parent is</u>
- 17 indigent or does not have sufficient resources or income to pay the
- 18 fee.
- 19 (d) A court may adopt rules for the waiver of a fee for
- 20 financial hardship under this article.
- 21 (e) An order under Subsection (b) is enforceable against the
- 22 parent by contempt.
- 23 <u>(f) The clerk of the court shall keep a record of the fees</u>
- 24 collected under this article and shall forward the funds to the
- 25 county treasurer, municipal treasurer, or person fulfilling the
- 26 role of a county treasurer or municipal treasurer, as appropriate.
- 27 (g) The fee collected under this article shall be deposited

- 1 in a special account that can be used only to offset the cost of the
- 2 operations of youth diversion programs under this subchapter.
- 3 (h) Except for the fee authorized under Subsection (a), a
- 4 fee may not be assessed for a child diverted under this subchapter.
- 5 (i) The diversion of a child may not be contingent on
- 6 payment of a fee under this article.
- 7 Art. 45.313. DIVERSION RECORDS. (a) A justice or
- 8 municipal court shall maintain statistics for each diversion
- 9 strategy authorized by this subchapter.
- 10 (b) Other than statistical records, all records generated
- 11 under this subchapter are confidential under Article 45.0217.
- 12 (c) All records of a diversion pertaining to a child under
- 13 this subchapter shall be expunged without the requirement of a
- 14 motion or request, on the child's 18th birthday.
- SECTION 2. Article 45.0215(a), Code of Criminal Procedure,
