- 5 SECTION 59. (a) Except as provided by Subsection (b) of
- 6 this section, Section 202.006, Human Resources Code, as amended by
- 7 this Act, applies to a member of the Texas Juvenile Justice Board
- 8 appointed before, on, or after the effective date of this Act.
- 9 (b) A member of the Texas Juvenile Justice Board who before
- 10 the effective date of this Act completed the training program
- 11 required by Section 202.006, Human Resources Code, as that law
- 12 existed before the effective date of this Act, is only required to
- 13 complete additional training on the subjects added by this Act to
