A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the administration of the Texas Innovative Adult Career
- 3 Education (ACE) Grant Program by the Texas Higher Education
- 4 Coordinating Board.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 136.001, Education Code, is amended by
- 7 amending Subdivision (1) and adding Subdivision (1-a) to read as
- 8 follows:
- 9 (1) "Coordinating board" means the Texas Higher
- 10 Education Coordinating Board.
- 11 (1-a) "Nonprofit organization" means an organization
- 12 exempt from federal income taxation under Section 501(a), Internal
- 13 Revenue Code of 1986, as an organization described by Section
- 14 501(c)(3) of that code.
- SECTION 2. Section 136.005(a), Education Code, is amended
- 16 to read as follows:
- 17 (a) The coordinating board [grant administrator] shall
- 18 establish and administer the Texas Innovative Adult Career
- 19 Education (ACE) Grant Program to provide grants to:
- 20 (1) eligible nonprofit workforce intermediary and job
- 21 training organizations; and
- 22 (2) eligible nonprofit organizations providing job
- 23 training to veterans.
- SECTION 3. Section 136.006, Education Code, is amended to

- 1 read as follows:
- 2 Sec. 136.006. ELIGIBLE ORGANIZATIONS. (a) To be eligible
- 3 for a grant under the program, a nonprofit workforce intermediary
- 4 and job training organization must:
- 5 (1) apply to the <u>coordinating board</u> [grant
- 6 administrator] in the manner prescribed by the coordinating board
- 7 [grant administrator];
- 8 (2) provide to eligible low-income students, in
- 9 partnership with public junior colleges, public state colleges, or
- 10 public technical institutes:
- 11 (A) job training; and
- 12 (B) a continuum of services designed to move a
- 13 program participant from application to employment, including
- 14 outreach, assessment, case management, support services, and
- 15 career placement;
- 16 (3) be governed by a board or other governing
- 17 structure that includes recognized leaders of broad-based
- 18 community organizations and executive-level or managerial-level
- 19 members of the local business community;
- 20 (4) demonstrate to the satisfaction of the
- 21 <u>coordinating board</u> [program advisory board] that the
- 22 organization's program has achieved or will achieve the following
- 23 measures of success among program participants:
- 24 (A) above-average completion of developmental
- 25 education among participating public junior college, public state
- 26 college, or public technical institute students;
- 27 (B) above-average persistence rates among

- 1 participating public junior college, public state college, or
- 2 public technical institute students;
- 3 (C) above-average certificate or degree
- 4 completion rates by participating students within a three-year
- 5 period compared to demographically comparable public junior
- 6 college, public state college, and public technical institute
- 7 students; and
- 8 (D) entry into careers with significantly higher
- 9 earnings for program participants than previously achieved; and
- 10 (5) provide matching funds in accordance with rules
- 11 adopted under this chapter.
- 12 (a-1) To be eligible for a grant under the program, a
- 13 nonprofit organization providing job training services to veterans
- 14 must:
- 15 (1) apply to the coordinating board [grant
- 16 administrator] in the manner prescribed by the coordinating board
- 17 [grant administrator];
- 18 (2) provide to veterans, in partnership with public
- 19 junior colleges, public state colleges, or public technical
- 20 institutes:
- 21 (A) job training; and
- 22 (B) a continuum of services designed to move a
- 23 program participant from application to employment, including
- 24 outreach, assessment, case management, support services, and
- 25 career placement;
- 26 (3) be governed by a board or other governing
- 27 structure that includes recognized leaders of broad-based

- 1 community organizations and executive-level or managerial-level
- 2 members of the local business community;
- 3 (4) demonstrate to the satisfaction of the
- 4 coordinating board [program advisory board] that the
- 5 organization's program has achieved or will achieve the following
- 6 measures of success among program participants:
- 7 (A) the measures prescribed by Subsections
- 8 (a) (4)(A)-(C);
- 9 (B) rapid attainment of civilian workforce
- 10 credentials; and
- 11 (C) entry into careers with significantly higher
- 12 earnings for program participants than previously achieved; and
- 13 (5) provide matching funds in accordance with rules
- 14 adopted under this chapter.
- 15 (b) The matching funds required under Subsection (a)(5) or
- 16 (a-1)(5) may be obtained from any source available to the
- 17 organization, including in-kind contributions, community or
- 18 foundation grants, individual contributions, and local
- 19 governmental agency operating funds. The coordinating board [grant
- 20 administrator] may adopt rules requiring an organization to
- 21 demonstrate compliance with the matching funds requirement before
- 22 the payment of the next installment under an awarded grant.
- 23 SECTION 4. Section 136.007, Education Code, is amended to
- 24 read as follows:
- Sec. 136.007. RULES. [(a)] The <u>coordinating board</u> [grant
- 26 administrator] shall adopt rules as necessary for the
- 27 administration of this chapter, including [in the manner provided

[(b) The grant administrator, with recommendations of the program advisory board, shall adopt] rules regarding eligibility,
```

by Chapter 2001, Government Code, for a state agency.

- 4 program tuition and fees, administrative costs, matching funds, and
- 5 case management and other supports for the program. The rules may
- 6 include provisions for the payment in periodic installments of
- 7 grant awards.

- 8 SECTION 5. The following provisions of Chapter 136,
- 9 Education Code, are repealed:
- 10 (1) Sections 136.002 and 136.004; and
- 11 (2) Section 136.005(a-1).
- 12 SECTION 6. This Act takes effect September 1, 2023.
