1 AN ACT 2 relating to the operation and management of the Iwo Jima monument 3 and museum by the Texas Historical Commission. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Chapter 442, Government Code, is amended by 5 6 adding Subchapter B-2 to read as follows: SUBCHAPTER B-2. IWO JIMA MONUMENT AND MUSEUM 7 Sec. 442.065. DEFINITION. In this subchapter, "monument 8 and museum" means the Iwo Jima monument and museum at the Marine 9 10 Military Academy in Harlingen, Texas. Sec. 442.066. IWO JIMA MONUMENT AND MUSEUM; FUND. (a) To 11 the extent authorized by law, the commission may enter into a 12 13 contract with the nonprofit entity that owns the monument and museum to transfer to the commission the operation and management 14 15 of the monument and museum. (b) The contract authorized by this section must include 16 17 provisions for: (1) expanding, renovating, managing, maintaining, 18 operating, or providing financial support for the monument and 19 museum, including administration, construction and operation of a 20 visitor center, and related activities; 21 22 (2) preserving military documents, relics, and other 23 items of historical interest;

(3) employing a museum director and other employees

- 1 the commission considers necessary to fulfill its duties and
- 2 responsibilities under the contract;
- 3 (4) accepting donations of money, property, and
- 4 historical relics; and
- 5 (5) acquiring property and historical relics with
- 6 <u>funds available for that purpose.</u>
- 7 (c) The Iwo Jima monument and museum fund is created as a
- 8 <u>fund outside the state treasury. The commission shall administer</u>
- 9 the fund but may contract with the nonprofit entity that owns the
- 10 monument and museum for administration of the fund. The fund
- 11 consists of:
- 12 (1) admissions revenue from the operation of the
- 13 monument and museum;
- 14 (2) sales revenue from the operation of the monument
- 15 and museum gift shop; and
- 16 (3) donations made to the commission for the monument
- 17 and museum.
- 18 (d) Money in the Iwo Jima monument and museum fund may be
- 19 spent without legislative appropriation and only to administer,
- 20 operate, preserve, repair, expand, or otherwise maintain the
- 21 monument and museum.
- (e) Interest and income from the assets of the Iwo Jima
- 23 monument and museum fund shall be credited to and deposited in the
- 24 <u>fund</u>.
- 25 SECTION 2. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this
