

AN ACT

relating to the participation of the medical school at The University of Texas Health Science Center at Tyler in the Joint Admission Medical Program.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 51.821(4), Education Code, is amended to read as follows:

(4) "Participating medical school" means each of the following entities:

(A) the medical school at The University of Texas Health Science Center at Houston;

(B) the medical school at The University of Texas Southwestern Medical Center;

(C) the medical school at The University of Texas Health Science Center at San Antonio;

(D) the medical school at The University of Texas Medical Branch at Galveston;

(E) the medical school at the Texas Tech University Health Sciences Center at Lubbock;

(F) the medical school at the Texas Tech University Health Sciences Center at El Paso;

(G) the Baylor College of Medicine;

(H) the college of osteopathic medicine at the University of North Texas Health Science Center at Fort Worth;

1 (I) the medical school at The Texas A&M
2 University System Health Science Center;

3 (J) the medical school at The University of Texas
4 at Austin;

5 (K) the medical school at The University of Texas
6 Rio Grande Valley;

7 (L) the medical school at the University of
8 Houston; ~~and~~

9 (M) the college of osteopathic medicine at Sam
10 Houston State University; and

11 (N) the medical school at The University of Texas
12 Health Science Center at Tyler.

13 SECTION 2. (a) As soon as practicable after the effective
14 date of this Act, the medical school at The University of Texas
15 Health Science Center at Tyler shall:

16 (1) enter into the agreement with the Joint Admission
17 Medical Program Council required by Section 51.829, Education Code;
18 and

19 (2) select an appropriate faculty member to represent
20 the medical school on the council.

21 (b) The medical school at The University of Texas Health
22 Science Center at Tyler shall provide internships and mentoring
23 under the Joint Admission Medical Program as appropriate beginning
24 not later than the 2025-2026 academic year, but is not required
25 before the 2026-2027 academic year to admit participating students
26 to the school under the program.

27 SECTION 3. This Act takes effect immediately if it receives

1 a vote of two-thirds of all the members elected to each house, as
2 provided by Section 39, Article III, Texas Constitution. If this
3 Act does not receive the vote necessary for immediate effect, this
4 Act takes effect September 1, 2023.
