- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 692A.005, Health and Safety Code, is
- 6 amended by amending Subsections (a) and (b) and adding Subsection
- 7 (b-1) to read as follows:
- 8 (a) A donor may make an anatomical gift:
- 9 (1) by authorizing a statement or symbol indicating
- 10 that the donor has made an anatomical gift to be imprinted on the
- 11 donor's driver's license or identification card;
- 12 (2) in a will;
- 13 (3) during a terminal illness or injury of the donor,
- 14 by any form of communication addressed to at least two adults, at
- 15 least one of whom is a disinterested witness; or
- 16 (4) as provided in Subsection (b) or (b-1).
- 17 (b) A donor or other person authorized to make an anatomical
- 18 gift under Section 692A.004 may make a gift by a donor card or other
- 19 record signed by the donor or other person making the gift or by
- 20 authorizing that a statement or symbol indicating the donor has
- 21 made an anatomical gift be included on a donor registry. If the
- 22 donor or other person is physically unable to sign a record, the
- 23 record may be signed by another individual at the direction of the
- 24 donor or other person and must:

- 1 (1) be witnessed by at least two adults, at least one
- 2 of whom is a disinterested witness, who have signed at the request
- 3 of the donor or the other person, or be acknowledged before a notary
- 4 public; and
- 5 (2) state that the record has been signed and
- 6 witnessed or acknowledged as provided in Subdivision (1).
- 7 (b-1) A donor or other person authorized to make an
- 8 <u>anatomical gift under Section 692A.004 may make a gift through an</u>
- 9 online registry. The online registration:
- 10 (1) does not require the consent of another person or
- 11 require a witness to sign at the donor's request or a notary public
- 12 to acknowledge the gift; and
- (2) constitutes a legal document under this chapter
- 14 that remains binding after the donor's death.
- SECTION 2. Section 692A.006(b), Health and Safety Code, is
- 16 amended to read as follows:
- (b) A record signed pursuant to Subsection (a)(1)(C) must:
- 18 (1) be witnessed by at least two adults, at least one
- 19 of whom is a disinterested witness, who have signed at the request
- 20 of the donor or the other person, or be acknowledged before a notary
- 21 public; and
- 22 (2) state that the record has been signed and
- 23 witnessed or acknowledged as provided in Subdivision (1).
- SECTION 3. Section 692A.007(b), Health and Safety Code, is
- 25 amended to read as follows:
- 26 (b) A record signed pursuant to Subsection (a)(1)(B) must:
- 27 (1) be witnessed by at least two adults, at least one

- 1 of whom is a disinterested witness, who have signed at the request
- 2 of the individual, or be acknowledged before a notary public; and
- 3 (2) state that the record has been signed and
- 4 witnessed or acknowledged as provided in Subdivision (1).
- 5 SECTION 4. Chapter 692, Health and Safety Code, is
- 6 repealed.
- 7 SECTION 5. Sections 692A.005, 692A.006, and 692A.007,
- 8 Health and Safety Code, as amended by this Act, apply only to the
- 9 validity of a record executed on or after the effective date of this
- 10 Act. The validity of a record executed before the effective date of
- 11 this Act is governed by the law in effect on the date the record was
- 12 executed, and that law continues in effect for that purpose.
- 13 SECTION 6. The change in law made by this Act applies only
- 14 to a document executed on or after the effective date of this Act. A
- 15 document executed before the effective date of this Act is governed
- 16 by the law on the date the document was executed, and that law is
- 17 continued in effect for that purpose.
- SECTION 7. This Act takes effect September 1, 2023.
