5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 531, Government Code, is amended by
7	adding Subchapter P to read as follows:
8	SUBCHAPTER P. BEHAVIORAL HEALTH CRISIS SERVICES
9	Sec. 531.601. DEFINITIONS. In this subchapter:
10	(1) "Crisis center" means a state-designated 988
11	Suicide & Crisis Lifeline center participating in the National
12	Suicide Prevention Lifeline network to respond to statewide or
13	regional communications.
14	(2) "Mobile crisis team" means a regionally located
15	multidisciplinary response behavioral health team.
16	Sec. 531.602. 988 SUICIDE AND CRISIS LIFELINE ADVISORY
17	COMMITTEE. (a) The 988 suicide and crisis lifeline advisory
18	committee is established to advise the commission and make
19	recommendations regarding implementing a state-designated 988
20	suicide and crisis lifeline.
21	(b) The advisory committee is composed of representatives
22	of the following:
23	(1) a crisis center;

10	(c) The executive commissioner shall appoint members to the
11	advisory committee.
12	Sec. 531.603. ESTABLISHMENT OF CRISIS CENTERS AND MOBILE
13	CRISIS TEAMS. (a) The commission shall establish:
14	(1) at least one crisis center to provide crisis
15	stabilization services to individuals in this state who are
16	accessing the 988 Suicide & Crisis Lifeline; and
17	(2) mobile crisis teams to respond to behavioral
18	health crises and provide crisis stabilization services.
19	(b) In establishing a crisis center, the executive
20	commissioner shall adopt rules to allow information sharing and
21	communication between a crisis center and a mobile crisis team to
22	enhance crisis care coordination.

5	Sec. 531.604. CRISIS CENTER POWERS AND DUTIES. (a) A
6	crisis center established by the commission shall:
7	(1) contract with the 988 Suicide & Crisis Lifeline;
8	(2) satisfy the requirements of and best practices
9	identified by the 988 Suicide & Crisis Lifeline;
10	(3) provide and report any applicable data;
11	(4) be equipped to deploy a mobile crisis team;
12	(5) satisfy the requirements for serving at-risk and
13	specialized populations as identified by the Substance Abuse and
14	Mental Health Services Administration;
15	(6) provide linguistically and culturally competent
16	care, including by requiring training and providing policies for
17	transferring a crisis center caller to an appropriate specialized
18	center within the 988 Suicide & Crisis Lifeline network; and
19	(7) provide follow-up services to individuals who call
20	the crisis center.
21	(b) The executive commissioner shall adopt rules to allow
22	appropriate information sharing and communication across crisis
23	response systems and emergency response systems to provide
24	real-time crisis care coordination.
25	Sec. 531.605. SERVING AT-RISK AND SPECIALIZED POPULATIONS.
26	A crisis center shall serve at-risk and specialized populations as
27	identified by the Substance Abuse and Mental Health Services

- 1 Administration. The populations served must include the LGBTQ
- 2 community, youth, minorities, individuals residing in rural areas,
- 3 veterans, American Indians, Alaska Natives, and individuals with
- 4 co-occurring substance use disorder and mental illness.
- 5 Sec. 531.606. CRISIS CARE COORDINATION. (a) The
- 6 commission shall ensure that an individual who contacts a crises
- 7 center is provided ongoing care through active collaboration and
- 8 coordination of services among crisis centers and mental health and
- 9 substance use disorder treatment providers, community mental
- 10 health centers, certified community behavioral health clinics,
- 11 community behavioral health centers, mobile crisis teams, hospital
- 12 emergency departments, and inpatient psychiatric settings.
- 13 (b) The commission may contract with the entities listed
- 14 under Subsection (a) to ensure the coordination of services.
- 15 Sec. 531.607. 988 SUICIDE AND CRISIS LIFELINE TRUST FUND.
- 16 (a) The 988 suicide and crisis lifeline trust fund is established
- 17 as a trust fund to be held by the comptroller outside the state
- 18 treasury and administered by the commission.
- 19 (b) The trust fund consists of:
- 20 (1) revenue derived from the fee described by Section
- 21 531.608;
- 22 (2) legislative appropriations of money for the
- 23 purposes of this subchapter;
- 24 (3) available federal funding this state allocates for
- 25 the purposes of the 988 Suicide & Crisis Lifeline;
- 26 (4) gifts, grants, and donations received by this
- 27 state for the purposes of the trust fund;

_	(5) Interest, dividends, and other income of the clust
2	fund; and
3	(6) money from any other source that is deposited in or
4	transferred to the trust fund.
5	(c) Money deposited in the trust fund may only be used to:
6	(1) implement, maintain, or improve the 988 Suicide &
7	Crisis Lifeline, including personnel and technological
8	infrastructure improvements necessary to achieve operational and
9	clinical standards and best practices as provided by the National
10	Suicide Prevention Lifeline;
11	(2) provide funding for crisis outreach and

- (e) The executive commissioner shall submit an annual

- 25 detailing the trust fund deposits and expenditures in the preceding

Sec. 531.608. 988 SUICIDE AND CRISIS LIFELINE FEE. (a) The

- 1 commission may impose a 988 suicide and crisis lifeline service fee
- 2 to supplement any federal, state, or local funding for suicide
- 3 prevention or behavioral health crisis services on each:
- 4 (1) local exchange access line or equivalent local
- 5 exchange access line, not including public telephone equipment
- 6 operated by coin or by card reader;
- 7 (2) wireless telecommunications connection;
- 8 (3) Voice over Internet Protocol service connection;
- 9 and
- 10 (4) purchase of a prepaid wireless telecommunications
- 11 service by any method.
- 12 (b) The executive commissioner by rule shall set the fee in
- 13 an amount sufficient to cover the costs of creating, operating, and
- 14 maintaining the suicide prevention services provided under this
- 15 subchapter, according to the national guidelines for crisis
- 16 services. The commission shall periodically adjust the fee amount
- 17 as necessary to provide for continuous operation, volume increases,
- 18 and maintenance.
- 19 (c) Revenue from the fee shall be deposited in the 988
- 20 suicide and crisis lifeline trust fund established under Section
- 21 531.607.
- 22 (d) A fee collected under this section may only be used to
- 23 offset costs as provided by 47 U.S.C. Section 251a.
- (e) Revenue from the fee may not be used for expenses that
- 25 are:
- 26 (1) reimbursable through Medicaid, Medicare, or
- 27 another insurer or governmental program; or

- 1 (2) covered because the service recipient's name and
- 2 health coverage information cannot be obtained or billed.
- 3 <u>(f) The executive commissioner shall submit an annual</u>
- 4 report to the legislature and the Federal Communications Commission
- 5 detailing the revenue generated by the fee in the preceding year.
- 6 Sec. 531.609. ANNUAL REPORT. (a) The commission shall
- 7 prepare an annual report of the usage of crisis centers and the
- 8 services provided by the centers.
- 9 (b) The commission shall present the annual report to the
- 10 legislature and the Substance Abuse and Mental Health Services
- 11 Administration.
- 12 SECTION 2. This Act takes effect September 1, 2023.
