4	SECTION 1. Chapter 444, Government Code, is amended by
5	adding Subchapter CC to read as follows:
6	SUBCHAPTER CC. CULTURAL ADVANCEMENT FUND PROGRAM
7	Sec.444.033. DEFINITIONS. In this subchapter:
8	(1) "Commission" means the Texas Commission on the
9	Arts.
10	(2) "Cultural advancement" means any efforts that
11	promote and support the sustainability of any culture in the State
12	of Texas, including a culture's art, dance, music, or history.
13	(a) For purposes of this section, "culture" means
14	any nationality, racial, or ethnic group.
15	(3) "Fund" means the cultural advancement fund created
16	under Section 444.034.
17	Sec. 444.034. CULTURAL ADVANCEMENT FUND. (a) The
18	commission shall establish and administer the Cultural Advancement
19	Fund as a dedicated account in the general revenue fund.
20	(b) The following amounts shall be deposited in the fund:
21	(1) any money appropriated by the legislature for
22	the fund for purposes of this chapter;
23	(2) interest earned on the investment of money in
24	the fund; and

1 (3) gifts, grants, and donations received for the 2 fund. Sec. 444.035. GRANT PROGRAM. (a) The commission shall 3 establish and administer the Cultural Advancement Fund grant 4 program to benefit cultural centers, nonprofit corporations 5 defined by section 22.001, Business Organizations Code, art venues, 6 7 museums, or other entities that spur economic development through cultural advancement. 8 9 (b) To be eligible to receive a grant under the grant program, an applicant must: 10 11 (1) apply in a manner prescribed by commission rule; 12 (2) be in good standing under the laws of this state; 13 and 14 (3) have a legitimate need for the grant. Sec.444.036. USES OF GRANT. A grant recipient may use the 15 16 grant received under this subchapter for any expense needed to promote cultural advancement, including costs related to payroll, 17 programming, remodeling, and renovating facilities. 18 Sec.444.037. RULES. The commission shall adopt rules 19 20 necessary to implement this subchapter.
