S.B. No. 2580

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the creation of the Liberty County Municipal Utility
3 District No. 12; granting a limited power of eminent domain;
4 providing authority to issue bonds; providing authority to impose
5 assessments, fees, and taxes.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Subtitle F, Title 6, Special District Local Laws
8 Code, is amended by adding Chapter 7977A to read as follows:

9 CHAPTER 7977A. LIBERTY COUNTY MUNICIPAL UTILITY DISTRICT NO. 12

10 SUBCHAPTER A. GENERAL PROVISIONS

11 Sec. 7977A.0101. DEFINITIONS. In this chapter:

12 (1) "Board" means the district's board of directors.

13 (2) "Commission" means the Texas Commission on
14 Environmental Quality.

15 (3) "Director" means a board member.

16 (4) "District" means the Liberty County Municipal
17 Utility District No. 12.

18 Sec. 7977A.0102. NATURE OF DISTRICT. The district is a
19 municipal utility district created under Section 59, Article XVI,
20 Texas Constitution.

21 Sec. 7977A.0103. CONFIRMATION AND DIRECTOR ELECTION
22 REQUIRED. The temporary directors shall hold an election to
23 confirm the creation of the district and to elect five permanent
24 directors as provided by Section 49.102, Water Code.

1 Sec. 7977A.0104. CONSENT OF MUNICIPALITY REQUIRED. The
2 temporary directors may not hold an election under Section
3 7977A.0103 until each municipality in whose corporate limits or
4 extraterritorial jurisdiction the district is located has
5 consented by ordinance or resolution to the creation of the
6 district and to the inclusion of land in the district as required by
7 applicable law.

8 Sec. 7977A.0105. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.

9 (a) The district is created to serve a public purpose and benefit.

10 (b) The district is created to accomplish the purposes of:

11 (1) a municipal utility district as provided by
12 general law and Section 59, Article XVI, Texas Constitution; and

13 (2) Section 52, Article III, Texas Constitution, that
14 relate to the construction, acquisition, improvement, operation,
15 or maintenance of macadamized, graveled, or paved roads, or
16 improvements, including storm drainage, in aid of those roads.

17 Sec. 7977A.0106. INITIAL DISTRICT TERRITORY. (a) The
18 district is initially composed of the territory described by
19 Section 2 of the Act enacting this chapter.

20 (b) The boundaries and field notes contained in Section 2 of
21 the Act enacting this chapter form a closure. A mistake made in the
22 field notes or in copying the field notes in the legislative process
23 does not affect the district's:

24 (1) organization, existence, or validity;

25 (2) right to issue any type of bond for the purposes
26 for which the district is created or to pay the principal of and
27 interest on a bond;

1 (3) right to impose a tax; or

2 (4) legality or operation.

3 SUBCHAPTER B. BOARD OF DIRECTORS

4 Sec. 7977A.0201. GOVERNING BODY; TERMS. (a) The district
5 is governed by a board of five elected directors.

6 (b) Except as provided by Section 7977A.0202, directors
7 serve staggered four-year terms.

8 Sec. 7977A.0202. TEMPORARY DIRECTORS. (a) On or after the
9 effective date of the Act enacting this chapter, the owner or owners
10 of a majority of the assessed value of the real property in the
11 district may submit a petition to the commission requesting that
12 the commission appoint as temporary directors the five persons
13 named in the petition. The commission shall appoint as temporary
14 directors the five persons named in the petition.

15 (b) Temporary directors serve until the earlier of:

16 (1) the date permanent directors are elected under
17 Section 7977A.0103; or

18 (2) the fourth anniversary of the effective date of
19 the Act enacting this chapter.

20 (c) If permanent directors have not been elected under
21 Section 7977A.0103 and the terms of the temporary directors have
22 expired, successor temporary directors shall be appointed or
23 reappointed as provided by Subsection (d) to serve terms that
24 expire on the earlier of:

25 (1) the date permanent directors are elected under
26 Section 7977A.0103; or

27 (2) the fourth anniversary of the date of the

1 appointment or reappointment.

2 (d) If Subsection (c) applies, the owner or owners of a
3 majority of the assessed value of the real property in the district
4 may submit a petition to the commission requesting that the
5 commission appoint as successor temporary directors the five
6 persons named in the petition. The commission shall appoint as
7 successor temporary directors the five persons named in the
8 petition.

9 SUBCHAPTER C. POWERS AND DUTIES

10 Sec. 7977A.0301. GENERAL POWERS AND DUTIES. The district
11 has the powers and duties necessary to accomplish the purposes for
12 which the district is created.

13 Sec. 7977A.0302. MUNICIPAL UTILITY DISTRICT POWERS AND
14 DUTIES. The district has the powers and duties provided by the
15 general law of this state, including Chapters 49 and 54, Water Code,
16 applicable to municipal utility districts created under Section 59,
17 Article XVI, Texas Constitution.

18 Sec. 7977A.0303. AUTHORITY FOR ROAD PROJECTS. Under
19 Section 52, Article III, Texas Constitution, the district may
20 design, acquire, construct, finance, issue bonds for, improve,
21 operate, maintain, and convey to this state, a county, or a
22 municipality for operation and maintenance macadamized, graveled,
23 or paved roads, or improvements, including storm drainage, in aid
24 of those roads.

25 Sec. 7977A.0304. ROAD STANDARDS AND REQUIREMENTS. (a) A
26 road project must meet all applicable construction standards,
27 zoning and subdivision requirements, and regulations of each

1 municipality in whose corporate limits or extraterritorial
2 jurisdiction the road project is located.

3 (b) If a road project is not located in the corporate limits
4 or extraterritorial jurisdiction of a municipality, the road
5 project must meet all applicable construction standards,
6 subdivision requirements, and regulations of each county in which
7 the road project is located.

8 (c) If the state will maintain and operate the road, the
9 Texas Transportation Commission must approve the plans and
10 specifications of the road project.

11 Sec. 7977A.0305. COMPLIANCE WITH MUNICIPAL CONSENT
12 ORDINANCE OR RESOLUTION. The district shall comply with all
13 applicable requirements of any ordinance or resolution that is
14 adopted under Section 54.016 or 54.0165, Water Code, and that
15 consents to the creation of the district or to the inclusion of land
16 in the district.

17 Sec. 7977A.0306. DIVISION OF DISTRICT. (a) The board, on
18 its own motion or on receipt of a petition signed by the owner or
19 owners of a majority of the assessed value of the real property in
20 the district, may adopt an order dividing the district.

21 (b) An order dividing a district may create one or more new
22 districts and may provide for the continuation of the district.

23 (c) An order dividing the district shall:

24 (1) name any new district;

25 (2) include the metes and bounds description of the
26 territory of each of the districts;

27 (3) appoint temporary directors for any new district;

1 and

2 (4) provide for the division of assets and liabilities
3 between the districts.

4 (d) The board may adopt an order dividing the district
5 before or after the date the board holds an election to confirm the
6 district's creation.

7 (e) The district may be divided only if the district:

8 (1) has never issued any bonds; and

9 (2) is not imposing ad valorem taxes.

10 (f) A new district created by the division of the district
11 may not, at the time the new district is created, contain any land
12 outside the area described by Section 2 of the Act enacting this
13 chapter.

14 (g) On or before the 30th day after the date of adoption of
15 an order dividing the district, the district shall file the order
16 with the commission and record the order in the real property
17 records of each county in which the district is located.

18 (h) This chapter applies to any new district created by the
19 division of the district, and a new district has all the powers and
20 duties of the district.

21 (i) A new district created by the division of the district
22 shall hold a confirmation and directors' election.

23 (j) If the creation of the new district is confirmed, the
24 new district shall provide the election date and results to the
25 commission.

26 (k) A new district created by the division of the district
27 must hold an election as required by this chapter to obtain voter

1 approval before the district may impose a maintenance tax or issue
2 bonds payable wholly or partly from ad valorem taxes.

3 (l) The district may continue to rely on confirmation,
4 directors', bond, or tax elections held prior to the division.

5 (m) Municipal consent to the creation of the district and to
6 the inclusion of land in the district acts as municipal consent to
7 the creation of any new district created by the division of the
8 district and to the inclusion of land in the new district.

9 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

10 Sec. 7977A.0401. ELECTIONS REGARDING TAXES OR BONDS. (a)
11 The district may issue, without an election, bonds and other
12 obligations secured by:

- 13 (1) revenue other than ad valorem taxes; or
14 (2) contract payments described by Section
15 7977A.0403.

16 (b) The district must hold an election in the manner
17 provided by Chapters 49 and 54, Water Code, to obtain voter approval
18 before the district may impose an ad valorem tax or issue bonds
19 payable from ad valorem taxes.

20 (c) The district may not issue bonds payable from ad valorem
21 taxes to finance a road project unless the issuance is approved by a
22 vote of a two-thirds majority of the district voters voting at an
23 election held for that purpose.

24 Sec. 7977A.0402. OPERATION AND MAINTENANCE TAX. (a) If
25 authorized at an election held under Section 7977A.0401, the
26 district may impose an operation and maintenance tax on taxable
27 property in the district in accordance with Section 49.107, Water

1 Code.

2 (b) The board shall determine the tax rate. The rate may not
3 exceed the rate approved at the election.

4 Sec. 7977A.0403. CONTRACT TAXES. (a) In accordance with
5 Section 49.108, Water Code, the district may impose a tax other than
6 an operation and maintenance tax and use the revenue derived from
7 the tax to make payments under a contract after the provisions of
8 the contract have been approved by a majority of the district voters
9 voting at an election held for that purpose.

10 (b) A contract approved by the district voters may contain a
11 provision stating that the contract may be modified or amended by
12 the board without further voter approval.

13 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

14 Sec. 7977A.0501. AUTHORITY TO ISSUE BONDS AND OTHER
15 OBLIGATIONS. The district may issue bonds or other obligations
16 payable wholly or partly from ad valorem taxes, impact fees,
17 revenue, contract payments, grants, or other district money, or any
18 combination of those sources, to pay for any authorized district
19 purpose.

20 Sec. 7977A.0502. TAXES FOR BONDS. At the time the district
21 issues bonds payable wholly or partly from ad valorem taxes, the
22 board shall provide for the annual imposition of a continuing
23 direct ad valorem tax, without limit as to rate or amount, while all
24 or part of the bonds are outstanding as required and in the manner
25 provided by Sections 54.601 and 54.602, Water Code.

26 Sec. 7977A.0503. BONDS FOR ROAD PROJECTS. At the time of
27 issuance, the total principal amount of bonds or other obligations

1 issued or incurred to finance road projects and payable from ad
2 valorem taxes may not exceed one-fourth of the assessed value of the
3 real property in the district.

4 SECTION 2. The Liberty County Municipal Utility District
5 No. 12 initially includes all the territory contained in the
6 following area:

7 TRACT 1 - 460.66 Acres

8 480.66 ACRES OF LAND, SITUATED IN THE F.J. C. SMILEY SURVEY,
9 ABSTRACT 345, LIBERTY COUNTY, TEXAS, BEING A PART OF THAT CERTAIN
10 590.04 ACRE TRACT DESCRIBED AS TRACT THREE IN A DEED FROM
11 INTERNATIONAL PAPER REALTY CORPORATION TO COPPER STATION HOLDINGS,
12 LLC RECORDED IN LIBERTY COUNTY CLERK'S FILE 2005004984, SAID 480.66
13 ACRES BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

14 BEGINNING at a concrete monument stamped "CP&F L-160" found
15 for the lower Northwest corner of the herein described tract at an
16 ell corner of said 590.04 acre tract, the Northeast corner of

26 the Northeast corner of the Bailey tract, being a corner of said
27 590.04 acre tract and the Southeast corner of the David L. Muck 10.0

1 acre tract described in clerk's File 2005003535, continue along the
2 West line of said 590.04 acre tract, at 1024.62 feet pass a 1/2 inch
3 iron rod set in the South right-of-way line of County Road 2184,
4 from which point a 3/8 inch iron rod found at a fence corner bears
5 North 70 deg. 46 min. 06 sec. East - 35.44 feet, and continue for a
6 total distance of 1050.63 feet to a 60d nail set for the upper
7 Northwest corner of the herein described tract in the centerline of
8 County Road 2184, said point being the southwest corner of the
9 Kaitlyn Hanka 42.87 acre tract described in Clerk's File

11 Thence North 70 deg. 39 min. 07 sec. East, along the
12 centerline of County Road 2184, with the Southerly line of the Hanka

16 tract, a distance of 376.40 feet to an angle point;

17 Thence North 68 deg. 18 min. 24 sec. East, along the
18 centerline of County Road 2184, with the southerly line of the Hanka
19 tract, a distance of 110.56 feet to an angle point;

20 Thence North 65 deg. 24 min. 12 sec. East, along the
21 centerline of County Road 2184, with the Southerly line of the Hanka
22 tract, a distance of 50.58 feet to an angle point;

23 Thence North 63 deg. 57 min. 20 sec. East, along the
24 centerline of County Road 2184, with the southerly line of the Hanka
25 tract, a distance of 51.05 feet to an angle point;

26 Thence North 61 deg. 43 min. 32 sec. East, along the
27 centerline of County Road 2184, with the southerly line of the Hanka

1 tract, a distance of 6.88 feet to an angle point;

2 Thence North 60 deg. 11 min. 45 Sec. East, along the
3 centerline of County Road 2184, with the Southerly line of the Hanka
4 tract, a distance of 153.55 feet to an angle point;

5 Thence North 59 deg. 30 min. 01 sec. East, along the
6 centerline of County Road 2184, with the Southerly line of the Hanka
7 Tract, a distance of 162.45 feet to a point marking the Northeast
8 corner of the herein described tract at the southeast corner of the
9 Hanka tract, in the East line of the aforementioned 590.04 acre
10 tract;

11 Thence South 03 deg. 33 min. 57 sec. East, along the East line
12 of said 590.04 acre tract, at 37.18 feet pass an axle found, and
13 continue along the West line of the Sean Hardy Nelson 26.341 acre
14 tract described in Clerk's File 2005004844, the Billy E. Fly 6.0
15 acre tract described in Clerk's File 2006014900, the Foster Jay
16 Nelson tract described in Clerk's File 2005013371, which line is
17 the West line of the Nelson 99.4 acre tract and the Nelson 100 acre

3 corner of said 2.6 acre tract;

4 Thence, N 88°59'50" E, along a southerly line of said 99.4
5 acre tract, a distance of 60.00 feet to an axle found for the
6 southwesterly corner of that certain called 23.6084 acres of land
7 described in deed recorded in the Official Public Records of Real
8 Property of Liberty County, Texas, under County Clerk's File Number
9 2006009319 and the northwesterly corner of that certain called
10 24.628 acres of land described in deed recorded in the Official
11 Public Records of Real Property of Liberty County, Texas, under
12 County Clerk's File Number 2016001692;

13 Thence, S 00°38'29" E, along the westerly line of said 24.628
14 acre tract, a distance of 1,400.66 feet to an axle found for the
15 southwesterly corner of said 24.628 acre tract and the
16 northwesterly corner of that certain called 8.8163 acres of land
17 described in deed recorded under Volume 1906, Page 167 of the Deed
18 Records of Liberty County, Texas;

19 Thence, S 00°43'07" E, along the westerly line of said 8.8163
20 acre tract, a distance of 236.36 feet to a 5/8 inch iron rod with cap
21 set for the southwesterly corner of said 8.8163 acre tract and the
22 northwesterly corner of said 10.0274 acre tract;

23 Thence, N 89°09'16" E, along the Southerly line of said 8.8163
24 acre tract, a distance of 1,777.39 feet to a 3/4 inch iron rod found
25 in a westerly line of that certain called 1090.0 acres of land
26 described in deed recorded under volume 1957, Page 554 of the Deed
27 Records of Liberty County, Texas, for the southeasterly corner of

1 said 8.8163 acre tract.

2 Thence, along a westerly line of said 1090.0 acre tract, the
3 following courses and distances:

13 Records of Real Property of Liberty County, Texas, under County
14 Clerk's File Number 2016012578 for the Southeasterly corner of said
15 10.0274 acre tract and a westerly corner of said 1090.0 acre tract;

16 Thence, N 89°35'31" W, along the northerly line of said 12
17 acre tract, a distance of 269.19 feet to a 3/4 inch iron rod found
18 for the Northwesterly corner of said 12 acre tract;

19 Thence, S 01°19'18" E, along the westerly line of said 12 acre
20 tract and the Westerly line of that certain called 12 acres of land
21 described in deed recorded under Volume 1268, Page 315 of the Deed
22 Records of Liberty County, Texas, at 676.67 feet pass a 3/4 inch
23 iron rod found for the Southwesterly corner of said 12 acre tract
24 recorded under Liberty County Clerk's File Number 2016012578 and
25 the Northwesterly corner of said 12 acre tract recorded under
26 Volume 1268, Page 315 of the Deed Records of Liberty County, in all

13 acre tract, a distance of 436.62 feet to a railroad tie found for
14 the Northwesterly corner of that certain called 65 acres of land

18 Thence, S 01°29'49" E, along the Westerly line of said 65 acre

22 feet to a 1-1/2 inch iron pipe found in Southerly line of that
23 certain 200' Gulf States Utilities Company Right-of-way Easement

27 Gulf States Utilities Company Right-of-way Easement, a distance of

1 4,818.85 feet to a 1/2 inch iron pipe found in the Easterly line of
2 said Oak Shadows Subdivision;

3 Thence, N 00°25'01" W, along the Easterly line of said Oak
4 Shadows Subdivision, a distance of 49.82 feet to the POINT OF

2 Sec. 7977A.0307. NO EMINENT DOMAIN POWER. The district may
3 not exercise the power of eminent domain.

4 (b) This section is not intended to be an expression of a
5 legislative interpretation of the requirements of Section 17(c),
6 Article I, Texas Constitution.

7 SECTION 5. This Act takes effect immediately if it receives
8 a vote of two-thirds of all the members elected to each house, as
9 provided by Section 39, Article III, Texas Constitution. If this
10 Act does not receive the vote necessary for immediate effect, this
11 Act takes effect September 1, 2023.
