WHEREAS, A caring and purposeful life came to an untimely end with the passing of Dr. Nancy Lefeber Hughes of Galveston on March 18, 2022, at the age of 67; and

WHEREAS, Born in Galveston on December 21, 1954, to Edward and Ellie Lefeber, the former Nancy Ellen Lefeber grew up with the companionship of five older siblings, Edward, John, Robert, Ann, and Donald; she graduated from Ball High School in 1973 and married her high school sweetheart, Michael B. WHEREAS, Dr. Hughes was the devoted mother of three children, Laura, Katherine, and Matthew, and she was further blessed with two grandsons, Davis and Connor; she enjoyed hosting family gatherings at the home in Galveston's East End that she purchased and restored with her husband, and in addition to spending time with her loved ones, she was fond of rollerblading, sailing at Sea Star Base Galveston, making arts and crafts, going to see the Houston Grand Opera, and traveling the world; she was a lifelong member of Trinity Episcopal Church, where she displayed her beautiful singing voice, and she also played the violin in the Galveston Symphony Orchestra for many years alongside her husband, a cellist; and
