H.B. No. 82

A BILL TO BE ENTITLED

AN ACT

relating to the use of average enrollment for purposes of the public school finance system.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 48.005, Education Code, is amended to read as follows:

Sec. 48.005. AVERAGE ENROLLMENT [~~DAILY ATTENDANCE~~]. (a) In this chapter, average enrollment [~~daily attendance~~] is:

(1) the average number of students enrolled in the school district during a school year [~~quotient of the sum of attendance for each day of the minimum number of days of instruction as described under Section 25.081(a) divided by the minimum number of days of instruction,~~

[~~(2) for a district that operates under a flexible year program under Section 29.0821, the quotient of the sum of attendance for each actual day of instruction as permitted by Section 29.0821(b)(1) divided by the number of actual days of instruction as permitted by Section 29.0821(b)(1),~~

[~~(3) for a district that operates under a flexible school day program under Section 29.0822, the average daily attendance as calculated by the commissioner in accordance with Sections 29.0822(d) and (d-1)]~~; or

(2) [~~(4)~~] for a district that operates a half-day program or a full-day program under Section 29.153(c), one-half of

1 the average enrollment [~~daily attendance~~] calculated under
2 Subdivision (1).

3 (b) A school district that experiences a decline of two
4 percent or more in average enrollment [~~daily attendance~~] shall be
5 funded on the basis of:

6 (1) the actual average enrollment [~~daily attendance~~]
7 of the preceding school year, if the decline is the result of the
8 closing or reduction in personnel of a military base; or

9 (2) subject to Subsection (e), an average enrollment
10 [~~daily attendance~~] not to exceed 98 percent of the actual average
11 enrollment [~~daily attendance~~] of the preceding school year, if the
12 decline is not the result of the closing or reduction in personnel
13 of a military base.

14 (c) The commissioner shall adjust the average enrollment
15 [~~daily attendance~~] of a school district that has a significant
16 percentage of students who are migratory children as defined by 20
17 U.S.C. Section 6399.

18 (d) The commissioner may adjust the average enrollment
19 [~~daily attendance~~] of a school district in which a disaster, flood,
20 extreme weather condition, fuel curtailment, or other calamity has
21 a significant effect on the district's enrollment [~~attendance~~]. In
22 addition to providing the adjustment for the amount of
23 instructional days during the semester in which the calamity first
24 occurred, an adjustment under this section may only be provided
25 based on a particular calamity for an additional amount of
26 instructional days equivalent to one school year. The commissioner
27 may divide the adjustment between two consecutive school years.

1 (e) For each school year, the commissioner shall adjust the
2 average enrollment [~~daily attendance~~] of school districts that are
3 entitled to funding on the basis of an adjusted average enrollment
4 [~~daily attendance~~] under Subsection (b)(2) so that:

5 (1) all districts are funded on the basis of the same
6 percentage of the preceding year's actual average enrollment [~~daily~~
7 ~~attendance~~]; and

8 (2) the total cost to the state does not exceed the
9 amount specifically appropriated for that year for purposes of
10 Subsection (b)(2).

11 (f) An open-enrollment charter school is not entitled to
12 funding based on an adjustment under Subsection (b)(2).

13 (g) If a student may receive course credit toward the
14 student's high school academic requirements and toward the
15 student's higher education academic requirements for a single
16 course, including a course provided under Section 28.009 by a
17 public institution of higher education, the time during which the
18 student attends the course shall be counted as part of the minimum
19 number of instructional hours required for a student to be
20 considered a full-time student in average enrollment [~~daily~~
21 ~~attendance~~] for purposes of this section.

22 [~~(g-1) The commissioner shall adopt rules to calculate~~
23 ~~average daily attendance for students participating in a blended~~
24 ~~learning program in which classroom instruction is supplemented~~
25 ~~with applied workforce learning opportunities, including~~
26 ~~participation of students in internships, externships, and~~
27 ~~apprenticeships.~~]

(h) Time [~~Subject to rules adopted by the commissioner under Section 48.007(b), time~~] that a student participates in an off-campus instructional program provided by an entity other than a school district or open-enrollment charter school and approved by the commissioner in accordance with commissioner rule [~~under Section 48.007(a)~~] shall be counted as part of the minimum number of instructional hours required for a student to be considered a full-time student in average enrollment [~~daily attendance~~] for purposes of this section.

(i) A district or a charter school operating under Chapter 12 that operates a prekindergarten program is eligible to receive one-half of average enrollment [~~daily attendance~~] under Subsection (a) if the district's or charter school's prekindergarten program provides at least 32,400 minutes of instructional time to students.

(j) A district or charter school is eligible to earn full average enrollment [~~daily attendance~~] under Subsection (a) if the district or school provides at least 43,200 minutes of instructional time to students enrolled in:

(1) a dropout recovery school or program operating under Section 12.1141(c) or Section 39.0548;

(2) an alternative education program operating under Section 37.008;

(3) a school program located at a day treatment facility, residential treatment facility, psychiatric hospital, or medical hospital;

(4) a school program offered at a correctional facility; or

(5) a school operating under Subchapter G, Chapter 12.

(k) A charter school operating under a charter granted under Chapter 12 before January 1, 2015, is eligible to earn full average enrollment [~~daily attendance~~] under Subsection (a), as that subsection existed immediately before January 1, 2015, for:

(1) all campuses of the charter school operating before January 1, 2015; and

(2) any campus or site expansion approved on or after January 1, 2015, provided that the charter school received an academic accountability performance rating of C or higher, and the campus or site expansion is approved by the commissioner.

(l) A school district campus or charter school described by Subsection (j) may operate more than one program and be eligible for full average enrollment [~~daily attendance~~] for each program if the programs operated by the district campus or charter school satisfy all applicable state and federal requirements.

(m) The commissioner shall adopt rules necessary to implement this section, including rules that:

(1) determine the method to calculate the average number of students enrolled in a school district during a school year;

(2) establish the minimum amount of instructional time per day that allows a school district or charter school to be eligible for full average enrollment [~~daily attendance~~], which may differ based on the instructional program offered by the district or charter school;

(3) [~~(2)~~] establish the requirements necessary for a

1 school district or charter school to be eligible for one-half of
2 average enrollment [~~daily attendance~~], which may differ based on
3 the instructional program offered by the district or charter
4 school;

5 (4) [~~(3)~~] proportionally reduce the average
6 enrollment [~~daily attendance~~] for a school district if any campus
7 or instructional program in the district provides fewer than the
8 required minimum minutes of instruction to students; and

9 (5) [~~(4)~~] allow a grade or course repeated under
10 Section 28.02124 to qualify for average enrollment [~~daily~~
11 ~~attendance~~] even if the student previously passed or earned credit
12 for the grade or course, if the grade or course would otherwise be
13 eligible.

14 (n) The rules adopted under Subsection (m)(1) must include a
15 requirement that the agency use a school district's total
16 enrollment on the last Friday of October and March for purposes of
17 estimating the district's average enrollment for that school year.

18 (o) To assist school districts in implementing this section
19 as amended by H.B. 2442, [~~Acts of the~~] 85th Legislature, Regular
20 Session, 2017, the commissioner may waive a requirement of this
21 section or adopt rules to implement this section.

22 SECTION 2. Section 7.062(a), Education Code, is amended to
23 read as follows:

24 (a) In this section, "wealth per student" means a school
25 district's taxable value of property as determined under Subchapter
26 M, Chapter 403, Government Code, or, if applicable, Section 48.258,
27 divided by the district's average enrollment [~~daily attendance~~] as

determined under Section 48.005.

SECTION 3. Section 11.052(f), Education Code, is amended to read as follows:

(f) If single-member trustee districts are adopted or approved as provided by this section, the board shall divide the school district into the appropriate number of trustee districts, based on the number of members of the board that are to be elected from single-member trustee districts, and shall number each trustee district. The trustee districts must be compact and contiguous and must be as nearly as practicable of equal population. In a district with 150,000 or more students in average enrollment [~~daily attendance~~], the boundary of a trustee district may not cross a county election precinct boundary except at a point at which the boundary of the school district crosses the county election precinct boundary. Trustee districts must be drawn not later than the 90th day before the date of the first election of trustees from those districts.

SECTION 4. Sections 12.106(a), (a-2), and (d), Education Code, are amended to read as follows:

(a) A charter holder is entitled to receive for the open-enrollment charter school funding under Chapter 48 equal to the amount of funding per student in weighted average enrollment [~~daily attendance~~], excluding the adjustment under Section 48.052, the funding under Sections 48.101, 48.110, 48.111, and 48.112, and enrichment funding under Section 48.202(a), to which the charter holder would be entitled for the school under Chapter 48 if the school were a school district without a tier one local share for

purposes of Section 48.266.

(a-2) In addition to the funding provided by Subsection (a), a charter holder is entitled to receive for the open-enrollment charter school an allotment per student in average enrollment [~~daily attendance~~] in an amount equal to the difference between:

(1) the product of:

(A) the quotient of:

(i) the total amount of funding provided to eligible school districts under Section 48.101(b) or (c); and

(ii) the total number of students in average enrollment [~~daily attendance~~] in school districts that receive an allotment under Section 48.101(b) or (c); and

(B) the sum of one and the quotient of:

(i) the total number of students in average enrollment [~~daily attendance~~] in school districts that receive an allotment under Section 48.101(b) or (c); and

(ii) the total number of students in average enrollment [~~daily attendance~~] in school districts statewide; and

(2) \$125.

(d) Subject to Subsection (e), in addition to other amounts provided by this section, a charter holder is entitled to receive, for the open-enrollment charter school, funding per student in average enrollment [~~daily attendance~~] in an amount equal to the guaranteed level of state and local funds per student per cent of tax effort under Section 46.032(a) multiplied by the lesser of:

(1) the state average interest and sinking fund tax

1 rate imposed by school districts for the current year; or

2 (2) a rate that would result in a total amount to which
3 charter schools are entitled under this subsection for the current
4 year equal to \$60 million.

5 SECTION 5. Sections 12.263(a), (b), and (c), Education
6 Code, are amended to read as follows:

7 (a) Except as otherwise provided by this section, funding
8 for an adult education program operated under a charter granted
9 under this subchapter is an amount per participant through the
10 Foundation School Program equal to the amount of state funding per
11 student in weighted average enrollment [~~daily attendance~~] that
12 would be allocated under the Foundation School Program for the
13 student's enrollment [~~attendance~~] at an open-enrollment charter
14 school in accordance with Section 12.106.

15 (b) For purposes of determining the average enrollment
16 [~~daily attendance~~] of an adult education program operated under a
17 charter granted under this subchapter, a student is considered to
18 be in average enrollment [~~daily attendance, with a 100 percent~~
19 ~~attendance rate,~~] for:

20 (1) all of the instructional days of the school year,
21 if the student is enrolled for at least 75 percent of the school
22 year;

23 (2) half of the instructional days of the school year,
24 if the student is enrolled for at least 50 percent but less than 75
25 percent of the school year;

26 (3) a quarter of the instructional days of the school
27 year, if the student is enrolled for at least 25 percent but less

1 than 50 percent of the school year; or

2 (4) one-tenth of the instructional days of the school
3 year, if the student is enrolled for at least 10 percent but less
4 than 25 percent of the school year.

5 (c) A student enrolled in an adult education program
6 operated under a charter granted under this subchapter for less
7 than 10 percent of a school year may not be counted toward the adult
8 education program's average enrollment [~~daily attendance~~] for that
9 school year.

10 SECTION 6. Section 13.051(c), Education Code, is amended to
11 read as follows:

12 (c) Territory that does not have residents may be detached
13 from a school district and annexed to another school district if:

14 (1) the total taxable value of the property in the
15 territory according to the most recent certified appraisal roll for
16 each school district is not greater than:

17 (A) five percent of the district's taxable value
18 of all property in that district as determined under Subchapter M,
19 Chapter 403, Government Code; and

20 (B) \$5,000 property value per student in average
21 enrollment [~~daily attendance~~] as determined under Section 48.005;
22 and

23 (2) the school district from which the property will
24 be detached does not own any real property located in the territory.

25 SECTION 7. Section 13.102, Education Code, is amended to
26 read as follows:

27 Sec. 13.102. MINIMUM AREA AND ENROLLMENT [~~ATTENDANCE~~]

1 REQUIREMENTS. A new district may not be created with an area of
2 less than nine square miles or fewer than 8,000 students in average
3 enrollment [~~daily attendance~~], and a district may not be reduced to
4 an area of less than nine square miles or fewer than 8,000 students
5 in average enrollment [~~daily attendance~~].

6 SECTION 8. Section 13.283, Education Code, is amended to
7 read as follows:

8 Sec. 13.283. PAYMENTS REDUCED. The incentive aid payments
9 shall be reduced in direct proportion to any reduction in the
10 average enrollment [~~daily attendance~~] as determined under Section
11 48.005 of the reorganized school district for the preceding year.

12 SECTION 9. Section 19.009(d-2), Education Code, is amended
13 to read as follows:

14 (d-2) Beginning with the 2009-2010 school year, the
15 district shall increase the monthly salary of each classroom
16 teacher, full-time speech pathologist, full-time librarian,
17 full-time school counselor certified under Subchapter B, Chapter
18 21, and full-time school nurse employed by the district by the
19 greater of:

20 (1) \$80; or

21 (2) the maximum uniform amount that, when combined
22 with any resulting increases in the amount of contributions made by
23 the district for social security coverage for the specified
24 employees or by the district on behalf of the specified employees
25 under Section 825.405, Government Code, may be provided using an
26 amount equal to the product of \$60 multiplied by the number of
27 students in weighted average enrollment [~~daily attendance~~] in the

1 district during the 2009-2010 school year.

2 SECTION 10. Section 25.038, Education Code, is amended to
3 read as follows:

4 Sec. 25.038. TUITION FEE FOR TRANSFER STUDENTS. The
5 receiving school district may charge a tuition fee to the extent
6 that the district's actual expenditure per student in average
7 enrollment [~~daily attendance~~], as determined by its board of
8 trustees, exceeds the sum the district benefits from state aid
9 sources as provided by Section 25.037. However, unless a tuition
10 fee is prescribed and set out in a transfer agreement before its
11 execution by the parties, an increase in tuition charge may not be
12 made for the year of that transfer that exceeds the tuition charge,
13 if any, of the preceding school year.

14 SECTION 11. Section 25.045(c), Education Code, is amended
15 to read as follows:

16 (c) A student who transfers to another school district under
17 this section may not be charged tuition. The student is included in
18 the average enrollment [~~daily attendance~~] of the district in which
19 the student attends school.

20 SECTION 12. Sections 25.081(e) and (f), Education Code, are
21 amended to read as follows:

22 (e) A school district or education program is exempt from
23 the minimum minutes of operation requirement if the district's or
24 program's average enrollment [~~daily attendance~~] is calculated
25 under Section 48.005(j).

26 (f) The commissioner may proportionally reduce the amount
27 of funding a district receives under Chapter 46, 48, or 49 and the

1 average enrollment [~~daily attendance~~] calculation for the district
2 if the district operates on a calendar that provides fewer minutes
3 of operation than required under Subsection (a).

4 SECTION 13. Section 25.087(d), Education Code, is amended
5 to read as follows:

6 (d) A student whose absence is excused under Subsection (b),
7 (b-1), (b-2), (b-4), (b-5), (b-7), (b-8), or (c) may not be
8 penalized for that absence and shall be counted as if the student
9 attended school for purposes of funding under Chapter 48
10 [~~calculating the average daily attendance of students in the school~~
11 ~~district~~]. A student whose absence is excused under Subsection
12 (b), (b-1), (b-2), (b-4), (b-5), (b-7), (b-8), or (c) shall be
13 allowed a reasonable time to make up school work missed on those
14 days. If the student satisfactorily completes the school work, the
15 day of absence shall be counted as a day of compulsory attendance.

16 SECTION 14. Section 25.111, Education Code, is amended to
17 read as follows:

18 Sec. 25.111. STUDENT/TEACHER RATIOS. Except as provided by
19 Section 25.112, each school district must employ a sufficient
20 number of teachers certified under Subchapter B, Chapter 21, to
21 maintain an average ratio of not less than one teacher for each 20
22 students in average enrollment [~~daily attendance~~].

23 SECTION 15. Sections 25.112(a) and (b), Education Code, are
24 amended to read as follows:

25 (a) Except as otherwise authorized by this section, a school
26 district may not enroll more than 22 students in a prekindergarten,
27 kindergarten, first, second, third, or fourth grade class. That

1 limitation does not apply during:

2 (1) any 12-week period of the school year selected by
3 the district, in the case of a district whose average enrollment
4 [~~daily attendance~~] is adjusted under Section 48.005(c); or

5 (2) the last 12 weeks of any school year in the case of
6 any other district.

7 (b) Not later than the 30th day after the first day of the
8 12-week period for which a district whose average enrollment [~~daily~~
9 ~~attendance~~] is adjusted under Section 48.005(c) is claiming an
10 exemption under Subsection (a), the district shall notify the
11 commissioner in writing that the district is claiming an exemption
12 for the period stated in the notice.

13 SECTION 16. Section 29.008(b), Education Code, is amended
14 to read as follows:

15 (b) Except as provided by Subsection (c), costs of an
16 approved contract for residential placement may be paid from a
17 combination of federal, state, and local funds. The local share of
18 the total contract cost for each student is that portion of the
19 local tax effort that exceeds the district's local fund assignment
20 under Section 48.256, divided by the average enrollment [~~daily~~
21 ~~attendance~~] in the district. If the contract involves a private
22 facility, the state share of the total contract cost is that amount
23 remaining after subtracting the local share. If the contract
24 involves a public facility, the state share is that amount
25 remaining after subtracting the local share from the portion of the
26 contract that involves the costs of instructional and related
27 services. For purposes of this subsection, "local tax effort"

means the total amount of money generated by taxes imposed for debt service and maintenance and operation less any amounts paid into a tax increment fund under Chapter 311, Tax Code.

SECTION 17. Section 29.014(b), Education Code, is amended to read as follows:

(b) A school district to which this section applies may operate an extended year program for a period not to exceed 45 days. ~~[The district's average daily attendance shall be computed for the regular school year plus the extended year.]~~

SECTION 18. Section 29.081(f), Education Code, is amended to read as follows:

(f) The commissioner shall include a student who successfully completes a course offered through a program under Subsection (e) in the computation of the district's or school's average enrollment ~~[daily attendance]~~ for funding purposes. ~~[For a student who successfully completes a remote course offered through the program, the commissioner shall include the student in the computation of the district's or school's average daily attendance with an attendance rate equal to:~~

~~[(1) the district's or school's average attendance rate for students successfully completing a course offered in person under the program; or~~

~~[(2) if the district or school does not offer courses in person under the program, the statewide average attendance rate for students successfully completing a course offered in person under a program under Subsection (e).]~~

SECTION 19. Section 29.0822(d), Education Code, is amended

to read as follows:

(d) The commissioner may adopt rules for the administration of this section, including rules establishing application requirements. ~~[Subject to Subsection (d-1), the commissioner shall calculate average daily attendance for students served under this section. The commissioner shall allow accumulations of hours of instruction for students whose schedule would not otherwise allow full state funding. Funding under this subsection shall be determined based on the number of instructional days in the school district calendar and a seven-hour school day, but attendance may be cumulated over a school year, including any summer or vacation session. The attendance of students who accumulate less than the number of attendance hours required under this subsection shall be proportionately reduced for funding purposes. The commissioner may:~~

~~[(1) set maximum funding amounts for an individual course under this section; and~~

~~[(2) limit funding for the attendance of a student described by Subsection (a)(3) in a course under this section to funding only for the attendance necessary for the student to earn class credit that, as a result of attendance requirements under Section 25.092, the student would not otherwise be able to receive without retaking the class.]~~

SECTION 20. Section 29.184(b), Education Code, is amended to read as follows:

(b) A student who attends career and technology classes at another school under a contract authorized by Subsection (a) is

1 included in the average enrollment [~~daily attendance~~] of the
2 district in which the student is regularly enrolled.

3 SECTION 21. Sections 29.203(a) and (c), Education Code, are
4 amended to read as follows:

5 (a) A student who under this subchapter uses a public
6 education grant to attend a public school in a school district other
7 than the district in which the student resides is included in the
8 average enrollment [~~daily attendance~~] of the district in which the
9 student attends school.

10 (c) A school district is entitled to additional facilities
11 assistance under Section 48.301 if the district agrees to:

12 (1) accept a number of students using public education
13 grants that is at least one percent of the district's average
14 enrollment [~~daily attendance~~] for the preceding school year; and

15 (2) provide services to each student until the student
16 either voluntarily decides to attend a school in a different
17 district or graduates from high school.

18 SECTION 22. Section 29.403(b), Education Code, is amended
19 to read as follows:

20 (b) A student who is enrolled in a program under this
21 subchapter is included in determining the average enrollment [~~daily~~
22 ~~attendance~~] under Section 48.005 of the partnering school district.

23 SECTION 23. Section 29.457(a), Education Code, is amended
24 to read as follows:

25 (a) In addition to other funding to which a school district
26 is entitled under this code, each district in which alleged
27 offender residents attend school is entitled to an annual allotment

1 of \$5,100 for each resident in average enrollment [~~daily~~
2 ~~attendance~~] or a different amount for any year provided by
3 appropriation.

4 SECTION 24. Section 29.912(c), Education Code, is amended
5 to read as follows:

6 (c) The program must enable an eligible school district that
7 has fewer than 1,600 students in average enrollment [~~daily~~
8 ~~attendance~~] to partner with at least one other school district
9 located within a distance of 100 miles to offer a broader array of
10 robust college and career pathways. Each partnership must:

11 (1) offer college and career pathways that align with
12 regional labor market projections for high-wage, high-demand
13 careers; and

14 (2) be managed by a coordinating entity that:

15 (A) has or will have at the time students are
16 served under the partnership the capacity to effectively coordinate
17 the partnership;

18 (B) has entered into a performance agreement
19 approved by the board of trustees of each partnering school
20 district that confers on the coordinating entity the same authority
21 with respect to pathways offered under the partnership provided to
22 an entity that contracts to operate a district campus under Section
23 11.174;

24 (C) is an eligible entity as defined by Section
25 12.101(a); and

26 (D) has on the entity's governing board as either
27 voting or ex officio members, or has on an advisory body,

representatives of each partnering school district and members of regional higher education and workforce organizations.

SECTION 25. Section 30.003(b), Education Code, is amended to read as follows:

(b) If the student is admitted to the school for a full-time program for the equivalent of two long semesters, the district's share of the cost is an amount equal to the dollar amount of maintenance and debt service taxes imposed by the district for that year divided by the district's average enrollment ~~[daily attendance]~~ for the preceding year.

SECTION 26. Section 30.102(a), Education Code, is amended to read as follows:

(a) The Texas Juvenile Justice Department is entitled to receive the state available school fund apportionment based on the average enrollment ~~[daily attendance]~~ in the department's educational programs of students who are at least three years of age and not older than 21 years of age.

SECTION 27. Section 30A.151(f), Education Code, is amended to read as follows:

(f) For a full-time electronic course program offered through the state virtual school network for a grade level at or above grade level three but not above grade level eight, a school district or open-enrollment charter school is entitled to receive federal, state, and local funding for a student enrolled in the program in an amount equal to the funding the district or school would otherwise receive for a student enrolled in the district or school. ~~[The district or school may calculate the average daily~~

~~attendance of a student enrolled in the program based on:~~

~~[(1) hours of contact with the student,~~

~~[(2) the student's successful completion of a course,~~

~~or~~

~~[(3) a method approved by the commissioner.]~~

SECTION 28. Section 33.157, Education Code, is amended to read as follows:

Sec. 33.157. PARTICIPATION IN PROGRAM. An elementary or secondary school receiving funding under Section 33.156 shall participate in a local Communities In Schools program if the number of students enrolled in the school who are at risk of dropping out of school is equal to at least 10 percent of the number of students in average enrollment ~~[daily attendance]~~ at the school, as determined by the agency.

SECTION 29. Section 37.0061, Education Code, is amended to read as follows:

Sec. 37.0061. FUNDING FOR ALTERNATIVE EDUCATION SERVICES IN JUVENILE RESIDENTIAL FACILITIES. A school district that provides education services to pre-adjudicated and post-adjudicated students who are confined by court order in a juvenile residential facility operated by a juvenile board is entitled to count such students in the district's average enrollment ~~[daily attendance]~~ for purposes of receipt of state funds under the Foundation School Program. If the district has a local revenue level greater than the guaranteed local revenue level but less than the level established under Section 48.257, the district in which the student is enrolled on the date a court orders the student to be confined to a juvenile

1 residential facility shall transfer to the district providing
2 education services an amount equal to the difference between the
3 average Foundation School Program costs per student of the district
4 providing education services and the sum of the state aid and the

20 the student in the district's average enrollment ~~[daily attendance]~~

23 (1) the district's disciplinary alternative education
24 program; or

25 (2) a contracted placement with:

26 (A) another school district;

27 (B) an open-enrollment charter school;

(C) an institution of higher education;

(D) an adult literacy council; or

(E) a community organization that can provide an educational program that allows the student to complete the credits required for high school graduation.

SECTION 32. Sections 39.027(c) and (f), Education Code, are amended to read as follows:

(c) The commissioner shall develop and adopt a process for reviewing the exemption process of a school district or shared services arrangement that gives an exemption under Subsection (a)(1) as follows:

(1) to more than five percent of the students in the special education program, in the case of a district or shared services arrangement with an average enrollment ~~[daily attendance]~~ of at least 1,600;

(2) to more than 10 percent of the students in the special education program, in the case of a district or shared services arrangement with an average enrollment ~~[daily attendance]~~ of at least 190 and not more than 1,599; or

(3) to the greater of more than 10 percent of the students in the special education program or to at least five students in the special education program, in the case of a district or shared services arrangement with an average enrollment ~~[daily attendance]~~ of not more than 189.

(f) In this section, "average enrollment ~~[daily attendance]~~" is computed in the manner provided by Section 48.005.

SECTION 33. Section 39.053(g-1), Education Code, is amended

to read as follows:

(g-1) In computing dropout and completion rates such as high school graduation rates under Subsection (c)(1)(B)(ix), the commissioner shall exclude:

(1) students who are ordered by a court to attend a high school equivalency certificate program but who have not yet earned a high school equivalency certificate;

(2) students who were previously reported to the state as dropouts, including a student who is reported as a dropout, reenrolls, and drops out again, regardless of the number of times of reenrollment and dropping out;

(3) students in attendance who are not in membership for purposes of average enrollment [~~daily attendance~~];

(4) students whose initial enrollment in a school in the United States in grades 7 through 12 was as an unschooled asylee or refugee as defined by Section 39.027(a-1);

(5) students who are detained at a county pre-adjudication or post-adjudication juvenile detention facility and:

(A) in the district exclusively as a function of having been detained at the facility but are otherwise not students of the district in which the facility is located; or

(B) provided services by an open-enrollment charter school exclusively as the result of having been detained at the facility;

(6) students who are incarcerated in state jails and federal penitentiaries as adults and as persons certified to stand

trial as adults; and

(7) students who have suffered a condition, injury, or illness that requires substantial medical care and leaves the student:

(A) unable to attend school; and

(B) assigned to a medical or residential treatment facility.

SECTION 34. Section 39.262(a), Education Code, is amended to read as follows:

(a) The governor may present a financial award to the schools or districts that the commissioner determines have demonstrated the highest levels of sustained success or the greatest improvement in achieving the education goals. For each student in average enrollment [~~daily attendance~~], each of those schools or districts is entitled to an amount set for the award for which the school or district is selected by the commissioner, subject to any limitation set by the commissioner on the total amount that may be awarded to a school or district.

SECTION 35. Section 43.001(c), Education Code, is amended to read as follows:

(c) The term "scholastic population" in Subsection (b) or any other law governing the apportionment, distribution, and transfer of the available school fund means all students of school age [~~enrolled~~] in average enrollment [~~daily attendance~~] the preceding school year in the public elementary and high school grades of school districts within or under the jurisdiction of a county of this state.

SECTION 36. Section 44.004(c), Education Code, is amended to read as follows:

(c) The notice of public meeting to discuss and adopt the budget and the proposed tax rate may not be smaller than one-quarter page of a standard-size or a tabloid-size newspaper, and the headline on the notice must be in 18-point or larger type. Subject to Subsection (d), the notice must:

(1) contain a statement in the following form:

"NOTICE OF PUBLIC MEETING TO DISCUSS BUDGET AND PROPOSED TAX RATE

"The (name of school district) will hold a public meeting at (time, date, year) in (name of room, building, physical location, city, state). The purpose of this meeting is to discuss the school district's budget that will determine the tax rate that will be adopted. Public participation in the discussion is invited." The statement of the purpose of the meeting must be in bold type. In reduced type, the notice must state: "The tax rate that is ultimately adopted at this meeting or at a separate meeting at a later date may not exceed the proposed rate shown below unless the district publishes a revised notice containing the same information and comparisons set out below and holds another public meeting to discuss the revised notice." In addition, in reduced type, the notice must state: "Visit Texas.gov/PropertyTaxes to find a link to your local property tax database on which you can easily access information regarding your property taxes, including information about proposed tax rates and scheduled public hearings of each entity that taxes your property.";

(2) contain a section entitled "Comparison of Proposed

Budget with Last Year's Budget," which must show the difference, expressed as a percent increase or decrease, as applicable, in the amounts budgeted for the preceding fiscal year and the amount budgeted for the fiscal year that begins in the current tax year for each of the following:

(A) maintenance and operations;

(B) debt service; and

(C) total expenditures;

(3) contain a section entitled "Total Appraised Value and Total Taxable Value," which must show the total appraised value and the total taxable value of all property and the total appraised value and the total taxable value of new property taxable by the district in the preceding tax year and the current tax year as calculated under Section 26.04, Tax Code;

(4) contain a statement of the total amount of the outstanding and unpaid bonded indebtedness of the school district;

(5) contain a section entitled "Comparison of Proposed Rates with Last Year's Rates," which must:

(A) show in rows the tax rates described by Subparagraphs (i)-(iii), expressed as amounts per \$100 valuation of property, for columns entitled "Maintenance & Operations," "Interest & Sinking Fund," and "Total," which is the sum of "Maintenance & Operations" and "Interest & Sinking Fund":

(i) the school district's "Last Year's Rate";

(ii) the "Rate to Maintain Same Level of Maintenance & Operations Revenue & Pay Debt Service," which:

1 (a) in the case of "Maintenance &
2 Operations," is the tax rate that, when applied to the current
3 taxable value for the district, as certified by the chief appraiser
4 under Section 26.01, Tax Code, and as adjusted to reflect changes
5 made by the chief appraiser as of the time the notice is prepared,
6 would impose taxes in an amount that, when added to state funds to
7 be distributed to the district under Chapter 48, would provide the
8 same amount of maintenance and operations taxes and state funds
9 distributed under Chapter 48 per student in average enrollment
10 [~~daily attendance~~] for the applicable school year that was
11 available to the district in the preceding school year; and

12 (b) in the case of "Interest & Sinking
13 Fund," is the tax rate that, when applied to the current taxable
14 value for the district, as certified by the chief appraiser under
15 Section 26.01, Tax Code, and as adjusted to reflect changes made by
16 the chief appraiser as of the time the notice is prepared, and when
17 multiplied by the district's anticipated collection rate, would
18 impose taxes in an amount that, when added to state funds to be
19 distributed to the district under Chapter 46 and any excess taxes
20 collected to service the district's debt during the preceding tax
21 year but not used for that purpose during that year, would provide
22 the amount required to service the district's debt; and

23 (iii) the "Proposed Rate";

24 (B) contain fourth and fifth columns aligned with
25 the columns required by Paragraph (A) that show, for each row
26 required by Paragraph (A):

27 (i) the "Local Revenue per Student," which

1 is computed by multiplying the district's total taxable value of
2 property, as certified by the chief appraiser for the applicable
3 school year under Section 26.01, Tax Code, and as adjusted to
4 reflect changes made by the chief appraiser as of the time the
5 notice is prepared, by the total tax rate, and dividing the product
6 by the number of students in average enrollment [~~daily attendance~~]
7 in the district for the applicable school year; and

8 (ii) the "State Revenue per Student," which
9 is computed by determining the amount of state aid received or to be
10 received by the district under Chapters 43, 46, and 48 and dividing
11 that amount by the number of students in average enrollment [~~daily~~
12 ~~attendance~~] in the district for the applicable school year; and

13 (C) contain an asterisk after each calculation
14 for "Interest & Sinking Fund" and a footnote to the section that, in
15 reduced type, states "The Interest & Sinking Fund tax revenue is
16 used to pay for bonded indebtedness on construction, equipment, or
17 both. The bonds, and the tax rate necessary to pay those bonds,
18 were approved by the voters of this district.";

19 (6) contain a section entitled "Comparison of Proposed
20 Levy with Last Year's Levy on Average Residence," which must:

21 (A) show in rows the information described by
22 Subparagraphs (i)-(iv), rounded to the nearest dollar, for columns
23 entitled "Last Year" and "This Year":

24 (i) "Average Market Value of Residences,"
25 determined using the same group of residences for each year;

26 (ii) "Average Taxable Value of Residences,"
27 determined after taking into account the limitation on the

1 appraised value of residences under Section 23.23, Tax Code, and
2 after subtracting all homestead exemptions applicable in each year,
3 other than exemptions available only to disabled persons or persons
4 65 years of age or older or their surviving spouses, and using the
5 same group of residences for each year;

6 (iii) "Last Year's Rate Versus Proposed
7 Rate per \$100 Value"; and

8 (iv) "Taxes Due on Average Residence,"
9 determined using the same group of residences for each year; and

10 (B) contain the following information: "Increase
11 (Decrease) in Taxes" expressed in dollars and cents, which is
12 computed by subtracting the "Taxes Due on Average Residence" for
13 the preceding tax year from the "Taxes Due on Average Residence" for
14 the current tax year;

15 (7) contain the following statement in bold print:
16 "Under state law, the dollar amount of school taxes imposed on the
17 residence of a person 65 years of age or older or of the surviving
18 spouse of such a person, if the surviving spouse was 55 years of age
19 or older when the person died, may not be increased above the amount
20 paid in the first year after the person turned 65, regardless of
21 changes in tax rate or property value.";

22 (8) contain the following statement in bold print:
23 "Notice of Voter-Approval Rate: The highest tax rate the district
24 can adopt before requiring voter approval at an election is (the
25 school district voter-approval rate determined under Section
26 26.08, Tax Code). This election will be automatically held if the
27 district adopts a rate in excess of the voter-approval rate of (the

1 school district voter-approval rate)."; and

2 (9) contain a section entitled "Fund Balances," which
3 must include the estimated amount of interest and sinking fund
4 balances and the estimated amount of maintenance and operation or
5 general fund balances remaining at the end of the current fiscal
6 year that are not encumbered with or by corresponding debt
7 obligation, less estimated funds necessary for the operation of the
8 district before the receipt of the first payment under Chapter 48 in
9 the succeeding school year.

10 SECTION 37. Sections 45.0011(a), (d), and (e), Education
11 Code, are amended to read as follows:

12 (a) This section applies only to an independent school
13 district that, at the time of the issuance of obligations and
14 execution of credit agreements under this section, has:

15 (1) at least 2,000 students in average enrollment

SECTION 38. Section 45.006(a), Education Code, is amended to read as follows:

(a) This section applies only to a school district that:

(1) has an average enrollment [~~daily attendance~~] of less than 10,000; and

(2) is located in whole or part in a municipality with a population of less than 25,000 that is located in a county with a population of 200,000 or more bordering another county with a population of 2.8 million or more.

SECTION 39. Section 45.105(d), Education Code, is amended to read as follows:

(d) An independent school district that has in its limits a municipality with a population of 150,000 or more or that contains at least 170 square miles, has \$850 million or more assessed value of taxable property on the most recent approved tax roll and has a growth in average enrollment [~~daily attendance~~] of 11 percent or more for each of the preceding five years as determined by the agency may, in buying school sites or additions to school sites and in building school buildings, issue and deliver negotiable or nonnegotiable notes representing all or part of the cost to the

9 which is determined by dividing the amount budgeted by the district
10 for payment of eligible bonds by the quotient of the district's
11 taxable value of property as determined under Subchapter M, Chapter
12 403, Government Code, or, if applicable, Section 48.258, divided by
13 100; and

14 "DPV" is the district's taxable value of property as
15 determined under Subchapter M, Chapter 403, Government Code, or, if
16 applicable, Section 48.258.

17 SECTION 41. Section 46.005, Education Code, is amended to
18 read as follows:

19 Sec. 46.005. LIMITATION ON GUARANTEED AMOUNT. The
20 guaranteed amount of state and local funds for a new project that a

22 46.003 for a school district may not exceed the lesser of:

SECTION 43. Section 46.032(a), Education Code, is amended to read as follows:

"EDTR" is the existing debt tax rate of the district, which is determined by dividing the amount budgeted by the district for payment of eligible bonds by the quotient of the district's taxable value of property as determined under Subchapter M, Chapter 403, Government Code, or, if applicable, under Section 48.258, divided by 100; and

"DPV" is the district's taxable value of property as determined under Subchapter M, Chapter 403, Government Code, or, if applicable, under Section 48.258.

SECTION 44. Sections 48.0051(a) and (b), Education Code, are amended to read as follows:

(a) The [~~Subject to Subsection (a-1), the~~] commissioner shall adjust the average enrollment [~~daily attendance~~] of a school district or open-enrollment charter school under Section 48.005 in the manner provided by Subsection (b) if the district or school:

(1) provides the minimum number of minutes of operational and instructional time required under Section 25.081 and commissioner rules adopted under that section over at least 180 days of instruction; and

(2) offers an additional 30 days of half-day instruction for students enrolled in prekindergarten through fifth

 14 average enrollment [~~daily attendance~~] of a school district all or

(f) For purposes of this title, a district's adjusted average enrollment [~~daily attendance~~] under this section is considered to be the district's average enrollment [~~daily attendance~~] as determined under Section 48.005.

SECTION 46. Sections 48.010(a) and (b), Education Code, are amended to read as follows:

(a) Not later than July 1 of each year, the commissioner shall determine for each school district whether the estimated amount of state and local funding per student in weighted average enrollment [~~daily attendance~~] to be provided to the district under the Foundation School Program for maintenance and operations for the following school year is less than the amount provided to the district for the 2010-2011 school year. If the amount estimated to be provided is less, the commissioner shall certify the percentage decrease in funding to be provided to the district.

(b) In making the determinations regarding funding levels required by Subsection (a), the commissioner shall:

(1) make adjustments as necessary to reflect changes in a school district's maintenance and operations tax rate;

(2) for a district required to reduce its local revenue level under Section 48.257, base the determinations on the

(a) For each student in average enrollment [~~daily attendance~~], not including the time students spend each day in special education programs in an instructional arrangement other than mainstream or career and technology education programs, for which an additional allotment is made under Subchapter C, a district is entitled to an allotment equal to the lesser of \$6,160 or the amount that results from the following formula:

(1) 75 percent must be used to increase the compensation paid to classroom teachers, full-time librarians, full-time school counselors certified under Subchapter B, Chapter 21, and full-time school nurses, prioritizing differentiated compensation for classroom teachers with more than five years of experience; and

(2) 25 percent may be used as determined by the district to increase compensation paid to full-time district employees.

SECTION 48. Sections 48.052(a) and (c), Education Code, are amended to read as follows:

16 route from the nearest high school district.

17 SECTION 49. Section 48.101, Education Code, is amended to
18 read as follows:

19 Sec. 48.101. SMALL AND MID-SIZED DISTRICT ALLOTMENT. (a)
20 Small and mid-sized districts are entitled to an annual allotment
21 in accordance with this section. In this section:

22 (1) "AA" is the district's annual allotment per
23 student in average enrollment [~~daily attendance~~];

24 (2) "AE" [~~"ADA"~~] is the number of students in average
25 enrollment [~~daily attendance~~] for which the district is entitled to

12 \$100 million secured by and payable from the county's ad valorem
13 taxes and the authorized long-term indebtedness of which is rated
14 by a nationally recognized rating agency of securities issued by
15 local governments in one of the four highest rating categories for a
16 long-term obligation;

17 (L) an independent school district that has an
18 average enrollment [~~daily attendance~~] of 50,000 or more as
19 determined under Section 48.005, Education Code;

20 (M) a municipality or county operating under
21 Chapter 334, Local Government Code;

22 (N) a district created under Chapter 335, Local
23 Government Code;

24 (O) a junior college district that has a total
25 headcount enrollment of 40,000 or more based on enrollment in the
26 most recent regular semester; or

27 (P) an issuer, as defined by Section 1201.002,

that has:

(i) a principal amount of at least \$100 million in outstanding long-term indebtedness, in long-term indebtedness proposed to be issued, or in a combination of outstanding or proposed long-term indebtedness; and

(ii) some amount of long-term indebtedness outstanding or proposed to be issued that is rated in one of the four highest rating categories for long-term debt instruments by a nationally recognized rating agency for municipal securities, without regard to the effect of any credit agreement or other form of credit enhancement entered into in connection with the obligation.

SECTION 85. Section 1431.001(3), Government Code, is amended to read as follows:

(3) "Eligible school district" means an independent school district that has an average enrollment ~~[daily attendance]~~ of 190,000 or more as determined under Section 48.005, Education Code.

SECTION 86. Section 325.011(a), Local Government Code, is amended to read as follows:

(a) The district is governed by a board of directors composed of five members, with two directors appointed by the commissioners court of the county, two directors appointed by the governing body of the municipality having the largest population in the county, and one director appointed by the governing body of the school district with the largest number of students in average enrollment ~~[daily attendance]~~ in the county. The board shall

1 manage the district and administer this chapter.

2 SECTION 87. Section 1, Article 2688d, Vernon's Texas Civil
3 Statutes, is amended to read as follows:

4 Section 1. In all counties of the State where, according to
5 the preceding annual statistical report of the schools said county
6 has not more than four (4) school districts, with one (1) of such
7 districts comprising more than half of the county and having more
8 than two thousand (2,000) pupils in average enrollment [~~daily~~
9 ~~attendance~~] in the one (1) district alone, and such district having
10 an assessed valuation of more than Twenty Million Dollars
11 (\$20,000,000) and where there is only one (1) common school
12 district in such county with an average enrollment [~~daily~~
