5	SECTION 1. Article 49.10, Code of Criminal Procedure, is
6	amended by adding Subsection (e-1) to read as follows:
7	(e-1) This subsection expires April 1, 2027.
8	Notwithstanding Subsections (c) and (e) and Subchapter F, Chapter
9	264, Family Code, for each body that is the subject of an inquest by
10	a justice of the peace, the justice may certify that an autopsy is
11	<pre>not necessary if:</pre>
12	(1) the justice determines by clear and convincing
13	<pre>evidence that:</pre>
14	(A) the cause of death was the result of injuries
15	sustained as a result of a natural disaster; and
16	(B) the death was not caused by an unlawful act or
17	omission; and
18	(2) a person described by Article 49.33(a) is not
19	otherwise seeking an autopsy, regardless of the person's listed
20	priority for purposes of that subsection.
21	SECTION 2. Article 49A.063, Code of Criminal Procedure, as
22	added by H.B. 1610, Acts of the 89th Legislature, Regular Session,
23	2025, and effective April 1, 2027, is amended by adding Subsection
24	(c-1) to read as follows:

(c-1) Notwithstanding Subsections (b) and (c) and 1 Subchapter F, Chapter 264, Family Code, for each body that is the 2 subject of an inquest by a justice of the peace, the justice may 3 4 certify that an autopsy is not necessary if: 5 (1) the justice determines by clear and convincing 6 evidence that: (A) the cause of death was the result of injuries 7 sustained as a result of a natural disaster; and 8 9 (B) the death was not caused by an unlawful act or omission; and 10 11 (2) a person described by Article 49A.203(a) is not otherwise seeking an autopsy, regardless of the person's listed 12 13 priority for purposes of that subsection. SECTION 3. Subchapter A, Chapter 27, Government Code, is 14 15 amended by adding Section 27.0055 to read as follows: 16 Sec. 27.0055. EDUCATIONAL REQUIREMENTS FOR CERTAIN JUSTICES OF THE PEACE. (a) This section applies only to a justice 17 of the peace of a county not served by a medical examiner. 18 (b) The Department of State Health Services, 19 20 collaboration with the Texas Division of Emergency Management, shall develop a training program for justices of the peace on 21 managing mass fatality events. The training program must include: 22 (1) decision-making protocols for ordering an 23

- 12 SECTION 4. Section 411.1236, Government Code, is amended to

- 15 INFORMATION: TEXAS COMMISSION ON FIRE PROTECTION. (a) The Texas
- 16 Commission on Fire Protection is entitled to obtain as provided by
- 17 <u>Subsection (a-1)</u> [<u>from the department</u>] criminal history record
- 18 information [maintained by the department] that relates to a person
- 19 who is:
- 20 (1) an applicant for or holder of a license issued
- 21 under <u>Subchapter M, Chapter 418, or</u> Chapter 419; or
- 22 (2) an applicant for employment by or an employee of
- 23 the commission.
- 24 <u>(a-1) Subject to Sections 411.087 and 418.459 and</u>
- 25 consistent with the public policy of this state, the Texas
- 26 Commission on Fire Protection is entitled to:
- 27 (1) obtain through the Federal Bureau of Investigation

- 1 criminal history record information maintained or indexed by that
- 2 bureau that pertains to an applicant for or holder of a license
- 3 issued under Subchapter M, Chapter 418; and
- 4 (2) obtain from the department or any other criminal
- 5 justice agency in this state criminal history record information
- 6 maintained by the department or that criminal justice agency that
- 7 relates to a person described by Subsection (a).
- 8 (b) The Texas Commission on Fire Protection may not release
- 9 or disclose to any person criminal history record information
- 10 obtained from the Federal Bureau of Investigation under Subsection
- 11 (a-1)(1). Criminal history record information obtained by the
- 12 Texas Commission on Fire Protection under Subsection (a-1)(2) [(a)]
- 13 may not be released to any person or agency except on court order or
- 14 with the consent of the person who is the subject of the criminal
- 15 history record information, or as provided by Subsection (c).
- 16 (c) The Texas Commission on Fire Protection is not
- 17 prohibited from disclosing criminal history record information
- 18 obtained under Subsection (a-1)(2) in a criminal proceeding or in a
- 19 hearing conducted by the commission or by the State Office of
- 20 Administrative Hearings on behalf of the commission [if the
- 21 information is entered into evidence by the board in an
- 22 administrative, civil, or criminal hearing under Chapter 419].
- 23 (d) The Texas Commission on Fire Protection shall destroy
- 24 criminal history record information that is obtained under this
- 25 section after the information is used for its authorized purpose.
- SECTION 5. Subchapter F, Chapter 411, Government Code, is
- 27 amended by adding Section 411.14104 to read as follows:

- 1 Sec. 411.14104. ACCESS TO CRIMINAL HISTORY RECORD
- 2 INFORMATION: TEXAS DIVISION OF EMERGENCY MANAGEMENT. (a) The
- 3 Texas Division of Emergency Management is entitled to obtain
- 4 criminal history record information as provided by Subsection (b)
- 5 that relates to a person who registers as a volunteer for
- 6 governmental disaster response or recovery operations under
- 7 Subchapter N, Chapter 418.
- 8 (b) Subject to Sections 411.087 and 418.485 and consistent
- 9 with the public policy of this state, the Texas Division of
- 10 Emergency Management is entitled to obtain from the department or
- 11 any other criminal justice agency in this state criminal history
- 12 record information maintained by the department or that criminal
- 13 justice agency that relates to a person described by Subsection
- 14 (a).
- 15 (c) Criminal history record information obtained by the
- 16 Texas Division of Emergency Management under Subsection (b) may not
- 17 <u>be released or disclosed to any person except on court order or as</u>
- 18 provided by Subsection (d).
- 19 (d) The Texas Division of Emergency Management is not
- 20 prohibited from disclosing criminal history record information
- 21 obtained under Subsection (b) in a criminal proceeding.
- (e) The Texas Division of Emergency Management shall
- 23 destroy criminal history record information that is obtained under
- 24 this section after the information is used for its authorized
- 25 purpose.
- SECTION 6. Sections 418.005(a) and (b), Government Code,
- 27 are amended to read as follows:

- 1 (a) This section applies only to:
- 2 (1) an elected law enforcement officer [or county
- 3 judger] or an appointed public officer of the state or of a
- 4 political subdivision, who has management or supervisory
- 5 responsibilities and:
- 6 (A) whose position description, job duties, or
- 7 assignment includes emergency management responsibilities; or
- 8 (B) who plays a role in emergency preparedness,
- 9 response, or recovery; [and]
- 10 (2) an emergency management coordinator designated
- 11 under Section 418.1015(c);
- 12 (3) a county judge;
- 13 (4) a sheriff; and
- 14 (5) a mayor of a municipality that is not covered by a
- 15 county's hazard mitigation plan [by the emergency management
- 16 director of a county with a population of 500,000 or more].
- 17 (b) Each person described by Subsection (a) shall complete a
- 18 course of training provided or approved by the division of not less
- 19 than 16 [three] hours regarding the responsibilities of state and
- 20 local governments under this chapter every two years. The initial
- 21 course of training must be completed not later than the 180th day
- 22 after the date the person:
- 23 (1) takes the oath of office, if the person is required
- 24 to take an oath of office to assume the person's duties as a public
- 25 officer;
- 26 (2) otherwise assumes responsibilities as a public
- 27 officer, if the person is not required to take an oath of office to

- 1 assume the person's duties; or
- 2 (3) is designated as an emergency management
- 3 coordinator under Section 418.1015(c).
- 4 SECTION 7. Section 418.1015, Government Code, is amended by
- 5 adding Subsections (e), (f), and (g) to read as follows:
- 6 (e) If a disaster is imminent or occurring or has recently
- 7 occurred and the presiding officer of the governing body of a county
- 8 is not able to act as emergency management director for the county
- 9 because the presiding officer is absent from the county,
- 10 incapacitated, deceased, or otherwise unavailable, the following
- 11 persons in the following order of priority, as available, are
- 12 designated as the emergency management director for the county for
- 13 purposes of the disaster until the presiding officer becomes
- 14 available:
- 15 (1) the sheriff; or
- 16 (2) the county commissioner with the longest period of
- 17 <u>continuous service on the commissioners court.</u>
- 18 (f) If a disaster is imminent or occurring or has recently
- 19 occurred and the presiding officer of the governing body of an
- 20 incorporated city is not able to act as emergency management
- 21 director for the city because the presiding officer is absent from
- 22 the city, incapacitated, deceased, or otherwise unavailable, the
- 23 following persons in the following order of priority, as available,
- 24 are designated as the emergency management director for the city
- 25 for purposes of the disaster until the presiding officer becomes
- 26 available:
- 27 (1) the mayor pro tempore of the city;

- 1 (2) if an elected position, the marshal of the city; or
- 2 (3) the member of the governing body of the city with
- 3 the longest period of continuous service on the governing body.
- 4 (g) Each county and incorporated city by order, ordinance,
- 5 or other measure shall adopt procedures to implement Subsection (e)
- 6 or (f), as applicable.
- 7 SECTION 8. Section 418.106, Government Code, is amended by
- 8 adding Subsections (b-1), (f), and (g) to read as follows:
- 9 (b-1) In a county with a population of 68,750 or less, a
- 10 <u>local or interjurisdictional emergency management agency's</u>
- 11 emergency management plan must include procedures to establish a
- 12 unified incident command structure for the county and any
- 13 municipality located in the county.
- (f) Except as provided by Subsection (g), each local or
- 15 interjurisdictional emergency management agency shall annually
- 16 conduct a drill on the agency's emergency management plan. The
- 17 <u>division shall supervise all emergency management plan drills.</u>
- 18 (g) If a political subdivision served by a local or
- 19 <u>interjurisdictional emergency management agency is included in a</u>
- 20 disaster declaration issued by the governor under Section 418.014
- 21 or by the president of the United States, the local or
- 22 interjurisdictional emergency management agency is not required to
- 23 conduct a drill on the agency's emergency management plan for one
- 24 year from the date the declaration is initially issued.
- 25 SECTION 9. Subchapter E, Chapter 418, Government Code, is
- 26 amended by adding Section 418.1103 to read as follows:
- Sec. 418.1103. POST-DISASTER AFTER-ACTION REPORT. (a) A

- 1 local or interjurisdictional emergency management agency for an
- 2 area that is wholly or partly the subject of a disaster declaration
- 3 by the governor under this chapter or by the president of the United
- 4 States shall:
- 5 (1) complete a post-disaster after-action report on a
- 6 form prescribed by the division not later than the 60th day after
- 7 the date a disaster declaration expires or is terminated; and
- 8 (2) submit the report to the division.
- 9 (b) The division shall adopt the post-disaster after-action
- 10 report form required to be completed and submitted under this
- 11 <u>section</u>.
- 12 SECTION 10. Chapter 418, Government Code, is amended by
- 13 adding Subchapters M and N to read as follows:
- 14 SUBCHAPTER M. EMERGENCY MANAGER LICENSES
- Sec. 418.451. DEFINITIONS. In this subchapter:
- 16 (1) "Commission" means the Texas Commission on Fire
- 17 Protection.
- 18 (2) "Emergency manager" means a person who holds an
- 19 emergency manager license under this subchapter.
- 20 "Emergency manager license" means a license issued
- 21 under this subchapter and includes a bridge, basic, intermediate,
- 22 <u>advanced</u>, or master license.
- Sec. 418.452. ADMINISTRATOR; RULES; FEES. (a) The
- 24 commission shall administer and enforce this subchapter.
- 25 (b) The commission may adopt rules to implement this
- 26 subchapter. The division shall adopt rules regarding the minimum
- 27 requirements for each type of license and the minimum requirements

- 1 for the continuing education necessary to renew an emergency
- 2 manager license in order to implement this subchapter.
- 3 (c) The commission may adopt fees reasonable and necessary
- 4 to cover the costs of administering this subchapter.
- 5 Sec. 418.453. DATABASE OF LICENSE HOLDERS. (a) The
- 6 commission, in coordination with the division, shall establish and
- 7 maintain records of each person who holds an emergency manager
- 8 <u>license</u>, including whether the license is valid and whether any
- 9 disciplinary proceeding is pending.
- 10 (b) The commission shall make the records under this section
- 11 available to an emergency management director or the director's
- 12 associated governmental entity on request.
- Sec. 418.454. ADVISORY COMMITTEE. (a) The division may
- 14 establish an advisory committee to provide recommendations on the
- 15 <u>implementation of this subchapter, including</u> on the policies,
- 16 standards, and curriculum adopted under this subchapter.
- 17 <u>(b) If established, the committee consists of nine members</u>
- 18 appointed by the division chief or the chief's designee and must
- 19 contain at least one emergency manager and a representative of a
- 20 governmental entity that employs or is associated with an emergency
- 21 manager.
- (c) Chapter 2110 does not apply to the advisory committee.
- Sec. 418.455. LICENSING REQUIREMENT. A person may not
- 24 serve as an emergency management coordinator under Section
- 25 418.1015(c) for a period that exceeds six months beginning the day
- 26 <u>after the date on which the person was designated as an emergency</u>
- 27 management coordinator, unless the person holds an emergency

- 1 manager license.
- 2 Sec. 418.456. ELIGIBILITY FOR EMERGENCY MANAGER LICENSE;
- 3 ISSUANCE. (a) To be eligible for an emergency manager license, a
- 4 person must:
- 5 (1) submit an application to the commission in a form
- 6 and manner prescribed by the commission;
- 7 (2) demonstrate that the person meets eligibility
- 8 <u>criteria under Section 418.457; and</u>
- 9 (3) not be disqualified based on the person's criminal
- 10 history, as described by Section 418.458.
- 11 (b) The commission shall issue a bridge, basic,
- 12 intermediate, advanced, or master emergency manager license, as
- 13 appropriate, to an applicant who meets the eligibility requirements
- 14 prescribed by Subsection (a).
- 15 Sec. 418.457. EMERGENCY MANAGER LICENSES. (a) To be
- 16 eligible for a bridge emergency manager license, a person must
- 17 complete not less than 40 hours of training and instruction on
- 18 emergency management, which must consist of courses provided or
- 19 approved by division rule.
- 20 (b) The division by rule shall establish the minimum
- 21 eligibility requirements for basic, intermediate, advanced, and
- 22 <u>master emergency manager licenses</u>, including any minimum hours of
- 23 training and instruction or years of experience performing the
- 24 <u>duties of an emergency management coordinator.</u>
- Sec. 418.458. INELIGIBILITY BASED ON CRIMINAL HISTORY. (a)
- 26 A person is not eligible for an emergency manager license if the
- 27 person has been convicted or placed on deferred adjudication

- 1 community supervision for:
- 2 <u>(1)</u> a felony; or
- 3 (2) any offense that directly relates to the duties
- 4 and responsibilities of an emergency management coordinator, as
- 5 determined by the commission.
- 6 (b) The commission, in consultation with the division, may
- 7 adopt rules specifying offenses, other than those described by
- 8 Subsection (a), a conviction or placement on deferred adjudication
- 9 community supervision for which would disqualify a person as not
- 10 eligible for an emergency manager license.
- 11 Sec. 418.459. AUTHORITY TO CONDUCT CRIMINAL HISTORY CHECK.
- 12 (a) The commission may conduct a criminal history check, including
- 13 a check of any criminal history record information maintained by
- 14 the Federal Bureau of Investigation, in the manner provided by
- 15 Subchapter F, Chapter 411, on each person who applies for an
- 16 emergency manager license.
- (b) For purposes of conducting the criminal history check,
- 18 the commission may require an applicant to submit a complete and
- 19 <u>legible</u> set of fingerprints, on a form prescribed by the
- 20 commission, to the commission or to the department for the purpose
- 21 of obtaining criminal history record information from the
- 22 department and the Federal Bureau of Investigation.
- (c) The commission may require the applicant to pay a fee to
- 24 cover any costs associated with conducting a criminal history check
- 25 under this section.
- Sec. 418.460. ALTERNATIVE QUALIFICATIONS. The division by
- 27 rule may allow an applicant for an emergency manager license to

- 1 credit military experience, professional experience, education, or
- 2 another certification toward the eligibility requirements of
- 3 Section 418.457, including an emergency management credential
- 4 issued by another state.
- 5 Sec. 418.461. PROVISION OR APPROVAL OF TRAINING REQUIRED.
- 6 The division shall provide or approve training, instruction, and
- 7 courses sufficient to enable a person to meet the licensing and
- 8 continuing education requirements under this subchapter.
- 9 <u>Sec. 418.462. EXPIRATION; CONTINUING EDUCATION; RENEWAL.</u>
- 10 (a) An emergency manager license expires on the first anniversary
- 11 of the date the license is issued.
- 12 (b) The commission shall renew an emergency manager license
- 13 if an emergency manager:
- 14 (1) completes not less than 16 hours of continuing
- 15 education on emergency management provided or approved by division
- 16 rule; and
- 17 (2) submits an application for renewal to the
- 18 commission on a form and in a manner prescribed by the commission.
- 19 (c) The commission by rule may adopt a system under which
- 20 licenses expire on various dates during the year.
- Sec. 418.463. DENIAL; SUSPENSION; REVOCATION. (a) The
- 22 commission may deny the issuance or renewal of an emergency manager
- 23 license or suspend or revoke an emergency manager license if a
- 24 person violates this subchapter or any rule adopted by the division
- 25 or commission under this subchapter, including being disqualified
- 26 based on the person's criminal history.
- 27 (b) A proceeding under this section is a contested case

1 under Chapter 2001. 2 SUBCHAPTER N. STATEWIDE VOLUNTEER MANAGEMENT SYSTEM 3 Sec. 418.481. DEFINITIONS. In this subchapter: (1) "Local government" means a municipality, a county, 4 a special district or authority, or any other political subdivision 5 6 of this state. 7 (2) "Volunteer management system" means the online 8 volunteer registration and management database established under 9 this subchapter. 10 Sec. 418.482. - 12 The division may conduct a criminal history check, based on the
- 13 criminal history record information maintained by the department or
- 14 any other criminal justice agency in this state, on each person who
- 15 applies to register as a volunteer under this subchapter.
- Sec. 418.486. INELIGIBILITY TO REGISTER BASED ON CRIMINAL
- 17 HISTORY. The division may adopt rules for the denial of a person's
- 18 application to register in the volunteer management system based on
- 19 the person's criminal history and for purposes of ensuring public
- 20 safety and operational integrity.
- Sec. 418.487. RULES. The division shall adopt rules for
