A BILL TO BE ENTITLED

AN ACT

2 relating to the measures to encourage eligible students to claim 3 certain tuition and fee exemptions at public institutions of higher 4 education for students who are or have been in foster or other 5 residential care.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 SECTION 1. Section 54.366(b), Education Code, is amended to 8 read as follows:

9 (b) The Texas Education Agency and the Texas Higher Education Coordinating Board shall develop outreach programs to 10 ensure that students in the conservatorship of the Department of 11 12 Family and Protective Services and in grades 9 through 12 [9-12] are aware of the availability of the exemption from the payment of 13 tuition and fees provided by this section. The outreach programs 14 must include the provision of informational materials regarding the 15 16 exemption to each:

17 (1) residential child-care facility as defined by 18 Section 42.002, Human Resources Code;

19 (2) foster parent or relative or other designated
20 caregiver for a student enrolled in grade 9 through 12; and

21 (3) school district, open-enrollment charter school,
22 and private school offering grade nine or above.

23 SECTION 2. Section 54.367(b), Education Code, is amended to 24 read as follows:

13 and private school offering grade nine or above.

SECTION 3. Subchapter D, Chapter 54, Education Code, is amended by adding Section 54.3671 to read as follows:

16 <u>Sec. 54.3671. STREAMLINED ELIGIBILITY DETERMINATION AND</u> 17 <u>APPLICATION PROCESS FOR CERTAIN STUDENTS. The Texas Higher</u> 18 <u>Education Coordinating Board, in consultation with the Department</u> 19 <u>of Family and Protective Services, shall design and implement a</u> 20 <u>streamlined eligibility determination and application process for</u> 21 <u>the tuition and fee exemptions provided by Sections 54.366 and</u> 22 <u>54.367. The streamlined process must:</u>

23 (1) be designed to decrease the administrative burden 24 on the department and students in determining exemption eligibility 25 by reducing data collection, data entry, and the copying and 26 recopying of applications;

(2) include a system through which a student may apply

for an exemption electronically through the department's Internet 1 2 website; and 3 (3) for a student determined by the department to be 4 eligible for an exemption, provide for the automatic submission by the department to the institution of higher education indicated by 5 6 the student of the tuition waiver letter or other documentation 7 required by the institution to verify the student's eligibility. SECTION 4. This Act takes effect immediately if it receives 8 a vote of two-thirds of all the members elected to each house, as 9 provided by Section 39, Article III, Texas Constitution. If this 10 Act does not receive the vote necessary for immediate effect, this 11

12 Act takes effect September 1, 2025.
