## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to assistance for tuition and fees at postsecondary
- 3 educational institutions for certain members of the Texas military
- 4 forces.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Sections 54.345(b) and (c), Education Code, are
- 7 amended to read as follows:
- 8 (b) An institution of higher education shall exempt a person
- 9 certified by the adjutant general as described by Subsection (a)
- 10 from the payment of tuition for the semester credit hours for which
- 11 the person enrolls, not to exceed  $\underline{15}$  [ $\underline{12}$ ] semester credit hours. If
- 12 the person is not charged tuition at the rate provided for other
- 13 Texas residents, the amount of the exemption may not exceed the
- 14 amount of tuition the person would be charged as a Texas resident
- 15 for the number of semester credit hours for which the person
- 16 enrolls, not to exceed 15  $[\frac{12}{2}]$  semester credit hours.
- 17 (c) An institution of higher education shall exempt a person
- 18 who receives an exemption from tuition under Subsection (b) from
- 19 the payment of all mandatory fees for any semester or term in which
- 20 the person receives the tuition exemption.
- 21 SECTION 2. Sections 437.226(c), (d), (e), (f), (g), and
- 22 (i), Government Code, are amended to read as follows:
- 23 (c) The adjutant general shall grant assistance for tuition
- 24 and mandatory fees under this section to eligible service members,

- 1 in an amount not to exceed the amount provided in the General
- 2 Appropriations Act. The adjutant general may apportion the number
- 3 of assistance awards among the components of the Texas military
- 4 forces necessary to meet the recruitment and retention needs of
- 5 those components. The number of assistance awards made to members
- 6 of the Texas State Guard may not exceed 45 [30] for any semester or
- 7 term unless the adjutant general finds a compelling need for
- 8 additional awards to members of the Texas State Guard.
- 9 (d) Assistance for tuition and mandatory fees may be awarded
- 10 under this section for tuition and mandatory fees charged for any
- 11 undergraduate or graduate course for any semester or term at an
- 12 institution of higher education or private or independent
- 13 institution of higher education, including a vocational or
- 14 technical course.
- 15 (e) A service member may not receive assistance for tuition
- 16 under this section for more than 15  $[\frac{12}{2}]$  semester credit hours in
- 17 any semester or term.
- 18 (f) A service member may not receive assistance for tuition
- 19 and mandatory fees under this section for more than seven [5]
- 20 academic years or 15 [10] semesters or terms, whichever occurs
- 21 first for the service member.
- 22 (g) Before each semester or term, the department must
- 23 certify to the appropriate public and private institutions of
- 24 higher education a list of the service members to whom the adjutant
- 25 general has awarded assistance for tuition and mandatory fees under
- 26 this section for that semester or term. The amount of assistance
- 27 awarded by the adjutant general under this section may not exceed

- 1 the amount of money available to fund the assistance awards.
- 2 (i) From money appropriated for purposes of this section,
- 3 the department shall authorize the comptroller to make a grant to a
- 4 service member attending a private or independent institution of
- 5 higher education to whom the adjutant general has awarded
- 6 assistance for tuition and mandatory fees for the semester or term
- 7 under this section. The amount of a grant under this subsection is
- 8 an amount equal to the average amount of reimbursement the
- 9 department estimates will be paid per student for the same semester
- 10 or term under Subsection (h).
- 11 SECTION 3. This Act applies beginning with the 2025 fall
- 12 semester.
- 13 SECTION 4. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2025.
