- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subtitle C, Title 5, Business & Commerce Code, is
- 6 amended by adding Chapter 121 to read as follows:
- 7 CHAPTER 121. CREATION OF EXPLICIT DEEP FAKE MATERIAL
- 8 Sec. 121.001. DEFINITIONS. In this chapter:
- 9 (1) "Deep fake generator" means an Internet website or
- 10 application operating in this state that allows a user to create or
- 11 generate deep fake material using software provided by the website
- 12 or application. The term does not include a separate platform on
- 13 which deep fake material is posted, sent, or distributed.
- 14 (2) "Deep fake material" means visual material,
- 15 created with the intent to deceive, that appears to depict a real
- 16 person performing an action that did not occur in reality.
- 17 (3) "Explicit deep fake material" means deep fake
- 18 material that appears to depict a real person engaging in sexual
- 19 conduct or other conduct resulting in the exposure of the person's
- 20 <u>intimate parts.</u>
- 21 (4) "Intimate parts," "sexual conduct," and "visual
- 22 material" have the meanings assigned by Section 21.16, Penal Code.
- Sec. 121.002. REQUIRED AGE VERIFICATION. (a) Before a deep
- 24 fake generator creates or generates explicit deep fake material,

- 1 the owner of the deep fake generator shall verify the age of the
- 2 person apparently depicted by the explicit deep fake material using
- 3 a commercially reasonable age verification method.
- 4 (b) The owner of a deep fake generator may not allow the deep
- 5 fake generator to create or generate explicit deep fake material
- 6 apparently depicting a person who is at least 18 years old without
- 7 the written consent of the person.
- 8 (c) The owner of a deep fake generator may not allow the deep
- 9 fake generator to create or generate explicit deep fake material
- 10 apparently depicting a person who is younger than 18 years old.
- 11 Sec. 121.003. PRIVATE CAUSE OF ACTION. (a) A person in
- 12 this state apparently depicted by explicit deep fake material in
- 13 violation of this chapter, or the person's parent or guardian if the
- 14 person is younger than 18 years old, may bring an action against the
- 15 owner of a deep fake generator who violates this chapter.
- 16 (b) A person who prevails in an action under this section
- 17 shall be awarded:
- 18 (1) actual damages, including damages for mental
- 19 anguish;
- 20 (2) court costs; and
- 21 (3) reasonable attorney's fees.
- (c) In addition to an award under Subsection (b), a person
- 23 who prevails in an action under this section may recover exemplary
- 24 damages.
- 25 (d) A cause of action under this section is cumulative of
- 26 any other remedy provided by common law or statute.
- 27 SECTION 2. Section 121.003, Business & Commerce Code, as
