A BILL TO BE ENTITLED

- 2 relating to the creation of certain explicit deep fake material;
- 3 providing a private cause of action.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subtitle C, Title 5, Business & Commerce Code, is
- 6 amended by adding Chapter 121 to read as follows:
- 7 CHAPTER 121. CREATION OF EXPLICIT DEEP FAKE MATERIAL
- 8 Sec. 121.001. DEFINITIONS. In this chapter:
- 9 (1) "Deep fake generator" means an Internet website or
- 10 application operating in this state that allows a user to create or
- 11 generate deep fake material using software provided by the website
- 12 or application. The term does not include a separate platform on
- 13 which deep fake material is posted, sent, or distributed.
- 14 (2) "Deep fake material" means visual material,
- 15 created with the intent to deceive, that appears to depict a real
- 16 person performing an action that did not occur in reality.
- 17 (3) "Explicit deep fake material" means deep fake
- 18 material that appears to depict a real person engaging in sexual
- 19 conduct or other conduct resulting in the exposure of the person's
- 20 <u>intimate parts.</u>
- 21 (4) "Intimate parts," "sexual conduct," and "visual
- 22 <u>material" have the meanings assigned by Section 21.16, Penal</u> Code.
- Sec. 121.002. REQUIRED AGE VERIFICATION. (a) Before
- 24 creating or generating explicit deep fake material, a deep fake

- 1 generator shall verify the age of the person apparently depicted by
- 2 the explicit deep fake material using a commercially reasonable age
- 3 verification method.
- 4 (b) A deep fake generator may not create or generate
- 5 explicit deep fake material apparently depicting a person who is at
- 6 least 18 years old without the written consent of the person.
- 7 (c) A deep fake generator may not create or generate
- 8 explicit deep fake material apparently depicting a person who is
- 9 younger than 18 years old.
- Sec. 121.003. PRIVATE CAUSE OF ACTION. (a) A person in
- 11 this state apparently depicted by explicit deep fake material in
- 12 violation of this chapter, or the person's parent or guardian if the
- 13 person is younger than 18 years old, may bring an action against a
- 14 deep fake generator who violates this chapter.
- 15 (b) A person who prevails in an action under this section
- 16 <u>shall be awarded:</u>
- 17 (1) actual damages, including damages for mental
- 18 anguish;
- 19 <u>(2)</u> court costs; and
- 20 (3) reasonable attorney's fees.
- 21 (c) In addition to an award under Subsection (b), a person
- 22 who prevails in an action under this section may recover exemplary
- 23 damages.
- 24 (d) A cause of action under this section is cumulative of
- 25 any other remedy provided by common law or statute.
- SECTION 2. Section 121.003, Business & Commerce Code, as
- 27 added by this Act, applies only to a cause of action that accrues on

- 1 or after the effective date of this Act.
- 2 SECTION 3. This Act takes effect September 1, 2025.
