- 16 17 under which an eligible recipient may obtain financial assistance in the form of reimbursement to cover the cost of delivery service 18 fees incurred by the recipient in connection with the purchase of 19 20 eligible food items under the supplemental nutrition assistance 21 program. In implementing the reimbursement program, the commission
- 23 (1) prescribe the form and manner for an eligible 24 recipient to request reimbursement, which may require the recipient

- 1 to submit an application online, by mail, or in person; and
- 2 (2) ensure that supplemental nutrition assistance
- 3 program benefits are not used to reimburse the cost of delivery
- 4 service fees under this section.
- 5 (c) The executive commissioner shall adopt rules necessary
- 6 to implement this section, including rules that:
- 7 <u>(1) establish a reimbursement methodology for</u>
- 8 determining the reimbursement amount that an eligible recipient may
- 9 receive to cover the cost of a delivery service fee assessed in
- 10 connection with the purchase of eligible food items, which may

- 23 a state agency determines that a waiver or authorization from a

- 26 authorization and may delay implementing that provision until the
- 27 waiver or authorization is granted.
