14	(2) to pay a nonprofit state association or
15	organization that:
16	(A) primarily represents political subdivisions;

18	(B) hires or contracts with an individual
19	required to register as a lobbyist under Chapter 305.
20	(b) If a political subdivision engages in an activity
21	prohibited by Subsection (a), a taxpayer or resident of the
22	political subdivision is entitled to appropriate injunctive relief
23	to prevent further activity prohibited by that subsection and
24	further payment of public funds related to that activity.

2 (1) a majority of the court votes to approve3 membership in the association;

4 (2) the association exists for the betterment of

6 (3) the association is not affiliated with a labor7 organization; and

8 (4) [neither the association nor an employee of the 9 association directly or indirectly influences or attempts to 10 influence the outcome of any legislation pending before the 11 legislature, except that this subdivision does not prevent a person 12 from providing information for a member of the legislature or 13 appearing before a legislative committee at the request of the 14 committee or the member of the legislature; and

15 [(5)] neither the association nor an employee of the 16 association directly or indirectly contributes any money, 17 services, or other valuable thing to a political campaign or 18 endorses a candidate or group of candidates for public office.

(b) If any association or organization supported wholly or partly by payments of tax receipts from political subdivisions engages in an activity described by Subsection (a)(4) [or (5)], a taxpayer of a political subdivision that pays fees or dues to the association or organization is entitled to appropriate injunctive relief to prevent any further activity described by Subsection (a)(4) [or (5)] or any further payments of fees or dues.

26 SECTION 3. Section 556.0056, Government Code, as added by 27 this Act, applies only to an expenditure or payment of public funds

by a political subdivision that is made on or after the effective date of this Act, including an expenditure or payment of public funds by a political subdivision that is made under a contract entered into before, on, or after the effective date of this Act. A contract term providing for an expenditure or payment prohibited by Section 556.0056, Government Code, as added by this Act, is void on the effective date of this Act.

SECTION 4. Section 89.002, Local Government 8 Code, as amended by this Act, applies only to the spending of money by a 9 county from the county's general fund that occurs on or after the 10 effective date of this Act. The spending of money by a county from 11 the county's general fund that occurs before the effective date of 12 this Act is governed by the law as it existed immediately before the 13 14 effective date of this Act, and that law is continued in effect for 15 that purpose.
