6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subtitle G, Title 4, Health and Safety Code, is
8	amended by adding Chapter 328 to read as follows:
9	CHAPTER 328. HUMAN TRAFFICKING PREVENTION IN CERTAIN FACILITIES
10	Sec. 328.001. DEFINITIONS. In this chapter:
11	(1) "Facility" has the meaning assigned by Section
12	<u>31.002.</u>
13	(2) "Medical assistant" has the meaning assigned by
14	Section 763.001.
15	Sec. 328.002. HUMAN TRAFFICKING SIGNS REQUIRED. (a) A
16	facility shall display a sign, at least 11 inches by 17 inches in
17	size, written in at least a 16-point font and in the form prescribed
18	by the attorney general, that includes:
19	(1) the following statements:
20	(A) "All health care practitioners and medical
21	assistants are required to receive human trafficking prevention
22	training."; and
23	(B) "An employee may not be disciplined,
24	retaliated against, or otherwise discriminated against for

reporting in good faith a suspected act of human trafficking."; 1 2 (2) information on recognizing and reporting human trafficking and a list of human trafficking indicators; 3 4 (3) a phone number the attorney general designates for 5 reporting a suspected act of human trafficking or a violation of 6 this chapter; and 7 (4) contact information for reporting suspicious 8 activity to the Department of Public Safety. 9 (b) The sign described by Subsection (a) must be posted: 10 (1) in a location easily visible to all facility 11 employees; and 12 (2) separately in English, Spanish, and any other primary language spoken by 10 percent or more of the facility's 13 14 employees. 15 Sec. 328.003. DISCRIMINATION AND RETALIATION PROHIBITED. A facility may not discipline, retaliate against, or otherwise 16 17 discriminate against a facility employee who in good faith reports a suspected act of human trafficking to the facility, a law 18 enforcement agency, the National Human Trafficking Resource 19 Center, the attorney general, or another appropriate authority. 20 21 SECTION 2. Subtitle A, Title 9, Health and Safety Code, is amended by adding Chapter 763 to read as follows: 22 CHAPTER 763. HUMAN TRAFFICKING PREVENTION TRAINING 23 24 SUBCHAPTER A. TRAINING FOR MEDICAL ASSISTANTS

2	commissioner of the Health and Human Services Commission.
3	(3) "Human trafficking" means conduct that
4	constitutes an offense under Section 20A.02, Penal Code.
5	(4) "Medical assistant" means an individual who, under
6	the supervision of a physician, assists with patient care
7	management, executes administrative duties, and performs clinical
8	procedures, including:
9	(A) conducting aseptic procedures;
10	(B) obtaining vital signs;
11	(C) preparing patients for the physician's care;
12	(D) performing venipunctures and non-intravenous
13	injections;
14	(E) observing and reporting patients' symptoms;
15	(F) administering basic first aid;
16	(G) assisting with patient examinations or
17	<pre>treatments;</pre>
18	(H) operating office medical equipment;
19	(I) collecting routine laboratory specimens, as
20	directed by the physician;
21	(J) administering medication, as directed by the
22	physician;
23	(K) performing basic laboratory procedures; and
24	(L) performing dialysis procedures, including
25	home dialysis.
26	Sec. 763.002. REQUIRED HUMAN TRAFFICKING TRAINING. A
27	medical assistant, within the time prescribed by commission rule,

- 1 shall successfully complete a training course approved by the
- 2 executive commissioner on identifying, assisting, and reporting
- 3 <u>victims of human trafficking.</u>
- 4 Sec. 763.003. TRAINING COURSE APPROVAL. (a) The executive
- 5 commissioner shall:
- 6 (1) approve training courses on human trafficking
- 7 prevention, including at least one course available without charge;
- 8 and
- 9 (2) post a list of the approved training courses on the
- 10 <u>commission's Internet website.</u>
- 11 (b) The executive commissioner shall update the list of
- 12 approved training courses described by Subsection (a) as necessary
- 13 and consider for approval training courses conducted by health care
- 14 facilities.
- SECTION 3. As soon as practicable after the effective date
- 16 of this Act, the attorney general shall design the sign required by
- 17 Section 328.002, Health and Safety Code, as added by this Act.
- SECTION 4. As soon as practicable after the effective date
- 19 of this Act, the executive commissioner of the Health and Human
- 20 Services Commission shall approve and post on the commission's
- 21 Internet website the list of approved human trafficking prevention
- 22 training courses and adopt rules necessary to implement Subchapter
- 23 A, Chapter 763, Health and Safety Code, as added by this Act.
- SECTION 5. This Act takes effect September 1, 2025.
