- 1 Merit. License plates issued under this subsection must include the
- 2 Texas Medal of Merit emblem and must include the words "Texas Medal
- 3 <u>of Merit" at the bottom of each plate.</u>
- 4 SECTION 5. This Act takes effect September 1, 2025.
